ANTIGUA

Ship letter sent before 1711.



5 October, 1693.

Rated "3" : 1660 inland rate of 3d. for over 80 miles from the port of landing to London - not the 1688 rate of 6d. In 1711 the payment of the captain's penny was legalised to encourage the handing over of ship letters so that the Post Office could rate them as such.

This letter from Walter Quarme is believed to be the earliest known from Antigua.


23 May, 1756.

The lack of postal markings is probably explained because this letter was carried in the private baggage of Mr. Edward Codrington (brother of the addressee) who is mentioned in it as travelling in the same ship.

The standard charge for West Indian ship letters included the captain's gratuity of 1d.
The legal basis for this charge is not known.


Rated "7" : 1711 inland rate of 2 x 3d. plus 1d.
captain's gratuity = 7d. On arrival at London "7" cancelled
by inspector's crown, "6" substituted and initialled,
possibly on the assumption that the letter originated from Portsmouth.





converted to local currency "5 Bitts".

Sir Ralph Payne, K.B., was Governor of the Leeward Islands
from 1771 to 1775. He returned, as Lord Lavington,
to be Governor again from 1799 to 1810.

1765 inland rate of 2 x 3d. = 6d. to London, 2 x 4d. = 8d.
to Wells, plus 1d. captain's gratuity = 1s.3d.

17 August, 1787.

Rated "6" : 1784 inland rate of 5d. plus 1d. captain's gratuity = 6d.

That it is a ship letter is confirmed by the strike of "SHIP LRE / BRISTOL 123". Most straight line Antigua handstamps were used on packet letters, but Lowe types PD3 & PD6 seem to have been used on ship letters.

This strike closely resembles Lowe type PD6, but both letters "A" seem to be from a different fount and there is no full stop. It pre-dates the earliest strike of PD6 in the Codrington correspondence by nearly 2 years.



Originally directed "By His Majesty's Ship - Perseus",
but this was crossed out and the letter sent by packet.

Ship letter routed via Liverpool.



26 August, 1795.

Rated "7" : 1784 inland rate of 6d. plus 1d. captain's gratuity = 7d.

Letters were frequently sent via Liverpool during the Napoleonic Wars to avoid the English Channel. The "LIVERPOOL/SHIP" handstamp is thought to have been used only on mail specially routed via Liverpool. This letter was routed "p. Brig. Alert".

Note the sender's instructional marking relating to the Cross Post.

ANTIGUA

Letter from Antigua, smuggled into England
and posted at Eltham to Richmond, Yorkshire.



12 April, 1798.

Letter headed "(Copy) Original p Packet Prince Ernest" and "Antigua 6th December 1797". The Prince Ernest was a Falmouth packet boat under Post Office contract; it left British occupied Martinique on 29 November, 1797, and was captured on 11 January, 1798, by an 18-gun French privateer.

This copy was presumably carried privately to England and taken to a relative of the writer at Eltham. As it was not sealed, the recipient was able to remove an enclosed Bill of Exchange and deal with it - promising to forward it to the addressee (the writer's aunt) when accepted.

She added that "Antigua is in great want of provision; corn at 24sh. a bushel, yams failing shortly, also little sugar made. The weather dry, the small pox just broke out in the Island. I hope the next packet will bring better news."

Posted on 12 April, 1798, at Eltham, where it received the only recorded strike in black of "Eltham/unpaid/Penny Post". Backstamped at Penny Post Chief Office and General Post Office in London, both on 12 April, 1798.

Rated "9" : 1796 inland rate of 8d. plus 1d. Penny Post = 9d.



This letter has no Antiguan markings as it was posted
after the bag for the packet was closed. The packet
letter handstamp was applied at Falmouth only to loose
letters not sent via London. This letter shows
very early use of the handstamp.



"G/JUL 21/1800", in red, on arrival.



This letter shows that it was apparently also used in 1800.
It includes a copy of a letter sent the previous
month by the regular Packet "Auckland".

Rated "2/2" : 1812 packet letter rate of 1s.3d. to Falmouth

Large fleuron markings were used 1808 - 1824.
Between 1810 - 1821 the year is always missing.

Packet letter to Edinburgh sent during the Falmouth mutiny.



16 December, 1810.

Rated "2/4" : 1805 packet letter rate of 1s.1d. to Plymouth plus 1805 inland rate of 1s.3d. to Edinburgh = 2s.4d.

Edinburgh arrival datestamp "JAN/31/1811".

On 24 October, 1810, the crews refused to take the packets out to sea after an over-zealous Customs Officer had broken open the seamen's chests and seized "their little private adventures" - small quantities of goods they took out and sold to augment their low pay. On 6 November, 1810, all the Falmouth packets were transferred to Plymouth: they were not transferred back until 4 February, 1811, arriving on 15 February, 1811.

Few examples are known from this short break in the Falmouth packet's history. This one is thought to be the only recorded example from Antigua.

Routed "p Edward" - a vessel probably chosen since its route
was unlikely to include the English Channel - a dangerous
place for shipping in the Napoleonic Wars.

Postmarked on arrival "PORT GLASGOW/SHIP LETTER"
and "GLASGOW/30 JAN 1813/405 - G", both in black.

only to loose letters not sent via London.

Letters at this period were not usually prepaid,
but this is clearly marked
"Post Paid 2/2" in red ink.

12 June, 1822.

Rated "2/-" : 1815 ship letter charge 8d., plus the inland charge (up to 15 miles) 4d., doubled = 2s.0d.

The "G P" handstamp was applied to letters transferred from the General Post to the Twopenny Post for delivery by one of their letter carriers, when no Twopenny Post charge was due.


Backstamped with red oval "4 o'Clock / .JY.15./1822 EVg".

The writer enclosed an account - hence the double rate - and said the letter would be sent by the "West Indian", "which it is said will sail tomorrow".

Rated "2/3" : 1812 inland rate 1s.1d. less 1d. to Falmouth
plus 1812 packet letter rate of 1s.3d. from Falmouth = 2s.3d.

Coconut Hall is in St. Peter parish.

Packet letter to Dodington marked "Consignees Letter".



5 May, 1829.

A consignee's letter was exempt from sea postage, but this one became liable to postage after reaching Falmouth. It was rated "9" (9d.) and sent to Cirencester, where that town's name was deleted and replaced by Bath, the new post town. It was then re-directed to London and the charge altered to "1/6" (1s.6d.).


A charge of "2/3" on the front of the letter has been cancelled by a red "inspector's crown" and a similar charge on the back was probably ignored.

Backstamped with Antigua small fleuron "MY 5 / 1829", at Cirencester with unframed, undated circular mark with mileage mark removed and in London "19 JU 19 / 1829".





On receipt at Ryde, re-directed to Chelsea at the 1812 inland rate of 8d., so "2/2" deleted and "2/10" substituted.

Rated "2/5". The rate of 1s.0d./ $\frac{1}{2}$ oz. was brought into use on the introduction of Uniform Inland Postage on 10 January, 1840.

This is a very early example of the Uniform Packet Rate.

Rated "160" : 160 reis Portuguese postage due in Madeira.

Not backstamped for arrival in Madeira, but the endorsement states that it arrived on 20 May, 1843.

No adhesives were in use in Antigua after the use
of British ones ceased on 30 April, 1860 until
the first Antigua adhesives were issued
in August, 1862.






