#### EXCISE.

The quantity of Rum manufactured in this Ward Union during the year 1889 was 22,670 gallons against 39,742 for the preceding year, being a decrease of 17,072 gallons.

A considerable amount of dissatisfaction was expressed at the stringency of the new Regulations, but they have proved quite practicable and worked smoothly.

#### ROADS.

The past rainy season has been exceptionally severe, and the roads have suffered proportionately; several of the mud roads having become impassable, and the metal roads much cut up.

Important lessons in road-making are often taught by such a season, two being, the necessity of placing depôts of metal and putting bridges and approaches into thorough order previous to the commencement of the rains; draining should also be carried out in good time; the neglect of these precautions often proves most expensive.

I cannot think the present system of paying Road Foremen by the day, a good one; valuable work can be performed by them during the wet season in constant inspection of the roads and bridges and carrying out immediate repairs; at present visits on many of the roads are so few and far between that the damage has become considerable before a step is taken.

There are two portions of road in this Road Union which become impassable annually, and for the metalling of which a special Vote of money should be obtained, if possible, before the next wet season. I allude to the mud portion of the Southern Main Road lying between the Caroni and Conupia Railway Stations, a distance of about  $1\frac{3}{4}$  miles; it seems extraordinary that this important connecting link should be allowed to become an impassable sea of mud annually, cutting off road communication entirely between the Northern and Southern Districts.

The second portion, which also urgently requires a Special Vote, is the Eastern end of the Caroni Left Bank road beyond the St. Helena Estate; the traffic is very heavy, it being the only outlet from the first and second Las Lomas Roads, along both of which several thousand acres have been alienated during the past fifteen years; this narrow unmetalled outlet for such an extent of cultivation is to all intents and purposes utterly useless, and the unfortunate proprietors have to face the same hardships year after year to bring out their produce.

Blue metal laid on at least nine inches thick would be necessary, as this piece of road is flat and passes through Cacao cultivation; the road being narrow and shaded on either side does not derive much benefit from the sun.

The first mile or two of the Las Lomas No. 1 Road should be deviated, leaving the Caroni Left Bank Road somewhere near the Eastern boundary of the St. Helena Estate and running South for some distance to avoid passing through Cacao, rejoining its present route at a point near the property of one Alexandrine Bassoo; this would also relieve the Caroni Left Bank Road.

As the Golden Grove Road has to bear most of the traffic from Las Lomas, owing to the proprietors residing and doing business at Arouca, annual improvements should be made to this road; for several years past I believe Estimates have been framed for metalling this road, but funds have not been available.

The small strip of road from the St. Helena Bridge to the Estate Barracks should undoubtedly be metalled without delay, as it becomes impassable even in a mild wet season.

There are 43 roads in this Road Union, and the amount estimated for their up-keep for 1889 was £2,273, being £555 15 10 in excess of 1888. The amount estimated and sanctioned for 1890 is £2,410 10 0.

I regret to say that the utility of reserving Crown Lands has been entirely overlooked in this Ward Union; several reserves are necessary along the Las Lomas roads for burning clay, supplying timber for bridges, &c.; later the lands will be required for other purposes.

The Tacarigua Districts, having the St. Mary's Village as a centre, appears to me to have been strangely overlooked in the matter of public institutions which other Districts of far less importance can boast of, such as a Post Office, Guard House, and Telegraph Station. The present building used as a Post Office is conveniently situated, but unsuitable in other respects; a Telepraph Station is undoubtedly a sine quá non where so many large and important Sugar Estates exist; and the Police of Arouca and Tunapuna must have their hands full, without considering the St. Mary's and Paradise Villages, which are also thickly populated; Sunday drinking appears to be becoming a common practice in these Villages.

I cannot close my Report without testifying to the satisfactory manner in which the staff under me have performed their duties during the past year.

#### REPORT ON THE GOVERNMENT SAVINGS BANK FOR THE YEAR 1889.

RECEIVER-GENERAL'S OFFICE,

PORT-OF-SPAIN,

28th February, 1890.

SIR,

I have the honour to submit my Annual Report of the Government Savings Bank for the year 1889, together with the following statements:—

- Statement of Deposits in the Government Savings Bank on 31st December, 1889.
- II. Statement of number of East Indian Immigrant Depositors in 1889 and balances remaining at their credit on 31st December of that year.
- III. Comparative Statement of transactions from 1880 to 1889.
- IV. Statement showing the total amount deposited and withdrawn each year since 1880, and amount in deposit at the end of 1889.
- V. Return of Investments of Government Savings Bank and rate of interest received thereon.
- VI. Classification of Depositors in the Government Savings Bank.
- VII. Return showing expenditure for maintenance of Government Savings Bank and receipts and payments of Interest account.
- 2. It will be seen by these statements that the Bank is making sure and steady progress, and the increase in the numbers of depositors of the labouring classes is an indication, not only of their appreciation of the Institution, but that they are not reduced to such straightened means as to preclude them from laying by a portion of their earnings. This may be taken, to a certain extent, as an index of the prosperity of the labouring classes.
- 3. The total number of depositors in the Savings Bank generally has increased by two hundred and fifty-six in 1889, but the proportion of the number of small deposits is greater last year than it was the year before. The total amount at credit of depositors on 31st December, 1889, was £129,059 8 0 as against £122,754 6  $3\frac{1}{2}$  in 1888. The sum of deposits during the year exceeded that of the previous year by £13,020 7 5, and the total of the withdrawals was £9,467 8 9, more than it was in 1888.
- 4. The amount at credit of depositors in the eight Branch Banks recently established at the end of last year was £3,840 8 3 as against £3,129 5  $9\frac{1}{2}$  in 1888. The numbers of depositors in these Banks have very much increased, there being 152 more in 1889 than there were the previous year. At three of the Branches especially the increase has been marked, viz.: at Arima it was 57, at Couva 43, and at Mayaro 41.

Of the East Indian depositors there was an addition to the numbers in 1889 of 68, and the balance at credit improved by £1,876 12 2½.

- 5. Arrangements were made in 1889 for a Branch Bank to be opened at LaBrea which took place on the first of this year. The return of deposits for January shows a satisfactory result.
- 6. That the Trinidad Government Savings Bank is making satisfactory progress may be seen by a comparison of the returns of this Colony with those of British Guiana. The Guiana Bank, it being remembered, is a much older Institution.

7. A system of receiving deposits by means of Postage Stamps was instituted on the 1st November last year. The object of this is to encourage the saving of small sums. The minimum amount which can be saved at a time by this means is one penny, and facilities are afforded the Public of transmitting their deposits free of charge, through the Post Office, to prevent the necessity of attending the Savings Bank personally.

The system has been in operation only a short time, but I think I may say so far, that it has been successful. Circulars have been addressed by me to the clergymen of the various denominations, asking them to co-operate with the Government in starting the system, as it was considered that it might be the means of inculcating the principles of thrift in school children.

8. The following is the result of the Postage Stamp operations. In November and December last year there were eighty deposits, amounting to £14 16 0, distributed as follows:—

In January the Branch Bank returns shows 41 deposits of a total of £5 5 0:—Couva 24, Mayaro 14, and Montserrat 3, whilst in Port-of-Spain from the first of the year to the present time there have been 73 deposits of the total value of £11 11 0, in fact a day does not pass now without a deposit being made by Postage Stamps in this office. The sums now received show that the object of the system is being obtained, viz., the saving of small sums, for of the 73 deposits in the chief office this year, 54 were of one shilling each made up of penny stamps, whilst 4 more, amounting together to £4 4 0, were, with one exception, also entirely of penny stamps on sheets of one shilling each received through Penny Savings Banks. This makes in all in Port-of-Spain alone in two months 140 deposits of one shilling each, which is a contrast to the report I made last year that out of 7,533 deposit transactions in Port-of-Spain in 1888, there were only 8 of 1/- each! The total number of Postage Stamp deposits in the Branch Banks from November, 1889, to 31st January, 1890, and in the chief office to date are 182, of a total of £27 3 0.

- 9. The Public appreciate the increase of the interest bearing capital which the Ordinance of last year provides for. Interest is now paid on a principal sum not exceeding £300 instead of £200 as formerly. The privilege of depositing at interest to the extent of £500 by Trustees of Penny Savings Banks will be readily taken advantage of. Pass Books are now issued free of charge to Depositors.
- 10. It is to be regretted that depositors do not avail themselves of the opportunities the law allows them of making "appointments" of sums they deposit, under £50. It would be to their interest to do this, as when a Depositor dies and leaves no will, the appointment would take effect, and thus save the person for whom the money is intended much time and trouble in obtaining payment of the sum at the credit of the deceased Depositor. I am of opinion that the amount for which an appointment can be made should be extended to £100 instead of £50 as it now is.
- 11. The Managers of Branch Banks have additional work thrown on them by the Savings Bank business, and I have much pleasure in saying that considerable interest and energy is displayed as a rule by these officers in the performance of their Bank duties for which they receive no remuneration. I would recommend for consideration, as I did in my Minute No. 338 of the 4th October, 1888, that the Managers of Branch Banks be paid for these duties an allowance, based on the number of accounts that are in existence in each Bank. It would amount to a payment according to results, and I feel confident it would stimulate their efforts and benefit the Bank very much. The expenditure for the maintenance of the Staff of the Bank in the chief office was reduced by £200 a year, in 1889, by the reorganization of the Treasury Staff which took place last year, but I feel compelled to ask for an additional clerk for the Bank in the chief office in view of the great increase of work generally which has taken place and is still doing so. The Government recognized the necessity of additional clerkia assistance being given to the Bank some years ago, and this necessity has obviously very much increased since then. Under present arrangements, with an additional clerk's salary even, the cost of the Bank's establishment will be less than it was formerly.
