# 400TH ANNIVERSARY OF THE DISCOVERY OF TRINIDAD.

# Correspondence respecting the proposed issue of a special Commemorative Stamp.

In Continuation of Council Paper No. Registered No. of Correspondence, 6605/1897.

The Governor to the Secretary of State.

No. 463.

GOVERNMENT HOUSE,

22nd December, 1897.

SIR,

The 31st of July, 1898, will be memorable in the annals of Trinidad on account of its being the 400th Anniversary of its discovery by Columbus. On that day in the year 1498, he sighted the Trinity Peaks on the South Coast of Trinidad, and at the same time first saw the Main Land of the Western Hemisphere.

- 2. It is my intention to celebrate this remarkable event during the visit of the North American and West Indian Squadron in February next, on which subject I shall address you in a separate despatch, but I desire to have a lasting memorial in the issue of a Commemorative Stamp, in which desire my Executive Council concurs.
- 3. The postage for letters between all parts of Her Majesty's Empire is about to be reduced to two pence, so that a new stamp of that value will be required, and I think this new 2d. stamp might well be made commemorative of Columbus' discovery of Trinidad.
- 4. I propose that 500,000 of this stamp should be sold to the public, after which a 2d. stamp of the ordinary Trinidad pattern will be issued. This commemorative stamp will be used for postage purposes only, so that it may be printed in any colour and of any size. All details I leave to the good taste of the Crown Agents and Messrs. de la Rue & Co., but I enclose a photograph of a stained glass window which is in the Council Chamber here, the design of which I should wish, if possible, adapted to the purpose. The artist would probably reduce the number of figures and otherwise alter the picture, but I would like the stamp in its main points to follow the design in the window.
- 5. It is absolutely necessary that the issue should be in Trinidad by June, 1898, so as to be issued on 31st July.
- 6. I may mention that the proposed celebration and the commemorative stamp is exciting considerable interest, and I beg that, should you approve the proposal, as I sincerely trust you may, the Crown Agents will be at once instructed to take the necessary steps to give it effect.

# ROYAL MAIL STEAM PACKET SERVICE.

# Correspondence with the Secretary of State on the subject of the Service to Trinidad.

In continuation of Council Paper No. Registered No. of Correspondence, No. 5960/1897.

The Governor to the Secretary of State.

14th December, 1897.

SIR.

I have the honour to draw your attention to the great advantage it would be to Trinidad if the Royal Mail Ocean Steamer could call at Trinidad on its way from Barbados to Jamaica, and vice versû.

- 2. This change of route would be advantageous to the Company, as more cargo is landed at Trinidad than at any other island, and under present arrangements all this cargo has to be transhipped at Barbados.
- 3. The advantages to Trinidad are obvious, as not only would the transhipment of cargo be obviated, but the mails would be received one day earlier and despatched one day later, and passengers would be saved the hot and wearying route round the Windward Islands and the transhipment at Barbados.
- 4. The only difficulty would be in making up the time between Barbados and Jamaica, so that the delivery of mails at the latter island should not be delayed.
- 5. As there would be no transhipment of Trinidad cargo at Barbados, a few hours could be saved there. The remaining loss of time might be made up by omitting Jacmel (Hayti) altogether, and letting that island be served from Jamaica. Any loss of subsidy to the Company would be gladly borne by Trinidad.
- 6. I do not know if any arrangement such as I propose, if approved, could be made at once, or if it would be necessary to wait for the expiration of the present contract. In either case I would beg that it may be given careful consideration, and that the Royal Mail Company may be consulted. An incidental advantage would be that Tobago could be given an improved service by the Inter-colonial steamer calling there on its way to Trinidad.
- 7. Sir C. C. Knollys suggested this scheme in his despatch, No. 465, of 27th September, 1894, and in view of the Report of the West India Commissioners recommending greater shipping facilities; in view also of the probability of Trinidad becoming an important commercial transit centre now that there is a prospect of better relations with Venezuela; and, finally, in view of the necessity which is daily growing of making Tobago a district of Trinidad, I venture to think that the scheme is deserving of your most favourable consideration.

# REGULATIONS FOR CONDUCTING INTER-COLONIAL MONEY ORDER BUSINESS.

1. These Regulations apply to Money Orders drawn in Trinidad and Tobago on the following Colonies :-

Barbados. Antigua. British Guiana. Dominica. British Honduras. Grenada. Montserrat. Leeward Islands. St. Lucia. Nevis. St. Vincent. St. Kitts. Jamaica.

2. The maximum amount for which a Money Order may be drawn, shall not exceed Forty-eight Dollars or Ten Pounds.

3. The Commission charged on issuing Money Orders shall be as follows:—

4. The applicant for Money Orders shall give on a printed Requisition to be furnished him by the Postmaster, the surname in full, and at least the initial of one Christian name of the remitter and the payee, together with the address of the remitter.

5 Every Money Order and Advice must be drawn on authorised forms only.

6. The signature of the payee, on payment of a Money Order, must be affixed to the receipt on the Order in the place provided for the purpose. If the payee be unable to write, he should sign the receipt by making his mark to be witnessed in writing.

7. In the event of a Money Order miscarrying or being lost, a duplicate will be granted a written application (containing the necessary particulars, and accompanied by an additional commission) to the Postmaster of the Colony where the original Order was payable.

8. On the receipt of a similar application, payment of a Money Order may be stopped. 9. When it is desired that any error in the name of the remitter, or of the payee, should be corrected, or that the amount of a Money Order should be repaid to the remitter, application must be made by the remitter to the Chief Money Order Office of the issuing Colony. This application must be accompanied by an additional commission.

10. Repayment, whether of an original, or a duplicate Order, must not be made to the remitter unless it has been ascertained through the Chief Office of the Colony where such Order was payable, that the advice has been cancelled at the Office on which the Order was

originally drawn.

11. If an Order be not paid before the end of the twelfth Calendar month after that in which it was drawn-for instance, if drawn in January and not paid before the end of the following January, all claim to the Money will be forfeited, unless under special circumstances the Government of the Colony in which the Order was drawn think proper to allow it.

12. The advices of all Money Orders drawn in one Colony, after being impressed with the date stamp of the Office in such Colony, shall be forwarded by the first Packet, with a list similar to the accompanying form to the Postmaster of the other Colony, each list of advices being numbered consecutively 1, 2, 3, &c., in order of despatch, the numbers commencing at the beginning of each year at 1.

13. The Postmaster of each Colony shall not pay any Order unless the advice has been previously received, and unless that advice bears the date stamp of the Office at which the

Order purports to have been issued.

14. After once paying a Money Order by whomsoever presented, the paying Colony shall not be liable to any further claim. If a wrong payment however be made owing to the negligence on the part of any officer of the Department, the Governor of the Colony in which the negligence occurs, if he sees fit, may require the officer in default to make good the loss.

15. The Commission to be allowed to the paying office shall be half per cent.

16. The Postmaster in each Colony to be authorized to adopt any additional Rules (to be submitted in the case of Barbados for the approval of the Governor in Council) for the greater security against fraud or for the better working of the system generally. All such additional Rules, when approved, to be communicated to the Postmasters of the other Colonies.

17. Accounts between Trinidad and the Colonies named in Regulation 1, shall be

adjusted quarterly through the Crown Agents for the Colonies.

Made by the Governor, with the approval of Her Majesty's Postmaster-General in pursuance of provisions of the Post Office Ordinances No. 7 and No. 37 of 1890, this Seventh day of April, 1898.

# POSTMASTER-GENERAL.

# Annual Report for 1897.

Last Report, Council Paper No. 53 of 1897. Registered No. of Correspondence, No. 2378/1898.

HONOURABLE COLONIAL SECRETARY.

1. In my Annual Report for 1896, I called attention to the falling off in the amount remitted by Money Orders from this Colony to the United Kingdom and Foreign Countries, owing to the order issued by the Secretary of State on 7th April, 1896, to the effect that no person should be permitted to forward Money Orders by any Mail for an aggregate sum exceeding £20, and notwithstanding the fact that Orders may now be obtained up to 10, a. m., on the day of the departure of the Mail, neither the number of Orders nor the amount remitted to and through the United Kingdom during 1897, reached the totals of 1896.

2. There is almost every day evidence of the inconvenience experienced by Merchants and others in being subjected to this restriction, and I quite expect that a movement will shortly be made to obtain either the withdrawal of the restriction or

an increase in the amount to a sum not less than £100.

3. In the statement of Money Orders issued on the United Kingdom (including Appendix A. through Orders), British Guiana, Barbados, Grenada, St. Vincent, St. Lucia, Leeward Islands, Tobago and United States of America, Appendix A, it will be seen that the total amount issued during 1897, was £40,091 13 10, the number of Orders being 16,362, as compared with 22,405 Orders issued in 1896 for a total sum of £45,073 8 2, the sum collected as commission being £60 14 10 below that of 1896.

4. The main falling off in remittances was £3,914 16 2 to United Kingdom and Foreign Countries; £980 1.5 to Barbados, and £313 7 11 to Tobago; whilst there was an increase in the amount remitted to Grenada and Leeward Islands.

5. The remittances to the United States of America were slightly below those of 1896.

6. In the statement of Money Orders issued by the United Kingdom (including Appendix B. through Orders), British Guiana, Barbados, Grenada, St. Vincent, St. Lucia, Tobago, Leeward Islands and United States of America, Appendix B, the total amount exceeds that of 1896, by £728 4 6; the increases being from British Guiana, Barbados, Grenada and Tobago. Those from United Kingdom, St. Lucia, Leeward Islands and United States of America fell slightly below 1896.

7. As I pointed out in my last report, the sale of £10,649 17 5 Postage and Appendix C. Revenue Stamps in 1896, was quite abnormal, consequent upon the abolition of the old Postage Stamps and the introduction of a new design for Postage and Revenue Stamps, so that it is not surprising to find that the novelty of the New Stamps having abated, the sales for 1897 only amounted to £9,180 9 5½, being £1,469 7 11½ less than in 1896. I had estimated that the total Revenue of this Department for 1897 would be £9,020, but that as will be seen was exceeded by the sale of Stamps alone.

8. Money Order Offices were in operation at Port-of-Spain, San Fernando, Princes Appendix D. Town, Couva, Chaguanas, Cedros, Arima, Arouca, Mayaro, La Brea and St. Joseph

during 1897, and it is contemplated to add Tacarigua to the list shortly.

9. As an evidence of the increasing favour in which the Inland Money Order System is held, I may point out that the total sum remitted by Money Order within the Island in 1883 was £573 13  $10\frac{1}{2}$ . In 1897 the amount dealt with had risen to £9,324 1 0, being £1,205 8 1 more than in 1896.

10. The effect of this remittance of Money by Money Order is of very great importance to this Department, as it is found that the more Money Order Offices there are in operation the fewer complaints are made of missing letters containing Bank Notes. The number of such complaints has fallen quite 75 per cent. during the last 10 years, notwithstanding the very large increase in the number of Inland letters dealt with. No doubt some part of this diminution in the number of complaints is due to the more extended use of Registration, and I have reason to think there are very few persons who, in transmitting money to any place within the Island, fail to make use of either the Money Order or Registration Systems.

11. In an equally satisfactory degree do the remittances by Money Orders to places outside the Colony affect the number of complaints as to missing letters containing Bank Notes. The remitters of money to the Windward and Leeward Islands are principally Artisans, Labourers and domestic Servants whose residence in Trinidad is temporary, and who find it a convenient means of sending money to

their families resident in the adjacent Islands, and it was from this class that most complaints used to be received.

Appendix E.

- 12. There were dealt with in the General Post Office, Port-of-Spain, during 1897, a total of 724,104 Postal Articles forwarded to San Fernando and the various Sub-Offices throughout the Colony, being an excess of 216,672 over the preceding year; and it is interesting to note that whilst 89,004 of that excess was in Letters and Post Cards over which the Government exercises the sole right of collection and transmission, the very large number of 235,080 Newspapers and Books or 110,982 more than in 1896 were forwarded in 1897, although the Government has no control as to the manner in which Newspapers shall be conveyed within the Colony.
- 13. It is to be regretted that farthings are not in circulation in Trinidad, as I am quite sure if the minimum rate for Newspapers and Books, within the Colony, could be reduced to one farthing for the first 4 ounces, and ½d for each additional 4 ounces, the public would greatly appreciate the privilege, and this Department would very considerably extend its usefulness without appreciably increasing the cost for transport charges.

New Post & Money Order Offices. 14. The Office at St. Joseph was made a Money Order Office in October, 1897, and Post Offices were opened at Guiaco, Cumuto and Guanapo in December, 1897.

Remittances to

15. There were 1,213 Money Orders issued on India amounting to £3,616 11 2, being £926 7 9 less than in 1896.

Direct Money Order System with Jamaica and British Honduras.

- 16. A Direct System of Money Orders between this Colony and Jamaica will come into operation on 1st May next, and arrangements are nearly completed for a similar Service to British Honduras.
- 17. Since my last report the Sub-Offices at Williamsville, Erin, Blanchisseuse and Oropuche have been removed to more suitable premises, and fitted with modern appliances.

Appendix F.

18. There was a falling off of 431 in number of parcels received in Trinidad from beyond Sea, and 302 increase in the number of parcels sent from the Colony to places beyond Sea, during 1897.

Appendix C.

19. In the Inland Parcel Post, Appendix C, it will be seen that there was an increase of 1,164 Parcels forwarded from Port-of-Spain to San Fernando and Sub-Offices last year.

Parcel Post with United States of America. 20. There is every prospect that within a very short time the arrangements for a direct Parcel Post Service with the United States of America will have been completed, an agreement having been entered into with the Trinidad Shipping and Trading Company for the conveyance of parcels by their direct Steamers.

Mails per Cargo Steamer from Barbados.

- 21. I had occasion in my last report, to call attention to the great inconvenience and additional expense caused by the conveyance by Cargo Steamer once a month of the English Mails between Barbados and this Colony. In consequence, I understand, of some extra Cargo Boats being employed, the English Mails on three successive occasions, viz.: March 22, Avon, 11.40 a.m.; April 5th, Essequibo, 4.50 p.m.; April 19th, Larne, 7.45 p.m., have been forwarded from Barbados by Cargo Steamer.
- 22. If Mails are delivered to the Post Office before noon on Tuesday, they can be in the hands of Merchants and others before they leave their places of business at 4 p.m., but as in the case of the *Essequibo* and *Lurne* where the Mails did not reach this Office till after 4 p.m., several Merchants have assured me that no benefit accrues to them in such a case, and that they would much prefer to have the English Mail arrive at 6 a.m. on Wednesday, as formerly.
- 23. So far as this Department is concerned, the conveying by Cargo Steamer of the English Mail is very rarely of any advantage in expediting, to any considerable extent, the Mails for the country; and it frequently necessitates keeping the entire staff on duty till 10 p.m., besides doubling the cost of Extra Letter Carriers.

24. I shall be glad if something can be done to remedy this drawback to the otherwise punctual and satisfactory performance of the Royal Mail Contract.

25. It could easily be arranged that if the Cargo Steamer cannot leave Barbados on Monday in time to reach Trinidad by noon Tuesday, the Mails should come by the Inter-colonial Steamer as usual, and notice forwarded to the Agents here to that effect. This would enable me to advise the local Newspapers, the Post Office at San Fernando, and my Sub-Offices, and also permit me to arrange the attendance of my staff so as to save the Colony considerable expense.

Absent from the Colony.

26. During my absence from the Colony from May 13th, to November 30th, 1897, Mr. J. H. Collens acted as Postmaster-General, and my thanks are due to him and the staff generally for the efficient manner in which the work of this Department was performed.

A PARCEL POST Convention between this Colony and the United States of America has been concluded and takes effect from to-day.

There shall be admitted to the Mails exchanged under this convention articles of Merchandize and Mail matter, except Letters, Post Cards and written matter of all kinds that are admitted under any conditions to the domestic Mails of the Country of Origin except that no packet must exceed 11 lbs. in weight nor the following demensions, greatest length in any direction three feet six inches; greatest length and girth combined, six feet; and must be so wrapped or enclosed as to permit their contents to be easily examined by Postmasters and Customs Officers.

The following articles are prohibited viz:-

Publications which violate the Copyright laws of the Country of destination, poisons and explosive or inflammable substances, fatty substances; liquids, and those which easily liquify; confections and pastes, live or dead animals except dead insects and reptiles when thoroughly dried; fruits and vegetables and substances which exhale a bad odour; lottery tickets; lottery advertisements or lottery circulars; all obscene or immoral articles; articles which may in any way damage or destroy the Mails or injure the person handling them.

A letter or communication of the nature of personal correspondence must not accompany, be written on, or enclosed with any parcel.

#### RATES OF POSTAGE.

On all parcels transmitted by post under this Convention to the United States of America there shall be charged the following rates of postage viz:—

# LETTERS.

Unpaid letters to or from Postal Union Countries are charged double the prepaid rate. Partially prepaid letters are charged with double the deficiency.

2. No letter for a Colony or Foreign Country may exceed two feet in length or one foot in width or depth.

<sup>\*</sup> The transmission by Letter post of Coin, Gold, Silver, precious Stones or Jewellery, &c., is prohibited to those Countries marked thus\*.

- 3. Letters not specially directed by a particular route are, as a rule, forwarded by the first Mail dispatched.
- 4. The addresses of letters for Russia should be very plainly written; the name of the Town, and of the Province in which it is situated, should also be added in English, French or German.

  POST CARDS.
- 1. Official Post Cards, single and reply, are transmissible to all parts of the World. Single cards are issued with impressed stamps of 1d., and Reply Cards bearing stamps of the value of 1d. on each half.
- 2. Inland Post Cards are also transmissible abroad if the additional postage required is supplied by means of postage stamps affixed to the cards.

#### PRIVATE POST CARDS.

- 1. Private Post Cards bearing adhesive stamps of the value of one penny, and private reply cards with adhesive stamps of the value of one penny on each half, may be sent as post cards to places abroad, provided that they are in conformity with the official post cards. They must be of the same size and substance as the official cards, and must have the words "Post Card" printed or written on the address side, without the Royal arms.
- 2. The reply halves of private double cards must bear in print or writing the words "Post Card—Great Britain and Ireland" and "Reply."
- 3. Plain cards without any printed or written inscription cannot be sent abroad as Single or Reply Post Cards.
- 4. Engravings or advertisements may in future be printed on the face as well as on the back of a post card. They must not, however, interfere in any way with the clear indication of the address or with the stamping and marking of the postal service. Addresses of Post Cards may be written by hand or be shown upon a gummed label not exceeding two centimetres by five.
- 5. Except stamps for prepayment and the labels mentioned above it is forbidden to join or attach to post cards any article whatsoever.
- 6. Post Cards may not exceed the following dimensions: length, 14 centimetres, width, 9 centimetres.
- 7. The sender of a post card with reply paid may indicate his name and address on the face of the "Reply" half, either in writing or by sticking a label on it.

#### COMMERCIAL PAPERS.

- 1. The rate of postage for commercial papers is the same as for printed papers except that the lowest charge is  $2\frac{1}{2}d$ .
- 2. The following are considered as commercial papers and allowed to pass as such at the reduced postage, viz.: ½d. for every two ounces—viz.: all papers and documents whether writings or drawings, produced wholly or partly by hand not having the character of an actual and personal correspondence, such as papers of legal procedure, deeds of all kinds drawn up by public functionaries, way-bills or bills of lading, invoices, the various documents of Insurance Companies, copies of or extracts from acts under private signature, written on stamped or unstamped paper, musical scores or sheets of music in manuscript, the manuscripts of works or of newspapers, forwarded separately, pupils exercises with corrections but without any comment on the work, &c.
- 3. Commercial papers are subject, so far as regards form and conditions of transmission, to the regulations, prescribed for printed papers.

Commercial papers must not exceed more than 4 lbs. in weight or measure more in any direction than 18 inches. In the form of a roll commercial papers 30 inches in length and 4 inches in diameter may be forwarded.

#### SAMPLES.

- 1. Samples of merchandise are only allowed to pass at the reduced postage which is fixed for them under the following conditions.
- 2. They must be placed in bags, boxes, or removable envelopes, in such manner as to admit of easy inspection.
- 3. They must possess no saleable value nor bear any writing, except the name or the commercial style of the sender, the address of the person for whom they are intended, a manufacturer's or trade mark, numbers, prices, and indications relative to weight or measurement, and demensions or to the quantity to be disposed of, or such as are necessary to determine the origin and the nature of the goods. Articles of

glass, packets containing liquids, oils, fatty substances, dry powders, whether dyes or not, as well as packets of live bees, may be admitted to transmission as samples of merchandise, provided that they be packed in the following manner::—

- Articles of glass must be securely packed (boxes of metal, wood, leather or card Loard) in a way to prevent all danger to the correspondence and Postal Officers.
- 2. Liquids, oils, and fatty substances easily liquified must be enclosed in glass bottles hermetically sealed. Each bottle must be placed in a wooden box furnished with sawdust, cotton, or spongy material in sufficient quantity to absorb the liquid in case the bottle be broken. Finally, the box itself must be enclosed, in a case of metal, of wood with a screw top, or of strong and thick leather.
- 3. Fatty substances which are not easily liquified, such as ointments, soft soap, resin, &c., the transmission of which offers less inconvenience, must be enclosed in an inner cover (box, bag, of linen or parchment, &c.) which must itself be placed in a second box of wood, metal or strong and thick leather.
- Dry powders, whether dyes or not, must be placed in cardboard boxes, which themselves are enclosed in a bag of linen or parchment.
- Live bees must be enclosed in boxes so constructed as to avoid all danger and to allow the contents to be ascertained.

Transmission at the sample rate is likewise accorded to articles of natural history, dried or preserved animals and plants, geological specimens, &c., when sent for no commercial purpose and packed in accordance with the general regulations concerning samples of merchandise.

A packet of samples may not exceed 12 ounces in weight, 12 inches in length, 8 inches in breadth, and 4 inches in depth.

### SPECIAL EXCEPTIONS FOR THE UNITED KINGDOM.

The following articles specifically defined in the British Customs tariff as chargeable with duty either as being pure spirit or as containing spirits, or into the manufacture of which spirit has entered cannot be transmitted by sample post to the United Kingdom, viz.:—

### LIQUIDS.

Perfumed Spirits. Chloroform. Collodion. Ether. Acetic. Ether Butyric. Ether Sulphuric. Ethyl, Sodide of. Ethyl, Chloride. Ethyl, Bromide. Wine. Beer.

# OTHER THAN LIQUIDS.

Chlorate Hydrate. Confectionery in the manufacture of which Spirit has been used. Transparent Soap in the manufacture of which Spirit has been used.

#### PRINTED PAPERS OF EVERY KIND-(4d for 2 ozs.)

- 1. The following are considered as printed papers and allowed to pass as such at the reduced postage: Newspapers and periodical works; books, stitched or bound; pamphlets; sheets of music; visiting cards; address cards; proofs of printing, with or without the manuscripts relating thereto; papers impressed with prints in relief for the use of the blind; engravings; photographs; and albums containing photographs, pictures, drawings, plans, maps, catalogues, prospectuses, announcements, and notices of various kinds; printed, engraved, lithographed or otographed, and in general, all impressions or copies obtained upon paper, parchment, or cardboard, by means of printing, engraving, lithography, orthography, or any other mechanical process, easy to recognise, except the copying press and the type writer. To printed papers are assimilated reproductions of a manuscript or type-written original when they are obtained by a mechanical process of polygraphy (chromography, &c.,) but, in order to pass at the reduced postage, these reproductions must be brought to the Post Office counter and must number at least twenty copies precisely identical.
- 2. Stamps for prepayment, whether obliterated or not, and all printed articles constituting the sign of a monetary value are excluded from transmission at the reduced postage.
- 3. Printed papers of which the text has been modified after printing, either by hand, or by means of a mechanical process, or bears any marks whatever, capable of constituting a conventional language, cannot be sent at the reduced rate.

- 4. By way of exception to the rule laid down by the preceding paragraph it is allowed—
  - (a.) To indicate on the outside of the missive the name, commercial style, and the address of the sender.
  - (b.) To add in manuscript on printed visiting cards, the address of the sender, his title as well as good wishes, congratulations, thanks, condolences or other formulas of courtesy, expressed in five words at most or by means of conventional initials (p. f. &c.).
  - (c.) To indicate or to alter in a printed paper in manuscript or by a mechanical process the date of despatch, the signature or the commercial style and the profession, as well as the address of the sender.
  - (d.) To enclose the "copy" with corrected proofs, and to make in those proofs alterations and additions which relate to accuracy, form, and printing. In case of want of space, these additions may be made on separate sheets.
  - (e.) To correct also errors in printing in printed documents other than proofs.
  - (f.) To erase certain parts of a printed text in order to render them illegible.
  - (g.) To make prominent by means of marks, and to underline words or passages of the text to which it is desired to draw attention.
  - (h.) To insert or correct in manuscript or by a mechanical process, figures in prices current, tenders for advertisements, stock and share lists, trades circulars, and prospectuses as well as the travellers name and the date and place of his intended visit, in travellers announcements.
  - (i.) To indicate in manuscript, in advices of the departures of ships, the dates of those departures;
  - (k.) To indicate in cards of invitation and notices of meetings, the names of persons invited, the date, the object, and the place of gathering;
  - (1.) To add a dedication on books, sheets of music, newspapers, photographs and engravings, Christmas and New Year cards, as well as to enclose the relative invoice;
  - (m.) In forms of order or subscription for books, newspapers, engravings, pieces of music; to indicate in manuscript the works required or offered, and to erase or underline the whole or part of the printed communications;
  - (n.) To paint fashion plates, maps, &c.;
  - (o.) To add, in manuscript or by a mechanical process, to cuttings from newspapers and periodical publications, the title, date, number and address of the publication from which the article is extracted. Save the exceptions explicitly authorised herein, additions made in manuscript or by means of a mechanical process, which would deprive a printed paper of its general character and give it that of individual correspondence, are forbidden.
- 5. Printed papers must be either placed in wrappers, upon rollers, between boards, in cases open at both sides or at both ends, or in unclosed envelopes, or simply folded in such a manner as not to conceal the nature of the packet or lastly, tied with a string easy to unfasten. Address cards, and all printed matter of the form and substance of an unfolded card may be forwarded without wrapper, envelope, fastening, or fold. The face is reserved for postage stamps, for indications relating to the postal service, and for the address. The sender is allowed to indicate on it his name, calling, and address, by means of a stamp, autograph stamps, or other typographic process. Book orders may also bear the printed indication "Book Order Form" or "Order for Books." Cards, bearing the inscription "Post Card" are not allowed to go at the rate for printed matter.

The rate of postage for printed papers, Books of every kind is ½d. for any weight not exceeding 2 ounces, and ½d. for each additional 2 ounces.

No packet of printed papers or books may exceed 4 lbs. in weight, 18 inches in length, 12 inches in width or depth.

To all places not mentioned in the above list the present rates of postage on parcels will continue in force.

Registration.—1. The fee for registration is 2d. To some Countries an article can be registered only to the port of arrival; it being left in those cases, to the postal authorities of the Country to which that port belongs to continue the registration or not as they may think proper. To Madagascar there is no arrangement whatever for registration.

- Registration is applicable equally to letters, post cards, newspapers, book packets and patterns addressed to places abroad.
- 3. The Sender of a registered article addressed to any Foreign Country or British Colony in the Postal Union may obtain an acknowledgment of its due receipt by the addressee on paying a fee of  $2\frac{1}{2}$ d, as well as the registration fee in advance at the time of registration.
- 4. No article addressed to initials or a fictitious name can be registered. The prohibition, however, does not extend to articles addressed to the care of a person or firm.
- 5. Every letter presented for registration must be enclosed in a strong envelope securely fastened.
- 6. It is prohibited to send to a Country of the Postal Union any registered article marked on the outside with the declared value of the contents; and Postmasters will therefore refuse to receive articles which are so marked.
- 7. Registered articles must be prepaid as regards both postage and registration fee.
- 8. Articles to be registered must be given to an agent of the Post Office, and a receipt obtained for them; they should on no account be dropped into a Letter box.
- 9. It is forbidden to send coin, jewellery or precious articles through the Post to Countries of the Postal Union. No letters or packets containing such articles can be accepted for registration.
- 10. The several Postal Administrations of the Countries belonging to the Postal Union undertake to pay an indemnity of fifty francs in the event of its being proved to their satisfaction that a registered letter itself has been lost whilst in their custody, but no question of compensation is entertained by them for, or in respect of, the loss of the enclosure of any such letter.

Constitution of the Legislative Council.

2. The Legislative Council of the Colony of Trinidad and Tobago shall consist of the Governor and of the following Officers, that is to say: the persons from time to time lawfully discharging the functions of Colonial Secretary, Attorney-General, Commandant of the Local Forces, Solicitor-General, Auditor-General, Director of Public Works, Surgeon-General, Protector of Immigrants, Receiver-General, and Collector of Customs, who shall be called the Official Members of the Legislative Council, and of such other persons as are now Members of the Council, or as the Governor may hereafter from time to time appoint by any Instrument under the Public Seal of the Colony, who shall be called the Un-official Members of the Legislative Council.

Official Members.

3. The Official Members of the Legislative Council shall take precedence of the Un-official Members; and among themselves shall take precedence according to the Order in which their respective offices are herein-before mentioned. The Un-official Members shall among themselves take precedence according to the order which they now hold, and in the case of Un-official Members hereafter appointed according to the priority of their respective appointments; or if appointed by the same Instrument, according to the order in which they are named therein.

Precedence of Members

> 4. Every Un-official Member of Our said Legislative Council re-appointed immediately on the termination of his term of office shall take precedence according to the date of his first appointment to the said Council.

> 5. Every person who at the date of the receipt of these Instructions in Our said Colony is an Un-official Member of the Legislative Council may retain his seat until the end of five years from the date of the Instrument by which he was appointed, and every Un-official Member appointed or to be appointed after the date of such receipt shall vacate his seat at the end of five years from the date of the Instrument by which he is appointed.

Vacation of seats by Un-official Members

Every such Un-official Member shall be eligible to be re-appointed by Our said Governor for the like period of five years.

NOTES—Excluding the earnings belonging to the newly opened Tabaquite Extension, there is a marked falling off in the passenger traffic generally. The loss of Revenue from Goods traffic is due to the cessation of haulage of construction material for the new lines, also to fewer estate supplies having been dealt with. The Telegraph receipts owe their losses to the Suburthe telegraph receipts owe their losses to the subtr-ban Telephone system now controlling the country districts, also the Cedros and Mayaro lines. Miscella-neous earnings are regulated almost entirely by the sales of old materials, &c., and there were practically none of these in the month of November, 1898, which generally speaking, has been one of unusual dulness, notwithstanding that the Cocoa brought into town by Railway was 3,272 bags against only 2,677 in November, 1897. The reduced tariff continues to exercise a depressing influence upon the total revenues of the Department.
