BE it enacted by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof as follows:—

- 1. This Ordinance may be cited as the Post Office Ordi-Short title. nance 1903. It shall be read with the Post Office Ordinances, Construction. 1890—1896. The Post Office Ordinances 1890–1896 and this Ordinance may together be cited as the Post Office Ordinances, 1890–1903.
- 2. Subject to the regulations to be from time to time Postal Orders. made under this Ordinance, the Postmaster-General with the consent of the Governor may for the purpose of the transmission of small sums through the Post Office, authorize his officers or any of them to issue in addition to the Money Orders already authorized by law, Postal Orders payable within this Colony only. Such orders shall be exempt from stamp duty.

Regulations.

- 3. It shall be lawful for the Postmaster-General with the approval of the Governor from time to time to make, alter or revoke regulations with regard to Postal Orders—
 - (a.) Fixing the amounts for which such orders may be issued and the poundage payable in respect thereof;
 - (b.) Specifying the places at which such orders may be issued and paid;
 - (c.) Providing for the making up of amounts for which orders are not issued by the affixing of postage stamps to such orders;
 - (d.) Prescribing the form of such orders;
 - (e.) Generally for regulating and controlling the issue and payment of such orders.

Any such rules shall be deemed to be rules under Section 5 of Ordinance 37 of 1890.

EXCELLENCY:

I have the honour to report to Your Excellency that the recent events which have occurred here, are likely to lead to the eventual resumption of work on the Canal, but it nevertheless appears to me desirable to issue a warning against any possible contemplated immigration of labourers from Trinidad, in search of employment, for the present.

It is out of the question, for the moment, to indicate with any certainty how many months must elapse before a demand for labour will arise which cannot easily be met by the surplus supply with which we have long been burdened on the Isthmus, but in any case it may be taken for granted that ample notice will be given, as soon as there is any prospect of employment on a large scale, in the construction of the Canal, and in the meantime, an influx of labour in anticipation of such demand should be seriously discouraged, as it would only result in increasing the numbers of the un-employed, and occasioning hardship and disappointment to the immigrants themselves.
