Broken amounts, but not fractions of a penny, may be made up by the use of Trinidad Postage Stamps not exceeding five pence in value affixed to the face of any one Postal Order.

The person to whom a British Postal Order is issued must, before forwarding it, fill in the name of the person to whom the Order is to be paid, and may fill in the name of the Money Order Office at which the amount is to be paid. The insertion of the name of the Paying Office affords a safeguard against payment being made to a wrong person.

Every person to whom a Postal Order is issued should tear off and retain the counterfoil; its production will facilitate enquiry if the Order should be lost.

In the case of the miscarriage or loss of any British Postal Order unless proof can be given to the satisfaction of the Post Office that the name of the payée was inserted in the Order before the holder parted with it, and unless the number of the Order can be furnished, the Postmaster-General of the United Kingdom, cannot undertake to trace the Order with a view to accounting for the miscarriage or loss thereof.

After a British Postal Order has once been paid, to whomsoever it is paid, the Postmaster-General of the United Kingdom or Trinidad will not be liable for any further claim.

If a Postal Order be crossed & Co. payment will only be made through a Banker; and if the name of the Banker be added, payment will only be made through that Banker.

No British Postal Order will be paid, even though presented for payment through a Banker, unless the name of the payée be inserted in the body of the Order.

A British Postal Order presented by, or through, a Banker for payment will not (in the absence of an express arrangement between such Banker and the Postmaster-General to the contrary) be paid until after such Order has been examined at the Chief Office in the country of payment.

BRITISH VICE-CONSULATE.

Guadeloupe, Pointe-à-Pitre, 16th January, 1995.

Sir.

I have the honour to forward the inclosed translation of a letter which I received from the Officer Administering the Government of this Colony, relative to certain arrangements which His Excellency will be prepared to make for the reception of parties of tourists who may wish to visit Guadeloupe

whilst cruising in the West Indies this winter.

I may add that that part of the colony known as Guadeloupe proper is well worth visiting. Its mountain scenery is incomparably beautiful, and the most interesting districts are accessible by horse, carriage or automobile which can be hired here at reasonable prices.

The Commune of Saint Claude mentioned in Governor Richard's letter, is a beautiful and popular summer resort situated on the Western slope of Mount Soufrière. Some of the most elevated villas, at Matouba, in the same commune are at an altitude of 2,275 feet above the level of the sea. Saint Claude possesses some fine government buildings and a residence for the Governor of the island. Its climate is delightful at all seasons of the year and is very healthy, the mean temperature being 20° centigrade, and the minimum at Matouba, in the month of February, 10° centigrade.

High above Saint Claude towers Mount Soufrière, the highest peak in the island, if not in the lesser Antilles, with an altitude of 4,823 feet. The Soufrière is of a majestic and picturesque aspect, on the summit of which exists an active volcano. Be it only for an excursion to that wonderful curiosity of nature, tourists should not fail to include Guadeloupe in their West Indies cruise. But there are many other charming spots which it will be worth while to see also.

Perhaps your Excellency will be good enough to cause the above to be brought to the notice of tourists who may call at the islands under your Excellency's government.

I have learnt that English tourists intend taking advantage of the Royal Mail Steamers to visit the West Indies.

I have the honour to let you know, with the request that you will please inform the Governors of the English islands of the fact, that I shall be prepared, in the event of parties of tourists wishing to come to Guadeloupe, and stay there for some time in order to see the sights of the Colony, to make arrangements with the Military Authorities for placing at the disposal of the tourists certain government apartments at present unoccupied at Basse-Terre and at Saint Claude.

So far as I am concerned personally, I will do all what is necessary to facilitate their stay in the island.

I request you, Sir, to be good enough to keep me informed of the reply which will be made to the present communication.

Minutes.

The Minutes of the Special meeting on the 30th of January were read and confirmed.

Mr. Cipriani called attention to the absence from the Minutes of any mention of the fact Votes of Condolence≥ that he had spoken to the resolution which was adopted at the last meeting of the Council in connection with the death of the Honourable René de Verteuil.

> After discussion, His Excellency the Governor directed that in future, in the case of Votes of Condolence, the names of any members who spoke on the subject should be recorded in the Minutes of the meeting.

The Colonial Secretary read the following Minutes from His Excellency the Governor:-

MINUTE.

No. 1 of 1905.

W.I. Mail Service Tender of R.M.S.P.

Names of Members speaking to be recorded.

The Governor has the honour to inform the Honourable Members of the Legislative Council that having been confidentially advised by telegram that the only practicable tender for the Mail Service was from the Royal Mail Steam Packet Company, Limited, for an increased subsidy, and that the whole of the increase would have to be made up by the Colonies concerned, and having been requested to inform the Secretary of State by telegraph of his opinion, a telegram was despatched asking permission to consult the commercial community.

- 2. This permission was given by telegraph on the evening of the 17th of January, and on the 18th a letter was sent to the Chamber of Commerce to acquaint them of the circumstances and to ask their views. Ju reply a Resolution of the Chamber was sent objecting to any increase of subsidy as long as the Mail Service was conducted on the present lines, but stating that if Trinidad were made the headquarters and transfer port of the Royal Mail Steam Packet Company, Limited, the Chamber consider that the present extra subsidy of £5,000 a year might be continued for five years.
- 3. Since the above letter was sent to the Chamber of Commerce a despatch has been received from the Secretary of State forwarding a copy of the tender, and it now appears that were the offer accepted the annual contribution expected from Trinidad would probably be upwards of £13,000, although this Colony would enjoy no greater advantages under the new Contract than under the present one. As this Council was not in session, and as an immediate opinion was asked for, the Secretary of State has been informed that the Governor does not consider it to be to the interest of the Colony to pay so large a subsidy without any improvement of the existing service.

 - At the General Post Office, Port-of-Spain, and Post Offices at San Fernando and Scarboro, when open to the public and at the Wardens Offices mentioned above at such days and at such hours as shall be decided on, of which notice shall be given.
- 7. The Postmaster who issues a Postal Order shall sign the Order and affix the date stamp of his office in the place indicated on the Order for such stamp.
- 8.—(a.) The person to whom an Inland Postal Order is issued must before parting with it fill in the name of the person to whom the amount is to be paid. The person so named must, before payment can be made, sign the receipt at the foot of the Order.
- (b.) The person to whom an Order has been issued may, if he desires payment to be made at any particular one of the paying offices mentioned in Regulation 4, fill in the name of such office; in which case payment of the Order will only be made at such office.
- (c.) The name of the paying office if not already filled in by the remitter of the Order must be filled in at the time of payment by the person to whom payment is ultimately made.

- 9. In case of the miscarriage or loss of a Postal Order, unless the number and amount of the Order, and the name of the payee inserted thereon are furnished to him, the Postmaster-General will be unable to assist in tracing such Order, and no payment will be made on account of any such Order except on presentation of the Order itself.
- 10. After an Order has once been paid—to whomsoever it is paid—the Postmaster-General will not be liable for any further claim.

Payment of Postal Orders through Bankers.

- 11. If any Order be crossed "& Co." payment will only be made through a Banker, and if the name of a Banker be added payment will only be made through the Banker so named.
- 12. No Inland Postal Order will be paid, even though presented for payment by a Banker, unless the name of the payee be inserted in the body of the Order.
- 13. Payment of a Postal Order, on which any erasure or alteration appears, or which has not been stamped or signed by the issuing Postmaster, or which has been cut, defaced or in any way mutilated may be refused.
- 14. When payment of an Order has been made the paying officer is to initial it and write in red ink the date of payment in the place indicated on the Order for that purpose.
- 15. The Postmaster-General and any Postmaster, or Warden may refuse or delay payment of an Order it he has a good and sufficient reason for so doing, but the reason for so doing must be at once reported to the Postmaster-General.
- 16. If an Order be not paid within three months from the last day of the month of issue, a commission equal to the original poundage will be charged in respect of each further period of three months, or any fraction of three months, which has elapsed. The commission thus paid must be denoted by Trinidad Postage stamps affixed to the back of the Order.
- 17. Any person presenting an Inland Postal Order may be required to sign his own name thereto, notwithstanding that the receipt may have been already signed.

On the motion of the Acting Colonial Secretary, seconded by Mr. Fenwick and agreed to, the Suspension of Standing Orders were suspended and the reading of the Minutes of the previous meeting were Standing Orders accordingly postponed.

The Acting Colonial Secretary read the following Minute from His Excellency the Governor, Postponed.

viz.:-

MINUTE.

No. 7 of 1905.

The Secretary of State for the Colonies has desired the Governor to inform the Legislative Council West Indian Mail Service were not satisfactory, and as there Service. seemed to be a general wish throughout these Colonies that they should not be left entirely without a contract service, the Postmaster-General called for fresh tenders and four were received.

Of these the only tender which His Majesty's Government thought sufficiently favourable to consider, as an alternative to no contract, was that of Messrs. Elder, Dempster & Co. which is to continue the Mail Service on its present lines and at the present subsidy. The steamers running on the main line are to be of not less than 5,000 tons gross tonnage, and those on the branch lines 4,000 tons; Passengers and baggage to be landed and embarked free; and Barbados to remain port of transhipment as at present; all steamers to be fitted with cold storage; London to be the port of arrival and departure for freight; and Plymouth for passengers, giving an additional 24 hours for the outward mail.

The Postmaster-General is to have the option of requiring the fleet of Mail Steamers to be of the Port Kingston type if the contract be prolonged to ten years instead of five and a half, and for an extra payment of £26,000 the contractor is to undertake to run a fortnightly freight and cold storage service.

Trinidad and Jamaica will pay as now if the main line steamer continues to call at Trinidad, but if not then the extra contribution of £5,000 from Trinidad ceases, and Jamaica will pay £500 more as before Trinidad was put on the main line.

It should be clearly understood that in accordance with the advice of the Postmaster-General His Majesty's Government have accepted this contract conditionally on its merits, and as no other would be accepted by His Majesty's Government no other can be submitted to the Legislative Council. The alternative therefore is between accepting this tender and the discontinuance of the contract.

The Secretary of State has asked for the earliest possible reply, and should a preponderance of opinion be in favour of the contract it will be finally accepted, and any particular Colony that may object will be expected to continue to pay its existing contribution.

The Secretary of State desires to receive a full expression of opinion without the use of the votes of Official Members but he trusts that when the final decision is taken he may assume that the Colonies will abide by it.

 - "That if the Contract is still open this Council strongly favours preference being given to the Royal Mail Steam Packet Company if they are prepared to continue present service at subsidy not exceeding £80,000 a year, retaining Trinidad on Main Line without extra payment.
 - "That this Council protests against the acceptance of any tender under which this Colony would be forced to continue an extra payment of £5,000 a year to retain an advantage which the Royal Mail Steam Packet Company offered for no extra payment.
 - "That this Council protests strongly against the interests of the more important Colonies of Trinidad, Barbados, Jamaica, and Demerara being dependent on the opinions of Colonies the serving of which by any regular mail service is the principal reason why a heavy subsidy is required by Companies tendering."
- Mr. Goodwille moved as an amendment :-
 - "That if the Contract is still open Messrs, Elder Dempster & Co. should have the same opportunity to send in amended tenders as have now been submitted by the Royal Mail Company."

The amendment was not seconded.

His Excellency the Governor communicated to the Council the public telegram reporting the resolution passed by the Legislative Council of Jamaica, with regard to the Mail Service, and also the following telegram from the Right Honourable the Secretary of State for the Colonies, both of which he had just received:—

"In reply to your telegram of yesterday's date you will let it be clearly understood that His Majesty's Government adhere wholly to the terms of my previous telegrams and tenders having been opened cannot be party to any further competition between the tenderers."

After discussion, Mr. Fenwick accepted a proposal by Mr. Alcazar for the amendment of the Resolution he had proposed, and substituted the following, which he moved:—

"Resolved.—That the Un-official Members of this Council unanimously disapprove of the Contract with Messrs. Elder Dempster and Company for the reason that it does not require the Main line Steamers to call at Trinidad without an extra subsidy, and the only alternative to the acceptance of that Contract left to us by the Secretary of State being to have no Contract, desire to express their opinion that there should be no Contract: and that this Council protest strongly against the interests of the more important Colonies of Trinidad, Barbados, Jamaica and Demerara being dependent on the opinions of Colonies the serving of which by any regular Mail Service is the principal reason why a heavy subsidy is required by Companies tendering."

The resolution was seconded by Mr. Alcazar, and carried by the unanimous vote of the Un-official Members, the Official Members not voting.

At 2.35 p.m., His Excellency adjourned the Council to Monday, the 1st May.

SIR,

I have the honour to enclose for your information and guidance, a copy of a letter from the P.O. 26th June, 1905. General Post Office on the subject of the postal arrangements to be made in view of the termination of the Contract with the Royal Mail Steam Packet Company, and I would invite your special attention to paragraphs 10, 12, 13 and 17 of the Post Office letter.

- 2. With regard to paragraphs 12 and 13, I enclose, for your information, a copy of Sections 36-42 of the British Guiana Ordinance, No. 28 of 1893, not as being necessarily suitable for adoption in the Colony under your Government, but as an example of the kind of legislation required, should you be advised that the existing legislation does not adequately meet the necessities of the case, and that it is desirable that such powers as those referred to by the Postmaster-General should be conferred upon the Government by fresh legislation. In the meantime, in the absence of the requisite powers, you will probably think it desirable to adopt the course suggested in paragraph 13 of the Post Office letter, and if so it would be well if you would send me an intimation of your wishes by telegraph.
- 3. With reference to paragraph 10, I would suggest that the rates of payment proposed by the Postmaster-General should be adopted by your Government; and I am making a similar suggestion to the other West Indian Colonies served by the steamers of the Royal Mail Steam Packet Company.

GENERAL POST OFFICE, LONDON, June 26, 1905

SIR.

With reference to your letter of the 16th of this month, No. 20297/1905, and previous correspondence, I am directed to acquaint you, for the information of the Secretary of State for the Colonies, that the Postmaster-General has received from the Royal Mail Steam Packet Company information concerning their arrangements for the despatch of steamers to the West Indies after the termination of their contract. The Directors intend, it seems, to continue unaltered their existing services until the 1st of August next; and the steamers taking the outward voyages up to the date mentioned will also perform the homeward journeys as if they were Mail steamers, the corresponding inter-colonial steamers being maintained for the time being exactly on the same lines as under the contract.

- 2. As regards arrangements after the 1st of August, the Company have under consideration a revision of the dates of departure from this country which will probably involve some rearrangement of the inter-colonial services; but the Postmaster-General is assured that due notice of any decision to this effect will be communicated to him at least a fortnight in advance to the execution of any change in the services.
- 3. In these circumstances, the Postmaster-General has come to the conclusion that for the immediate future it will not be necessary to make any alterations in regard to the despatch of mails from this country; and he proposes to continue to forward by the Company's steamers all correspondence and parcels for the West Indies and Central America which would under present arrange nents fall into the contract service.
- 4. At present the two direct British mail routes are used for the conveyance of all correspondence not specially superscribed to be sent otherwise, for the whole of the West Indies. Such correspondence for Jamaica is sent alternately by the Royal Mail Company's service and Messrs. Elder, Dempster and Company's fruit service; for Turk's Islands it is sent by the fruit service only; and for the rest of the West Indies, namely, Barbados, Trinidad, Tobago, British Guiana, and the Leeward and Windward Islands, it is sent by the Royal Mail Company's service only.
- 5. Specially superscribed correspondence is also sent to the West Indies (1) by steamers belonging to Messrs. Scrutton Sons and Company, Messrs. J. and W. Harrison, and other firms; (2) by French packets (touching at Trinidad, St. Lucia, and British Guiana); and (3) by way of New York, whence there are frequent but irregular sailings to most of the islands.
- 6. When it is known to what extent the Company propose to modify their present service, it may perhaps be found desirable to forward the bulk of the correspondence viâ New York, while taking advantage of any favourable opportunities which may occur or sending mails by direct steamers.
- 7. Parcels would have to be sent by such steamers, as long as the New York route remains unavailable for parcel mails.
- 8. The Postmaster-General does not propose to enter into any arrangement whatever with the Company, but he will tender the mails to them as ship letter mails under the Post Office Act of 1840.
- 9. Payment for the conveyance of the correspondence will be made to the Commanders of the Royal Mail Company's steamers, or to the Company under the written authority of the Commanders, at ship letter rate settled by the Lords Commissioners of His Majesty's Treasury in accordance with the provisions of the Act in question. This rate has been fixed at $\frac{1}{2}$ d, for each letter, post-card or other article.
- 10. The Postmaster-General is advised that, under that Act and other Post Office Acts, parcels might legally be placed on the same footing as letters, and it would, therefore, be within his powers to require the carriage of parcels also at the above-mentioned rate. He is of opinion, however, that, as it has never yet been deemed advisable, even if equitable, to enforce this legal right, it would be inopportune to enforce it on the present occasion, especially as there is existing Treasury Authority for making special payments for the conveyance of parcels to the West Indies and places beyond. Under this authority payment for parcels will be made at the following rate:—

For each parcel not exceeding 3 lbs. in weight, 4d.

11. In the case of closed mails containing letters, postcards, &c., which may still be received from places abroad for conveyance by the Company's steamers, this Department would, in the natural course of events, receive payment from the Post Offices of the countries of origin under the regulations of the Postal Union; and the amounts received on that basis will be handed over t the Company.

- 12. With regard to the use of the steamers of the Royal Mail and other Companies for the conveyance of mails in the reverse direction, the Postmaster-General thinks it possible that, in the case of many, if not all, of the West Indian Colonies, powers similar to his own have been conferred by local legislation upon Colonial Postmasters, whereby they could require every master of a ship "to receive on board his vessel every post letter bag tendered to him for conveyance, and having received the same, to deliver it on his arrival at the port or place of destination without delay." If such be the case the various Colonial Postmasters will no doubt notify the local agents of the Company, or of any Companies whose steamers they propose to use, of their powers in this respect, and of their intention to act in accordance therewith, and to pay gratuities for the conveyance of letters, &c., at the authorized rates.
- 13. In cases, on the other hand, where such powers are not conferred by Colonial Legislatures, I am to point out that, under the Post Office (Management) Act, 1837, Section 2, the Postmaster-General's monopoly is extended "wheresoever within the United Kingdom and other His Majesty's dominions posts or post communications are established," and that the Postmaster-General is competent to appoint an agent at the various ports in the West Indies to tender and receive mails on his account. If, therefore, any difficulty were likely to arise in the way of despatching mails from the Colonies, Lord Stanley could at once appoint the Postmasters of the several Colonies to act as his agents.
- 14. Mr. Secretary Lyttelton will perhaps cause the various Colonies to be at once informed of the facts of the case, and of the steps about to be taken here.
- 15. I am to state that the Royal Mail Company have asked to whom they are to look for "the conclusion of arrangements" connected with the homeward mail service; and the Postmaster General of British Guiana has asked to be informed what rates are to be paid for the conveyance of mails by the Royal Mail Company's steamers after the expiration of the contract.
- 16. The scale of charges proposed to be paid by this office for outward parcels might also, it is thought, be conveniently adopted by the Post Offices of the Colonies.
- 17. But as regards "arrangements," Mr Lyttelton may probably agree with Lord Stanley that it is undesirable for the Colonial Governments at the present juncture to make any arrangements which can be construed into a contract or agreement with the Company.
- 18. Lord Stanley will be glad to learn Mr. Lyttelton's views on the whole matter as early as convenient.

SHIP LETTERS.

36. Every master of a vessel outward bound, or passing coastwise or otherwise between Duty of master of ports or places within the Colony, shall receive on board his vessel every mail bag tendered to outward-bound him by an Officer of the Post Office for conveyance, and, having received the same, shall deliver mails. it, on arriving at the port or place of his destination, without delay, and, if he fails to comply with this section, he shall on being convicted thereof, be liable to a penalty not exceeding five hundred dollars.

37.—(1.) Every master of a vessel inward bound shall collect all letters on board his vessel, Duty of master of not being letters excepted from the privilege of the Postmaster-General, and not being letters by inward-bound vessel as respects this Ordinance defined as shipowners' letters, and enclose them in some bag or other covering, letters. sealed with his seal, and addressed to the Postmaster-General, and without delay deliver such letters to the proper Officer of the Post Office demanding such letters, or, if no demand is made by such Officer, then at the Post Office with which he can first communicate, or, if the vessel is liable to the performance of quarantine, to the person appointed to superintend the quarantine, who, after taking the proper precautions, shall deliver them at the Post Office.

(2.) The master of every such vessel, shall at the port where the vessel reports, sign, in the presence of the proper Officer of the Post Office, who shall also sign the same, a declaration of compliance with this Ordinance (which may be in the form contained in the Second Schedule to this Second Schedule. Ordinance,) and shall not break bulk or make entry in any port until he has complied with this

- (3.) If any master of a vessel acts in contravention of or fails to comply with this section, he shall, if he has wilfully delayed the delivery of letters as required by this section, be liable, on being convicted thereof, to a penalty not exceeding one hundred dollars, and, in any other case, to a penalty not exceeding two hundred dollars.
- (4.) If any person appointed to superintend the quarantine acts in contravention of or fails to comply with this section, he shall, on being convicted thereof, be liable to a penalty not exceeding two hundred dollars.
- (5.) For the purposes of this section the Harbour Master of any port where any such vessel arrives shall be deemed to be an officer of the Post Office, and if any letters are delivered to a Harbour Master under this section he shall immediately forward the same to the nearest Post Office.

Opening mail bag by master of vessel.

- 38.—(1.) If any master of a vessel—
 - (a.) Opens a sealed mail bag with which he is intrusted for conveyance; or
 - (b.) Takes out of a mail bag with which he is intrusted for conveyance any postal packet or other thing,

he shall, on being convicted thereof, be liable to a penalty not exceeding five hundred dollars.

(2.) If any person to whom letters have been entrusted by the master of a vessel to bring on shore breaks the seal, or in any manner wilfully opens the same, he shall, on being convicted thereof, be liable to a penalty not exceeding one hundred dollars.

Duty of Officer of Customs as to delivery cf letters by master of vessel.

- 39.—(1.) An Officer of Customs shall not allow any inward bound vessel to report until the master has made the declaration required by this Ordinance with respect to letters, and shall not permit any such vessel to break bulk or make any entry until the letters on board thereof have been delivered to an Officer of the Post Office or at a Post Office as required by this Ordinance, and shall search every such vessel for letters which may be on board contrary to this Ordinance and may seize the same and forward them to the nearest Post Office.
- (2.) If any Officer of Customs acts in contravention of or fails to comply with this section, he shall, on being convicted thereof, be liable to a penalty not exceeding two hundred dollars.

- 40.—(1.) The following letters (in this Ordinance referred to as shipowners' letters), that is to say, letters of the owners, charterers, or consignees of vessels inward bound, and of the owners, consignees, or shippers of goods on board such vessels, when not exceeding the weights and when complying with the conditions hereinafter mentioned, shall—
 - (a.) If required to be delivered at the port of the vessel's arrival, be delivered to such owners, charterers, consignees, or shippers by the master before he delivers the other letters, to the Post Office, and shall be so delivered free of inland postage; and
 - (b.) If delivered elsewhere in the Colony, shall be delivered on payment of inland postage only: Provided that—
 - (a.) The letters brought by any one vessel to any one such person shall not collectively exceed six ounces in weight;
 - (b.) The owner, charterer, or consignee shall be described as such on the address and superscription; and
 - (c.) In the case of owners, shippers, or consignees of goods, it shall also appear by the ship's manifest that they have goods on board the vessel.
- (2.) If any shipowners' letters are found by an Officer of Customs to be in excess of the weights hereinbefore limited by this section, that Officer shall seize so many of the letters as will reduce the remainder within the said weights, and shall forward the same to the nearest Post Office.

Gratuities to masters of vessels. 41. The Postmaster-General may, with the approval of the Governor in Council, allow to masters of vessels in respect of postal packets, or any description thereof, conveyed by them on behalf of the Post Office, and also to pilots, seamen, and others in respect of postal packets, or any description thereof, brought by them to any Post Office from any vessels, such gratuities under such regulations and restrictions as from time to time may be determined upon.

Retention of ship letters after delivery of letters to Post Office.

42. If any person, being either the master or one of the officers or crew of a vessel inward bound, or a passenger thereof, knowingly has in his baggage or in his possession or custody, any letter not excepted from the privilege of the Postmaster-General, after the master has sent any part of the letters on board his vessel to the Post Office, he shall for every such letter be liable, on summary conviction, to a penalty not exceeding fifteen dollars, and if he detains any such letter after demand is made for the same, either by an Officer of Customs or by a person authorized by the Postmaster-General to demand the letters on board the vessel, he shall for every such letter be liable, on summary conviction, to a penalty not exceeding thirty dollars.

The Governor has the honour to return to the Honourable the Legislative Council the Ordinance passed at the meeting of the Council on the 3rd ultimo, entitled "An Ordinance to make provision for "giving effect to the recommendations of a Conference made with regard to quarantine in the West "Indies," for the purpose of introducing the following amendments, namely:—

Section 2-In line 2 the word "proposed" to be omitted.

Section 5-In the last line the word "delegate" to be substituted for the word "officer."

Section 8-Sub-section (i) to be omitted.

Section 34—The words "and the same may be recovered in any Court of competent jurisdic-

"tion," at the end of the section, to be omitted.

Section 40-In line 2 the words "Part I of" to be struck out.

In line 6 after the words "in default" the words "of payment" to be inserted.

In line 10 after the word "prescribed" the words "by this Ordinance" to be added.

In line 11 the words "by any rule or regulation made hereunder" to be struck out.

In the second line on page 12 the words "Part I of" to be omitted.

Section 41—In line 1 after the figures "33," the word "and" to be inserted, and in the next line "35 of" to be struck out and the words "under any rules and regulations under" to be inserted in lieu thereof.

Section 45-Sub-section (4) to read as follows:-

No plaintiff shall recover in any such action if tender of sufficient amends shall have been made before such action shall have been brought, or if a sufficient sum of money shall have been paid into Court after such action shall have been brought by or on behalf of the defendant; and if the plaintiff shall discontinue his action after issue joined or if upon demurrer or otherwise judgment shall be given against the plaintiff, the defendant shall recover his full costs of suit to be taxed, and in all other cases costs shall be in the discretion of the Court.

MINUTE.

No. 14 of 1905.

The Governor has the honour to inform Honourable Members, that having been advised by the Fruit Industry-Sub-Secretary of State for the Colonies, that he had been unable to obtain satisfactory guarantees from the sidiary Company Symington Fruit Company for the resumption of their operations in Trinidad, and had therefore of Royal Mail Steam brought the negotiations to a close, it became urgently necessary to seek some other means of disposing Packet Company. of the fruit, which had been planted to supply the market which that Company promised to afford.

The result of enquiries was an offer from the Royal Mail Steam Packet Company to form a subsidiary Company to undertake the purchase and shipment of fruit from Trinidad for the European markets, provided that a similar guarantee to that granted to the Symington Company, namely 5 per cent. on a maximum paid up capital not exceeding £15,000, could be given to them. This His Excellency undertook to recommend to the Council, on being advised that the Company had been actually formed, and the Secretary of State has approved of his doing so.

Advice has been received by the last mail that the Fruit Company has been formed and registered, under the auspices of the Royal Mail Steam Packet Company, with Mr. E. C. Skinner, the representative in Trinidad of that Company, as local Director, and that Mr. Frank Pink (of the firm of Messrs. William Pink & Sons, Fruit Merchants and Brokers, Portsmouth) has joined the directorate in England. Mr. Skinner leaves England by the mail of the 4th instant to arrange for commencing operations with the least possible delay.

It has been pointed out in the course of the negotiations with the Colonial Office, that as the subsidiary Company has already been formed and registered with a capital of £50,000, of which £8,000 will immediately be subscribed, and will be called up as required, on the liability of substantial shareholders, it would involve this Colony in a needless expenditure if the condition attaching to the grant to the Symington Company, that £8,000 must be fully paid up before any of the grant is available, is insisted on. In this the Secretary of State has expressed his concurrence.

A resolution to give effect to the proposals described will be submitted at this meeting, and the Governor recommends it to the favourable consideration of Honourable Members.

Petition from W. S. Powell—(M.P. 2794 1905.) The acting Colonial Secretary presented a petition from William S. Powell, with respect to the case of Mrs. M. Browne, an inmate of the House of Refuge, and moved that it do lie on the table.

East Indian Immigrants—Questions by Mr. Rust. Mr. Rust asked :--

- "Referring to the Annual Report of Protector of Immigrants for 1904-5—Council Paper No. 55 of 1905, page 15—
- "Will the Government give a return showing from what cause or causes no less than 1,059,852 working days were lost during the year 1904 by 9,556 indentured immigrants, or an average of 111 days per head?
- "Also—Will the Government give a return in tabulated form for the past five years of the number of indentured immigrants sent to prison—the nature of their offences—and the total number of days they spent in prison?
- "Also—Will the Government give a return in tabulated form for the past five years of the number of indentured immigrants treated in hospitals (estates or otherwise) and the total number of days they were in hospital?
- "Also—Is it within the knowledge of the Government, that on certain estates, within the past five years, as many as 30 per cent. of the adult male indentured immigrants on those estates have not earned the minimum wages, as provided for in Clause 70 of Ordinance No. 161?"

The acting Colonial Secretary replied :-

- 1. "The figures quoted in question 1 are taken from Estate returns, which in many cases "are carelessly compiled and they cannot be taken as accurate, nor are the causes of "lost days often given unless the number lost is so large as to seem to require special "explanation. It is not possible, therefore, to say what number of days should be "attributed to each cause."
- "The principal causes of lost time are desertion, absence with or without leave, refusal to "work, idleness, undergoing sentence in jail, sickness or childbirth. It must be "remembered that female immigrants are exempt from obligation to work in the 4th "and 5th years of their indenture, but the days on which they do not work are "included in the totals quoted.
- 2. "The number of indentured immigrants sent to prison within the last 5 years has "been in-

- "A return could be furnished showing the nature of offences, and the number of days "imprisonment, but to prepare it for the whole of these 7,530 cases would entail an "immense amount of labour, and a considerable expense, as special clerks would "have to be employed. The books at the gaol from which the information would be "taken can be submitted to the Honourable Member's inspection, if he desires it.
- 3. "The number of cases treated in the principal Estate hospitals is shown yearly in the "report of the Surgeon-General but not the length of stay in hospital."
- "The remaining information could only be obtained from the books of the Estate hospi-"tals by consent of the Estate authorities.
- "The answer to question 4 is in the affirmative. The cause of failure to earn the mini"mum required by Section 70 of Ordinance 161 is in every case made the subject of
 "careful enquiry, in order to decide what action shall be taken under the provisions
 "of that section."

Mr. Rust thanked the Hon. Member for the information given, and expressed the hope that fuller particulars would be procurable by the Labour Committee at present sitting.

With the leave of the Council Mr. Goodwille asked :-

Duty on dried

"Whether having regard to the provisions of the deed of concession to the New York Mr. Goodwille. "and Trinidad Asphalt Company, dated 12th July 1888, whereby it is stipulated

"that the duties on Asphalt made payable under Ordinances of 1895, and No. 1 of

"1888, shall be neither increased, diminished or varied, and that no act of the "Legislative Council which shall vary the amount of such duties shall receive the

"Royal assent, the Government will state under what authority the duty on boiled "Asphalt, known as dried Asphalt, has been reduced from 7/6 per ton to 6/11 per

"ton, and the Royalty from 2/6 to 2/4 per ton."

The acting Colonial Secretary replied :-

"There has been no real alteration of the duty charged on dried asphalt since the introduction of that process, when it was decided that the only duty which could legally be charged was on the quantity of crude asphalt used in the process. In the course of ten years' experience it has been positively ascertained what quantity of crude asphalt is required to produce a ton of dried asphalt, and duty is charged accordingly.

The acting Colonial Secretary obtained the leave of the Council to amend the Resolution relating to Mr. Cunningham-Craig's pension and emoluments, which he moved as follows: -

"That this Council approves the proposal contained in the Secretary of State's despatch Government Geolo-No. 137 of the 5th June, 1905, (Council Paper No. 68 of 1905), that this Colony gist-Pension and should accept responsibility for the payment of the pension of Mr. E. H. Cunningham-Craig, Government Geologist, on his ultimate retirement, in respect of the whole period of his employment under this Government and of the payment to him from the 24th November next of salary at the rate of £750 instead of £700 per annum.

Seconded by the Auditor-General and agreed to.

The acting Attorney-General moved :-

"That this Council having considered the report of the Committee on Crown Lands Crown Lands Committee's Report—
(Council Paper No. 73 of 1905) recommends its conclusions for the favourable mittee's Report—
Debate on. consideration of the Government."

Seconded by Mr. C. de Verteuil.

At 2 o'clock, and while the debate was proceeding, the Council adjourned for lunch.

On resuming the acting Colonial Secretary moved the suspension of the Standing Orders Suspension of Standing Order 10. in order that two of the Resolutions on Agenda might be proceeded with.

Seconded by the acting Attorney-General and agreed to.

The Honourable Member then moved :-

"That the Resolution of the 6th February last, granting a subsidy to the Symington Fruit Industry—
West India Fruit Company is hereby rescinded, and that this Council approves of Subsidiary Company
a contract being entered into with the Subsidiary Company now being formed Royal Mail Steam under the auspices of the Royal Mail Steam Packet Company for the shipment of Packet Company. fruit from Trinidad to European ports on the condition that this Colony will grant a subsidy to the said Subsidiary Company in the form of an annual grant for a period of five years equal to five per cent. on the actual paid up capital of the Company; provided that such grant shall not be payable on any capital which may be raised in excess of £15,000."

Seconded by Mr. Goodwille and agreed to.

Mr. Fenwick recorded his dissent to the Resolution.

The acting Colonial Secretary moved, that this Council approves the payment of fees Asphalt Industry amounting to £106 10 0 to Mr. J. W. Gordon and Professor H. Louis for their services in con—Fees to Mr. Gordon and Professor Louis. nection with the draft Asphalt Industry Regulation Ordinance.

Seconded by the acting Attorney-General, and agreed to.

The debate on the Crown Lands Committee's Report was resumed, His Excellency calling Crown Lands Committee's Report upon Mr. Robertson to address the Council. Debate continued.

At 3.40 p.m. Mr. Alcazar moved the adjournment of the debate.

Seconded by the acting Attorney-General and agreed to.

His Excellency adjourned the Council to Monday the 14th August, at noon.

With reference to your letter of the 7th of this month, No. 28121/1905 marked "Pressing," and previous correspondence regarding the appointment of certain Postmasters in the West Indian Colonies as agents of the Postmaster-General for the despatch and receipt of Mails, I am directed to send to you herewith instruments signed by Lord Stanley appointing as his agents in this connexion the Postmaster-General of Trinidad, and the Postmasters of Antigua, Barbados, Dominica, Jamaica, Montserrat, St. Kitts-Nevis and the Virgin Islands.

These appointments have been made in general terms, Lord Stanley being advised that it is not necessary to make the appointments personal to the present Postmasters.

The officials concerned will no doubt now act as suggested in the letter from this office of the 26th of June last, and notify the local agents of any Companies whose steamers they propose to use of their powers in this respect, and of their intention to pay gratuities for the conveyance of letters, etc., at the authorised rates, namely: -

(1.) One farthing for each letter, post-card, or other article, when the sea service does not exceed 300 miles, and

(2.) One half-penny for each letter, post-card, or other article when the sea service exceeds 300 miles.

As already suggested in the letter from this Office referred to above, payment for the conveyance of parcels sent from the West Indies might conveniently be made at the rates paid by the Imperial Post Office under existing Treasury Authority for outward parcels, namely :-

For each parcel not exceeding 3 lbs, in weight 4d. 8d.

But in the event of any objection to accept parcels at these rates, such as the Royal Mail Steam Packet Company appear already to have raised at Trinidad, Mr. Lyttelton will no doubt bear in mind the opinion expressed in the 10th paragraph of the Post Office letter of the 26th of June last. No. 22299, to the effect that parcels might legally be placed on the same footing as letters, and that it would actually be within the powers of the Postmaster-General or his agents to require the carriage of parcels at the Ship Letter rate.

APPOINTMENT.

TO THE POSTMASTER-GENERAL OF TRINIDAD.

Whereas by the Post Office (Duties) Act, 1840, Section 36, it is enacted (among other things) that every master of a vessel outward bound shall receive on board his vessel every post letter bag tendered to him for conveyance, and having received the same shall deliver it on his arrival at the port or place of his destination without delay, and every master of a vessel inward bound shall cause all letters on board his vessel (except as in the said Act mentioned) to be collected and enclosed in some bag or other envelope, and to be sealed with his seal, and to be addressed to any of Her Majesty's Deputy Postmasters, that they may be in readiness to send on shore by his own boat or by the pilot boat, or by any other safe or convenient means, in order that the same may be delivered at the first regular post office which can be communicated with, and at the regular port or place where the vessel shall report, shall sign a declaration in the presence of the person authorised by the Postmaster-General at such port or place, who shall also sign the same, and the declaration shall be in the form or to the effect more particularly described in the said Act.

MAIN ROADS.

Regulations declaring certain Main Roads in the Montserrat Road Union.

Whereas by Section 4 of the Roads Ordinance No. 200 (Revised edition), it is enacted that it shall be lawful for the Governor to make Regulations for all or any of the purposes in such section mentioned and amongst such purposes (Sub-Section I) for declaring what Public Roads shall be Main Roads.

Now therefore, I, HENRY MOORE JACKSON, Governor and Commander-in-Chief in and over the Colony of Trinidad and Tobago, &c., in pursuance of the powers vested in me as aforesaid, and all other powers in that behalf enabling me, do hereby make the following Regulations:—

The following Public Local Roads, that is to say:-

- That portion of the Road know as the Mararaval Road, now under the charge of the Montserrat Local Road Board, measuring two and a half (2½) miles, starting from the 8¾ mile post of the Couva Main Road and running in a Southerly direction till it meets the Corosal Local Road;
- The Road known as the Corosal Road now under the charge of the Montserrat Local Road Board, starting at the $2\frac{1}{2}$ mile post of Mararaval Road and running in a Southerly direction for a distance of $1\frac{7}{8}$ miles till it meets the Morichal Road;
- That portion of the Road known as the Morichal Road, now under the charge of the Montserrat Local Road Board, starting at the 17 mile post of the Corosal Road and running in a Westerly direction for a distance of 11 miles till it meets the Mayo Main Road at the 64 mile post, be declared to be a Main Road within the meaning of the Roads Ordinance No. 200 (Revised Edition).
