WAR CONTRIBUTION TAX ORDINANCE, 1917.

Despatches to and from the Secretary of State in connection with the Colony's contribution towards the expenses of the War.

Council Paper No. 105 of 1917.

GOVERNMENT HOUSE, 26th March, 1917.

I have the honour to transmit herewith an Ordinance which was passed by the Legislative No. 1 of 1917. Council on the 9th instant, entitled "An Ordinance to provide for the grant by the Colony of a "contribution to His Majesty towards the expenses of the War," together with the report of the 22ad March, 1917.* Attorney-General thereon.

- 2. For some months past there has been a feeling among all classes of the community that having regard to its wealth and resources the Colony was not contributing adequately towards the cost of carrying on the war, and various proposals as to the form in which additional assistance should be given to the Imperial Government have been discussed in the public press.
- 3. In October last when your proposals for the local issue of short dated bonds was under discussion in the Executive Council, Mr. Alcazar, K.C., the Senior Unofficial Member of the Legislative Council, suggested that in the event of such an issue being made the Colonial Government should assist the Imperial Government by undertaking to pay the interest on the £500,000 of bonds which it was proposed to issue in Trinidad, amounting to £30,000 per annum. Mr. Aleazar laid his suggestion before the Unofficial Members of the Legislative Council by whom it was unanimously approved; but pending the receipt of further instructions from you as to the issue of the bonds no further action was taken in the matter.
- 4. In December last, a deputation of the leading merchants and others in the Colony waited upon me to express the wish that the Colony of Trinidad should make a direct contribution to the Imperial Government towards the cost of the war. To this end they suggested that additional taxation should be imposed, the proceeds of which should be earmarked for that specific purpose. Various proposals as to the particular form of tax to be imposed were made by the deputation, such as an additional export tax on sugar, increased import duties, and a poll tax. I expressed warm sympathy with the object in view, but deprecated these particular proposals, suggesting as an alternative a trade tax or license duty on every profession, trade or calling.
- 5. A Committee of taxpayers considered that suggestion which was also laid before the Income Tax Committee, which I strengthened by the addition of several members for the consideration of this question. Eventually it was decided to adopt the principle of a war contribution based on incomes, and this form of tax has been accepted by the Legislative Council and is embodied in the present Ordinance. The measure has been passed at the suggestion and with the full approval of the unofficial section of the community, and was supported unanimously by every member of the Legislature. It is thus another indication of the desire of all parts of the Empire to assist His Majes y's Government in prosecuting the war to a satisfactory conclusion.
- 6. While the bill was still under discussion by the Council, I received your telegram of the 1st March intimating that it had been decided to prohibit the importation of rum and cocoa into the United Kingdom. Although your subsequent telegrams of the 3rd and 8th March modified this prohibition with respect to cocoa it was felt that the restriction of the market of one of the staple products of the Colony might have a serious effect on prices. I therefore informed the Legislative Council, before the bill was actually passed, that I would refrain from bringing it into operation until an opportunity should have been afforded of gauging the effect of the restriction of the shipment of cocoa to the United Kingdom, and that before bringing the Ordinance into force I would consult the Council on the subject.
- 7. The effect on the market of the restriction of the exports to England is now becoming clear, and the apprehensions of the merchants that there would be difficulty in disposing of the cocoa at satisfactory prices have been removed; I accordingly propose to have brought before the Council at their next meeting a resolution to the effect that the Ordinance should be brought into operation without further delay.

The following are considered as Commercial papers, and allowed to pass as such at the reduced postage viz.:—all papers and documents whether writings or drawings, produced wholly or partly by hand not having the character of an actual and personal correspondence, such as open letters and postcards of ancient date which have already served their original purpose, papers of legal procedure, deeds of all kinds drawn up by public functionaries, waybills or bills of lading, invoices, receipts, the various documents of Insurance Companies, copies of extracts from acts under private signature, written on stamped or unstamped paper, musical scores or sheets of music in manuscript, the manuscript of works or of newspapers, forwarded separately, pupils' exercises in original or with corrections, but without any comment on the work and other papers of a similar description.

Commercial papers must be put up in such a manner that they can be easily withdrawn for examination.

It must be borne in mind that War Tax Stamps can only be used for prepayment of postage on local letters and to places within the British Empire, and they must on no account be used for prepayment of postage on letters addressed to Foreign Countries.

- 13. The royalty on Oil is also expected to give a satisfactory increase. The estimate of £7,220 for the current year will probably reach £11,285, and the favourable prospects of next wear have rendered it possible still further to increase the estimate for 1918 to £17,700.
- 14. It is evident that the tax upon produce will have to be continued to enable the Colony to meet its obligations in connection with the War, and in paragraph 3 of this minute you have been asked to consider the desirability of increasing the rates so as to afford additional revenue to the extent of some £12,000. In the meantime, however, the Estimate has been framed on the rates imposed by Ordinance No. 46 of 1916, and in view of possible shorter crops it has been necessary to reduce the estimated receipts by £2,366 below those of the current year. An estimate showing the receipts from the increased rates suggested has been prepared and will be submitted for your consideration: and in connection with this it is suggested that molasses should be added to the list of articles subject to the tax at a rate of half a penny the gallon, and that the rates on copra, cocoa, and hides should be revised.

EXPENDITURE.

- 15. The estimated expenditure of 1918 is £1,093,589. This is £56,572 more than the Estimate for the year 1917, but it is actually less by £34,276 than the revised Estimate for this year.
- 16. The Estimate has been framed with the greatest possible care, and all avoidable expenditure has been excised from it. When it was first framed a deficit of £62,500 was shown, but a careful revision has reduced this to the present figure of £4,847. The few increases to the cost of the Establishment that have been included, and to which your attention will be drawn, are necessary for the maintenance of the efficiency of the Service.
- 17. (Head 4.—Colonial Secretary.)—The salary of the Statistical Clerk and Librarian has been increased from £250-£300 to £250-£350. The former salary is inadequate for the responsible duties of the Office, and the Secretary of State has authorised the increase being submitted for your approval.
- 18. (Head 8.--Savings Bank.) Provision has been made for the establishment of a bank at Moruga.
- 19. (Head 9.—Crown Lands.)—The salary of the 2nd Assistant in the Survey Department has been increased by £50, and a 3rd Assistant has been provided with a salary of £250 £300 and a travelling allowance of £100. These increases are necessary to enable the pressing work of the completion of the triangular Survey to be carried out
- 20. (Head 10.—Forest Department.)—This has up to the present been worked as a branch of the Crown Lands Department, but its duties have grown to be of sufficient importance to warrant the change that is now being made of forming it into an independent department. The salary of the Conservator has been increased from £400-£600 to £500-£700, and it has been necessary to appoint a Messenger at £30 per annum. A sum of £50 has been provided under the head of "Other Charges" to enable the Department to carry out experiments as to the possibility of using to a greater extent than is the case at present local timber for building purposes.
- 21. (Head 11.—Customs.)—The Revenue Schooner "Ponemah" has been detailed for duty in connection with the Defence Scheme, and the cost of her upkeep is now provided under that head.
- 22. (Head 12.—Constabulary.)—The salary of the Staff Sergeant of the Port-of-Spain Fire Brigade has been increased from £120 to £140, which is the rate of pay of other officers of that rank.
- 23. (Head 15.—Post Office.)—Provision has been made for an Assistant Cashier at £150-£200 to enable proper arrangements to be made for the convenience of the public. Attention was drawn to the necessity for this by the Finance Committee in February last. Provision is also made for establishing a Money Order Office at Caroni, and for the opening of District Post Offices at Brasso-Piedra, Caparo, Flanagin Town, and Rio-Claro.
- 24. (Head 20.—Wardens.)—The votes for Sanitation hitherto taken under this head have been transferred to the head of "Public Health," so as to place the expenditure under better control and secure more uniformity in administration. The several votes for Water Supply have for similar reasons been transferred to the head of Public Works. Provision has been made for the appointment of qualified Sanitary Inspectors in the important Districts of Tacarigua and Savana Grande.
- 25. (Head 21.—Medical.)—Provision has been made for the appointment of two additional Supernumerary Medical Officers to bring the number up to the requirements of Ordinance No. 195. The vacancies in the Establishment have at times thrown a good deal of extra work on some of the Medical Officers, and at the present time it has been necessary to sanction an arrangement under which one of the Medical Officers in Tobago has to take charge of two Districts.
