# Regulations made by the Governor in Executive Council under the Post Office Ordinance, 1918.

## PARCEL POST TO GREAT BRITAIN AND NORTHERN IRELAND.

- 1. Regulation 306 of the Postal Regulations dated the 16th day of September, 1914, is hereby revoked and in lieu thereof shall be read the following:—
  - 306.—(1) The maximum weight for parcels sent for delivery in Great Britain and Northern Ireland is 22 lb.
    - (2) All parcels sent for delivery in Great Britain and Northern Ireland exceeding 11 lb. in weight shall, if required by His Majesty's Postmaster-General, be collected by the addressee from the normal office of delivery.
    - (3) The maximum weight for parcels sent to other countries through Great Britain and Northern Ireland is as detailed in the London Post Office Guide.
- 2. Regulation 4 of the Postal Regulations dated the 15th day of March, 1923, is hereby revoked and in lieu thereof shall be read the following:—
  - 4. The rates of postage on parcels to Great Britain and Northern Ireland shall be as follows:—
