E NACTED by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof.

1. This Ordinance may be cited as the Post Office short title. (Amendment) Ordinance, 1940, and shall be construed construction. as one with the Post Office Ordinance, 1938, hereinafter No. 23-1938. referred to as the Principal Ordinance.

Section 39 of the Principal Ordinance replaced. 2. Section 39 of the Principal Ordinance is hereby repealed and replaced by the following:—

Execution of instruments.

39. Any instrument purporting to be executed by or on behalf of the Postmaster-General for the United Kingdom shall, until the contrary is proved, be deemed to have been so executed without proof of the official character of the person appearing to have executed the same.

Section 57 of the Principal Ordinance amended.

- **3.** Section 57 of the Principal Ordinance is hereby amended by substituting for paragraph (a) of subsection (1) the following—
  - (a) make, knowingly utter, deal in, or sell any fictitious stamp, or knowingly use for the purpose of the Post Office any fictitious stamp; or

Section 59 of the Principal Ordinance replaced. **4.** Section 59 of the Principal Ordinance is hereby repealed and replaced by the following—

Penalty for wrongfully writing on or marks the cover or the contents of any postal packet in any manner contrary to the laws and regulations relating to the Post Office shall incur a fine of fifty dollars.

Section 71 of the Principal Ordinance amended. 5. Section 71 of the Principal Ordinance is hereby amended by substituting the word "without" for the word "within" in the last line of subsection (1).

## OBJECTS AND REASONS.

The main object of the Bill is to make certain slight modifications to Ordinance 23 of 1938.

Clause 2 replaces Section 39 of the Principal Ordinance and conforms with the existing English practice: instruments are now signed for and on behalf of the Postmaster-General and not as hitherto by a Secretary of the Imperial Post Office in the name of the Postmaster-General.

Clause 3 replaces and amplifies Section 57 (1) (a) of the Principal Ordinance by making it an offence for a person knowingly to use for the purpose of the Post Office any fictitious stamp.

Clause 4 re-enacts Section 59 of the Principal Ordinance omitting the first part thereof, which is already provided for in Section 55.

Clause 5 corrects an obvious error.

## NOTICE TO IMPORTERS.

# Quota—Imports of Foodstuffs from the United Kingdom.

In order to regulate and control by Quota imports of foodstuffs from the United Kingdom, importers are requested to submit to the Secretary, Board of Control, Old Post Office Buildings, St. Vincent Street, not later than the 31st March, 1940, a statement showing the amounts (quantity) of each of the duty paid goods imported by them from the United Kingdom, during the period—1st September, 1937, to 31st August, 1939, month by month.

The statement should be classified under the three main headings: Food, Drink, Tobacco, and the goods imported, classified under those headings mentioned in accordance with the return of imports published in the Report of the Customs and Excise Department, for the year 1938 (Council Paper 58 of 1939).

The necessary forms for furnishing the return called for may be obtained on application at the offices of the Board of Control.

Importers are requested to state the amount of their purchases in units in accordance with the Units of quantity shown in the Customs Import & Export List.

Merchants who obtain their goods locally from Distributing Agents, and who are desirous of having a quota allotted to them, should also render a statement of their purchases on the forms provided, but in such cases, an endorsement at the head of the form should be made to clearly indicate that the return relates to goods duty paid by Distributing Agents from whom they have obtained their goods.

Separate returns should be made for goods purchased locally as distinct from those imported direct.

It is requested that particular care should be taken in the preparation of the return which will form the basis on which quotas against monthly requirements of each importer will be allotted to the trade.

It will be assumed that importers who fail to render the return asked for above, do not wish to participate in the quota to be allotted to imports from the United Kingdom.

## COLONIAL SECRETARY'S OFFICE, 15th March, 1940.

The following rules relating to attendance and overtime in the Post Office and Savings Department have been approved by His Excellency the Governor in Executive Council and are published for general information:—

## RULES. -POST OFFICE AND SAVINGS BANK.

#### Attendance and Overtime.

1. The calculation of all attendance shall be on a weekly basis of:-

Thirty-nine hours per week for Clerical Staff, 48 hours per week for Letter Carriers, Mail Motor Drivers, Labourers, &c. Officers on through duties (6½ hours per day Clerical Staff) (or 8 hours per day for others) shall be entitled to half an hour's relief on the premises. Officers on other duties must "book off" for the meal hour; and other times off duty.

- 2. In a week in which a Public Holiday occurs the weekly hours of duty will be proportionately less. Similarly, when an officer is absent on leave or for other valid reasons for a portion of a week, the weekly hours of duty will also be proportionately less.
- 3. Attendance in excess of the weekly hours of duty and Sunday and Public Holiday duty, shall be regarded as overtime and paid for at the appropriate rates.
- 4. Subject to the observance of the weekly hours of duty, officers may if necessary in the interest of the work, be booked for a long duty on one day and a short duty on another.
- 5. The Postmaster-General may, in his discretion, disallow any claims for overtime attendance necessitated by the negligence, indolence or inaccurate work of the officer concerned, or when the circumstances of the case seem to him to justify the disallowance.
- 6. Overtime claims made out on the appropriate form must be authorised daily by the Controlling Officer, and must be submitted monthly. The period must end on the last Saturday of the month, any days following such Saturday in any particular month being included in the claim for the succeeding month; in other words, the claims should cover a number of complete weeks only.
- 7. The necessity for the overtime must be stated in the remarks column of all claims submitted,
- 8. Overtime shall not be payable to Controlling Officers (First Class Clerks or Officers of a superior grade). Nevertheless, all officers whatever their grade, may be required to perform extra duty when circumstances demand and they are called upon to do so by competent authority.

9. Overtime payments calculated on salary shall be made in accordance with the following tables:—

To be paid at the rate of time and a quarter in respect of an 8-hour day on Mondays to Saturdays inclusive up to 4 hours after the normal working time and at time and a half thereafter, and at time and a half on Sundays and Public Holidays.

#### POSTAL REGULATIONS.

## Regulations made by the Governor in Council under the Post Office Ordinance, 1938.

These Regulations may be cited as the Post Office (Amendment) short title-Regulations, 1940, and shall be read as one with the Post Office Regulations, 1938, hereinafter referred to as the Principal Regulations.

- 2. In lieu of paragraph 2 (11) of the Principal Regulations, the following paragraph shall be substituted—
  - (11) The expression "fictitious postage stamp" has the same meaning as assigned to the term "fictitious stamp" by section 57 (4) of the Ordinance.
- 3. The following paragraphs numbered (15) and (16) shall be added to regulation 2 of the Principal Regulations—
  - (15) The expression "the purpose of the Post Office" has the same meaning as in the Ordinance;
    - (16) The expression "the Ordinance" means the Post Office Ordinance, 1938;
- 4. Paragraph 4 (e) of the Principal Regulations is hereby revoked and the following shall be substituted therefor—
  - (e) correspondence, other than letters and single post cards which is unpaid or insufficiently pre-paid and reply paid post cards of which the two halves are not fully pre-paid at the time of posting shall not be forwarded by the Postmaster-General but may be returned to the sender if practicable.
- 5. The following paragraph numbered (5) shall be added to regulation 21 of the Principal Regulations—
  - (5) Every small packet shall bear on the outside the name and address of the sender and the addressee, and for Customs purposes shall bear such label and shall have attached or contain such declaration, if any, as shall be required by the Postmaster-General.
- 6. Paragraph 44 (a) of the Principal Regulations is hereby amended by inserting after the word "box" in the first line the following words "with suitable partitions".
- 7. Paragraph 44 (d) of the Principal Regulations is hereby amended by inserting after the words "soft fruit" in the second line the following words—"and the boxes must be securely tied with string crossing the lids in two directions".
- 8. Regulation 143 of the Principal Regulations is hereby amended by deleting the word "Austria" in the third line and inserting the word "Poland" before the word "Brazil" in the fourth line.

- 9. Regulation 148 of the Principal Regulations is hereby amended by adding at the end thereof the following—"provided there is no reason to doubt the ownership of the money order".
- 10. Regulation 158 of the Principal Regulations is hereby repealed and replaced by the following—

void orders. 158. Every inland or foreign money order issued by the Postmaster-General shall become void at the expiration of twelve months from the last day of the month of issue.

11. Regulation 160 of the Principal Regulations is hereby repealed and replaced by the following—

Expiration of 160. Every money order issued in another country and money orders payable in the Colony which has not been presented for issued abroad payment within twelve months of the last day of the month of issue shall be void.

- 12. Regulation 177 of the Principal Regulations is hereby amended by deleting the following words appearing in brackets in the said regulation—" (except in the case of an order payable in Canada)".
- 13. Notwithstanding the provisions of the Principal Regulations where the Postmaster-General is satisfied that the addressee of postal packets is dead he may in his discretion—
  - (a) deliver or re-direct such postal packets on the written application of any one or more of the Executors named in the Will of the addressee or of a person appearing to the Postmaster-General to be entitled to take out Letters of Administration to the Estate of the addressee; or
  - (b) deliver or re-direct such postal packets on the written application of any person appearing to the Postmaster-General to be conducting the affairs of the deceased addressee of the postal packets; or
  - (c) retain such postal packets for such period as he may think fit and on production of Probate of the Will or Letters of Administration to the Estate of the addressee together with the written application of one or more of the executors or administrators, deliver or re-direct the packets in accordance with such request.
