Conditions under which Letters may be sent to Relatives or Friends in Enemy Countries or Enemy occupied Territory.

The territories included in these arrangements are: Belgium, Bulgaria, Czechoslovakia, Danzig, Denmark, Estonia, Finland, Germany, Greece, (Mainland), Greek Islands and Crete, Holland, Hungary, Italy and Italian Possessions, Latvia, Lithuania, Luxembourg, Norway, Poland (German occupied), Roumania and Yugoslavia.

- 1. Communications must be clearly written or typed on one side of the paper only, on plain, unwatermarked stationery, and must not exceed two pages of normal size. Writer should not put more than one letter in the same envelope. Erasures and corrections or mutilated stationery and additions by other people are not permitted.
- 2. Letters and envelopes must omit the sender's address. They may be in English or in the language of the country for which they are intended, and must contain nothing but matters of personal interest.
- (a) No reference may be made to any town, village, locality, ship or journey, or to the Censorship or to any other phase of the war, or to Thos. Cook & Son, Ltd., or any of their offices, or to the means by which the letter is sent. No printed matter, map, plan, sketch, drawing, print, photograph, or other pictorial representation or postage or revenue stamp, may be enclosed.
- (b) Business letters and letters containing directions about property or money matters must not be sent to Thos. Cook & Son, Ltd., but should be submitted by the sender to the Trading with the Enemy Branch of the Treasury and Board of Trade. Kingsway, London, W.C.
- (c) In letters intended for transmission to enemy territory or occupied territory mention must not be made of the receipt of a letter or letters therefrom. If desired, the addressee may be informed that his (or her) news or message has been received, but the date of such message must not be given.
- 3. Each letter must be placed in an open unstamped envelope fully inscribed to the addressee who should be asked to address any reply to your full name, care of Post Box 506, Lisbon, Portugal, Poste Restante addresses are not accepted. The use of titles or Naval, Military or Air Force rank is forbidden. The Lisbon Post Box must not be mentioned on the envelope.
- 4. The open envelope containing the letter should be placed in an outer unstamped envelope addressed to Thos. Cook & Son, Ltd., Berkeley Street, Piccadilly, London, W.1. together with a memorandum plainly written, containing in block letters the name (Christian name first) and full address of the sender. A married woman should give her own as well as her husband's initials.
- 5. The open envelope addressed to Thos. Cook & Son, I.td., must be enclosed in a sealed envelope ADDRESSED to THE CHIEF CENSOR, TERMINAL CENSORSHIP, G.P.O. For an extra fee of 6d. each, letters can be sent by Air Mail between London and Lisbon. Envelopes must not be endorsed "Air Mail".

Defence Regulations made by the Governor under the authority of the Emergency Powers (Defence) Act, 1939, and the Emergency Powers (Colonial Defence) Order in Council, 1939.

- 1. These regulations may be cited as the Defence (Amendment No. 12) Regulations, 1942.
- 2. The Defence Regulations, 1939, are hereby amended by inserting a new regulation immediately after regulation 5 thereof as follows:—

Special provisions for "shipping information" means any information as to the censorship arrival, departure, movements, convoying, escorting, armaments or manning of shipping, or as to the expected bunkering of shipping, or as to the bunkering or expected bunkering of shipping, or as to the supply of ship's stores to shipping, or as to the supply or expected supply of expected to be carried in any ships, or as to assemblies or expected assemblies of ships in particular localities or as to casualties to ships or persons on board ships or as to weather conditions affecting shipping; and a telegram or postal packet shall be deemed to contain shipping information whether such information shall be stated expressly in or on, or shall be capable of being inferred even approximately from, such telegram or postal packet.

- (2) No person shall despatch by post from the Colony to a person outside the Colony—
 - (a) any postcard containing shipping information; or
 - (b) any other postal packet containing shipping information on the outside thereof.
- (3) Any person desiring to send from the Colony to a person outside the Colony a telegram containing shipping information shall keep the telegram in a closed envelope until it is submitted for censorship and shall submit the same for censorship to the Deputy Assistant Censor, British Routeing Office, United States Naval Headquarters, Wrightson Road, Port-of-Spain. No person shall open any envelope containing any such censored telegram until it is handed in for transmission.
- (4) No person shall despatch by post from the Colony to a person outside the Colony any postal packet containing shipping information unless he shall first have submitted the same duly stamped for censorship to the Deputy Assistant Censor, British Routeing Office, United States Naval Headquarters, Wrightson Road, Port-of-Spain. No person shall open any such postal packet which has been censored.

DISEASES OF ANIMALS ORDINANCE.

In exercise of the powers conferred upon the Governor by paragraph (33) of section 12 of the Diseases of Animals Ordinance, the following regulations are, with the advice of the Executive Council, hereby made:—

No article, product, or material, set out in the Schedule hereto, shall be imported into the Colony except with prior written permission granted by or on behalf of the Director of Agriculture; and any articles, products or materials in respect of which written permission shall not have been obtained as aforesaid shall be deemed to be prohibited goods for the purposes of the Customs Ordinance.
- 3. No article, product, or material, set out in the Schedule hereto shall be administered to any animal except by a Veterinary Surgeon registered under the Veterinary Surgeons (Registration) Ordinance.

SCHEDULE.

- Material commonly used, for the protective inoculation of animals against disease.
- Material commonly used for immunising animals against disease including any Vaccine, Bacterin and Anti Sera which is so commonly used.
- Biological products commonly used for diagnosing disease in animals.

In this Schedule the term "disease" has the meaning assigned to it by section 2 of the Diseases of Animals Ordinance.

MOST IMPORTANT.

GOVERNMENT NOTICE

On account of existing military demands upon air transportation facilities the United States Government has found it necessary to impose limitations on the transportation of air mail from the United States to countries outside the American Continent, the West Indies, and other islands in the Caribbean area.

Regulations are accordingly published below dealing with letters so stamped or marked that they would ordinarily be transmitted via the United States to destinations outside the American Continent, the West Indies, and other islands in the Caribbean area—transmission from the United States onwards being by air. The effect of the regulations will be that if the letter exceeds two ounces in weight or is not in the usual and ordinary form of a letter or in any other case where the efficient prosecution of the war so demands the Postmaster-General will be authorised to despatch the letter in a mail bag for transmission from the United States onwards by surface mail.

It should be noticed that the regulations do not affect the transmission of mail to a destination in the United States or the transmission of a letter otherwise than via the United States or the transmission of a letter via the United States for carriage onwards by surface mail.

Defence Regulations made by the Governor under the authority of the Emergency Powers (Defence) Act, 1939, and of the Emergency Powers (Colonial Defence) Order-in-Council, 1939.

- 1. These regulations may be cited as the Defence (Air Mail Letters) Regulations, 1942.
- 2. These regulations shall apply to all letters (other than the official mail of the Government or of the Government of the United States) which are—
 - (a) posted in the Colony, and
 - (b) addressed to a destination outside the American Continent, the West Indies, and the other islands of the Caribbean area, and
 - (c) are so mailed or stamped that they would in the ordinary course of events be transmitted to their destination via the United States of America—the transmission from the United States of America onwards being by air.
- 3. It shall be lawful for the Postmaster-General to despatch any letter to which these regulations apply in a mail bag for transmission from the United States onwards by surface mail if—
 - (a) it exceeds two ounces in weight, or
 - (b) it is not in the usual and ordinary form of a letter, or
 - (c) the despatch of the letter in the manner aforesaid is in the opinion of the Postmaster-General necessary or expedient for the efficient prosecution of the war.
