(1) In lieu of the several rates of postage on foreign parcels to be transmitted to (a) the United Kingdom, and (b) the Irish Free State, which are set out in the Second Schedule to the Principal Regulations, there shall be charged and paid, in the case of parcels to be transmitted to the United Kingdom, the following rates, viz.: 60c., \$1.20, \$1.44 and \$2.40 respectively, and in the case of parcels to be transmitted to the Irish Free State, the following rates, viz.: 84c., \$1.44 and \$1.68 respectively, and the said Schedule is hereby amended accordingly.
- (2) In lieu of the several rates of postage on foreign parcels addressed to foreign countries not enumerated in the Second Schedule to the Principal Regulations, which are authorised to be added to the rates shown in the London Postal Guide by the said Schedule, there shall be charged and paid the following rates, viz.: 40c., 88c., \$1.02 and \$1.80 respectively, and the said Schedule is hereby amended accordingly.
 - 4. These Regulations shall come into force on the 1st April, 1948.
