## EXEMPTION OF GOODS IMPORTED FROM THE UNITED KINGDOM AND COLONIES GROUP FROM IMPORT LICENCE

In exercise of the powers conferred on the Controller of Imports and Exports by virtue of the Emergency Laws (Miscellaneous Provisions) Order 1947 and pursuant to regulation 3 (1) of the Imports and Exports (Control) Regulations 1941, the list of exceptions to the exemption from Import Licence of goods from the United Kingdom published in the *Royal Gazette* of 30th September, 1948, Control of Imports and Exports Notice No. 155 of 1948 is hereby amended by the addition of the words "other than toilet soap" after the word soap in item 1 (iv) of the said list.

NOTE:—The above amendment has the effect of exempting from Import Licence the importation into the Colony from the United Kingdom and Colonies *toilet soap only*, which has been produced, manufactured or processed in the United Kingdom. Importation of *laundry soap and all other kinds of soap* other than toilet soap are still subject to *Import Licence*. In view of agreement in force for making the British West Indian area self-sufficient in oils and fats, no licences will be granted for the importation of laundry soap other than Soap flakes, Lifebuoy (Laundry) and Sunlight (Laundry).
