THE POST OFFICE (AMENDMENT No. 2) REGULATIONS, 1963

PARLIAMENT OF TRINIDAD AND TOBAGO

RESOLUTION

THE CUSTOMS ORDINANCE, CH. 32. No. 2

WHEREAS it is provided by section 5 of the Customs Ordinance that it shall be lawful for the Senate and House of Representatives from time to time by resolution to impose duties of customs upon goods which may be imported into Trinidad and Tobago and to revoke, reduce, increase or alter any such duties, and to provide for the importation of any goods without payment of customs duty thereon:

Be it resolved:

That the Table of Exemptions from Duty contained in the Second Schedule of the Schedules of Import and Export Duties and Exemptions from Duties of Customs dated 6th April, 1962, and annexed to the Customs (Import Duty) Order, 1962, be amended by the insertion immediately after item 23 thereof of the following new item:

"Zoological Society	23A	Animals imported by the Zoological Society of Trinidad and Tobago for the purpose of public exhibition."
