(Motor Vehicles and Road Traffic Ordinance, Ch. 16. No. 3, section 78 (1))

ORDER RELATING TO THE CONTROL OF TRAFFIC AT THE ARIMA-FIVE-DAY SANTA ROSA MEETING TO BE HELD AT O'MEARA PARK ON THE 28TH AND 31ST AUGUST, 4TH, 11TH AND 18TH SEPTEMBER, 1965.

- 1. Between the hours of 11.30 a.m. and 4 p.m., control will be enforced as follows:—
 - (a) All vehicular traffic entering the Race Ground from the Churchill-Roosevelt Highway shall do so by way of the western entrance.
 - (b) All vehicular traffic leaving the Race Ground shall do so by way of the north-eastern entrance.
 - (c) All vehicular traffic coming from the South along the O'Meara-Ferry Road shall enter the Race Ground by way of the north-eastern entrance.
 - (d) No vehicular traffic shall be permitted south-bound along the O'Meara-Ferry Road between the Churchill-Roosevelt Highway and the eastern entrance to the Race Ground.
- 2. Between the hours of 4 p.ni. and 7 p.m., control will be enforced as follows:
 - (a) All vehicular traffic leaving the Race Ground shall do so by way of the western entrance leading to the Churchill-Roosevelt Highway.
 - (b) All vehicular traffic entering the Race Ground shall do so by way of the O'Meara-Ferry Road.
 - (c) No vehicular traffic shall be permitted north-bound along the O'Meara-Ferry Road between the Churchill-Roosevelt Highway and the eastern entrance to the Race Ground,
- 3. Control shall be enforced on the O'Meara Road between the Churchill-Roosevelt Highway and the Arima Railway Station as follows:—
 - (a) From 11.30 a.m. to 2 p.m., all vehicular traffic shall proceed in a southerly direction.
 - (b) From 4 p.m. to 7 p.m., all vehicular traffic shall proceed in a northerly direction.
- 4. No parking will be permitted on the following roads between 11 a.m. and 7 p.m.:—
 - (a) O'Meara Road.
 - (b) O'Meara-Ferry Road, between the Churchill-Roosevelt Highway and a point 200 yards South of the eastern entrance to the Race Ground.
 - (c) On the Churchill-Roosevelt Highway or its verges between the western entrance to the Race Ground and the O'Meara-Ferry Road.
 - (d) On the roads leading to and from the Λrima Race Club Buildings.
- 5. Vehicles will be parked at the direction of the Police on duty at the various parking lots South of the Club Buildings.
