We mentioned in the last issue of the Journal that many of the numeral obliterator cancellations on early British West Indies stamps were becoming quite rare and valuable citing one, an A8\$ from Old Harbour, Antigua, that was quoted at 50 pounds by Stanley Gibbons, when used on 6d lilac of G.B. It occurs to us that if each of us would survey our collections and duplicates for these cancellations, and advise others in the Groups interested in that particular country, of their holdings we might benefit our fellow members who are looking for these items, and in turn, profit from some material they would be willing to exchange for them.

The Jamaica International Stamp Exhibition - July 14-21 1962.

E. F, Aguilar, Kingston, Jamaica, has given us the following early information about the forthcoming Jamaican International Stamp Exhibition:

"Jamaica will be having an International Stamp Exhibition from July 14 to 21, 1962, just one week before the Ninth Central American and Caribbean Olympic Games takes place. This Exhibition will be confined to the stamps of the BWI Islands which include Bermuda, Bahamas, British Honduras and British Guiana. This has been organized through the Institute of Jamaica with the backing of the Government.

The Exhibition will be staged on three floors at the Institute of Jamaica, and will have 500 -frames, for competitive display while 100 frames have been reserved for special collections.

The Groups for the Exhibition are as follows:

Group 1 **JAMAICA**

- a) Postage Stamps 1860 1935 (to the end of George V reign mint and used)
- b) Obliterator numbers.
- c) Pre-stamp covers
- d) First flight covers to and from Jamaica.
- e) Temporary Rubber Date marks.
- f) Postmarks, single ring; squared circle and double ring steel stamp

Group 2. Territories other than Jamaica.

- a) Antigua, St Kitts, Montserrat and the Virgin islands.
- b) Barbados
- c) Dominica and Grenada,
- d) St. Lucia and St. Vincent
- e) Trinidad and Trinidad and Tobago.
- f) St Christopher-Nevis, Barbuda, Leeward Islands, Tobago. g) Cayman and Turks and Caicos Islands.
- h) British Guiana and British Honduras.
- i) Bermuda and Bahamas.

Group 3 Postmarks, other than Jamaica.

- a) Postal history of any of the territories listed in Group 2, including pre-stamp covers and postmarks.
- b) First flight covers to and from any of the territories listed in Group 2.

Group 4. . George VI issues of Jamaica or any territories listed in Group 2.

Group 5 Approved collections for Junior collectors confined to Jamaica only.

Cost of the frames are 3Pounds, 10 shilling each (\$10.00), and an entry is 35 shillings - (5.00). Every precaution and care will be taken of all collections received, as they will be coming into Jamaica in bond. But all collections must be insured by the owners .

Anyone interested in getting more details may write to Mr. C. B. Lewis c/o The Institute of Jamaica, 14-16 East Street, Kingston; or E. F. Aquilar, P.O. Box 406 Kingston. Mr., Aquilar is presently in England, and is making arrangements for the collections of Her Majesty the Queen, plus the de la Rues and Bradbury Wilkinson's, which will, occupy the special frames at the Institute. This will be one of the 'outstanding B.W.I. Exhibitions and (Dee Volenti), your Editor expects to be on hand for it.

Your Editor would like to throw this out as a suggestion: Wouldn't it be wonderful if the WIFSG could hold it's second annual meeting in Kingston, concurrently with the Exhibition!

A Listing Of All Known "Judicial" Overprinted Stamps. Of Jamaica

Clinton von Pohle submits the following taken from four listings, of all of the known JUDICIAL overprints: Scott's Nos. 21, 23, .28, 29, 30, 44, 45, 47, 53, 54, 56, 67, 68, 70, King Edward 3d King George VI 6d, 1/-, 2/-, 4/-, 5/-, 8/6, 10/-, Queen Elizabeth II 6d, 1/-, 2/-, 4/-, 5/-, 6 /6, 8/6 10/-, 20/-. If anyone knows of any other thus overprinted, let us hear from you.

Mr. G. J. Raymond has requested that the Group be queried as to whether modern manuscript postal cancels are known in Jamaica. Does anyone know? The only ones we have seen are the A-36 numeral obliterator cancellations on Scott's 1, 2, 4 and 5, which, of course, cannot be called modern. Mr. Raymond further states that in British Honduras, just last year, mail for some time, from GUINEA GRASS sub p.o. was normally cancelled by writing the village name and date in ball-point pen, across the stamp, circumstances not known. Also, in the Bahamas, due to a temporary lack of any date stamp, letters were normally cancelled in ink across the stamps, at various times in the past 8 months at PIRATE'S WELL, (Mayaguana Island) and PORT HOWE, (Cat Island). At the latter village a whole message appeared in ink across a single stamp! 'Date Stamp cut of order, G.T.S., P.M.". A few years previously, Lower Deadman's Cay had to cancel mail in a similar fashion, pending receipt of a new datestamp. Does any member know of any other offices pursuing this course in the absence of a date stamp?

Mr. Raymond also would like to know whether any member possesses a cover, or on-piece of the post WWII small circular Temporary Rubber Date Stamp of GRAND TURK.

We hope that this meets with the full approval of all concerned, and feel that nothing but good can come from such a merger. Mr. Raymond has also supplied us with the information that BRITISH HONDURAS has recently published a new 1960 POST OFFICE GUIDE, obtainable at 60¢ U.S.A. plus 15c postage, from the General Post office at Belize, British Honduras.

Gail Raymond has sent in the following, representing the contents of his Bahamas Newsletter:

"Some 2½ years later we now learn that the Bahamas P.O. no longer exists at remote, tiny WALKERS CAY. The northern most of the Bahamas Islands, it has supported a small crawfish industry, but is more well known for the famous WALKER CAY CLUB, fishing resort. A Bahamas P.O. opened here on 10 March 1953, with Mr. Ellis I Boyd, (Collector of Revenue), serving as postmaster. It utilized a large 23 mm double-ring Temporary Rubber Datestamp, usually poorly struck in red ink. It was used quite rarely, as most mail arrived and departed with the frequent airflights to West Palm Beach, Florida, with U.S.A. stamps on outgoing mail. When the two enterprises closed the Collector of Revenue was no longer needed and departed on 31 Dec. 1958, thereby quietly closing the P.O. The Club has since reopened, but the P.O. is not expected to re-open. During WWII the U. S. Navy had a small rescue unit on the island, with the P.O. designated as NAVY 513, using only a stock U. S. Navy datestamp. Covers are identifiable only by the Navy 513 return address. Covers from either P.O. are rare. New Steel Datestamps are now in use at FORT HOWE, HIGH ROCK, FORBES HILL, KNOWLES, CHESTER, LONG CAY, LANDRAIL POINT, NORTH PALMETTO POINT, SOUTH PALMETTO POINT, WEMYSS BIGHT, BANDY POINT, SIMMS, BURNT GROUND, ROLLEVILLE, SMITH POINT, CHEROKEE SOUND, JAMES CISTERN AND INDUSTRIOUS HILL. An old "ROSES" steel die (star over date), is being used again.

More On The Birmingham Markings

Fred Seifert has written the following concerning the Birmingham cancellations, and feeling that it is of interest to the entire group, am, reprinting his letter, in parts '? All of my Duncans are Type B-3. ' Have never seen B-1. I have the following to add to Clint's list: Half-Way-Tree B1, MOB Kingston Paid B1, Parcels Office Kingston B1,Rowlandsfield B1, Whitehall B1,

In the nitpicking department: Dee Side appears as two words, although on earlier types it was one word; Kings Vale is two words; Savanna La Mar.is spelled out in full; Carisbrooke with one r; Dumfries not Dunfries; Epworth with one p. Reference dates of issue, the following may help. I have a sheet of 36 proofs strikes of B-1 types in purple. Attached to the sheet is a small printed form "With the Compliments of the Postmaster for Jamaica" and in manuscript "These are new stamps just received (some initials I can't decipher) 6/12/46". The marks .are as follows -- as they appear on the sheet: Birds Hill, Parcels Office Kingston, Benbow, Haddington, Burnt Savannah, Kingston. Jamaica Registered, Grove Town, Silver Spring, Jacks River, Mandeville, T..P.O. Jamaica, Morgan's Pass, Whitehall, Irish Town, Perth Town, Dias, M.O.B. Kingston, Paid, Dumfries, Carmel, Parcels Office Kingston, Freeman's Hall, Clover Hill Rowlandsfield, Salt Spring, Kingston, Jamaica Registered, Falmouth Kingston, Haining, Strathbogie, Brandon Hill, T.P.O. Jamaica; Muirhouse, Darley, Newton, Braeton. Dates on the strikes are 6, 9, or 26 Jy 46. However, a note on the sheet says "The dates are just samples and not the true dates of issue, G.C.G." (Probably Geoffrey C. Gunter. It looks like his handwriting). Where there is duplication in the above list there was mote than one stamp. This is evidenced by differences in the letter spacing and in-the lengths of the bars at the sides.

I have another proof sheet with 8 Type B-1 strikes also in purple as follows: Jeffrey. Town; Portland Cottage, Lacovia, Treasure Beach; Half-Way-Tree, Top Hill, Haddo and Maggotty, All are dated 4 Au 44. While, this was probably not the issue date, it gives a general idea of the time of issue.
