INAUGURATION OF A NEW POSTAL AUCTION.

· * * *

A majority of the Board of Trustees has approved of the idea of our first Mail Auction. We are printing hereunder the Rules and Regulations to be observed for the auctions. If anyone seeks a change in these rules, or if experience so dictates, please write our President, so that they may be adjusted before the second sale. We will attempt to run two sales a year.

All commissions received and all payments to vendors will be handled through the office of the treasurer, and all funds will become the property of the BCPSG. The only charges to be made against the commissions received will be postal charges and mailing costs. Complete records of all lots and all bids will be maintained for six months after the date of the sale. Prices realized will be will be included in the Journal following the sale.

VENDORS.

1. Only members of the B.C.P.S.G. or their beirs, may offer material for sale through this auction. All members are solicited to offer any surplus, or duplicate material that they may wish to dispose of, through this sale.

2. Any material to be offered should be fully insured and mailed to: B.C.P.S.G., % Robert Topaz, 34 Maryellen Toad, Waban, Mass., U.S.A. 02160. All material should be sent prepaid. All material will remain the property of the owner, until payment is received by the BCPSG when sold, and insurance should be maintained by the vendor until the sale is consummated.

3. No material may be withdrawn from sale, after the final listing is made, except that a vendor may buy back his material as set forth below.

4. No reserve or minimum bids will be accepted, but vendors wishing to protect their material may bid on their own material. A commission fee of 5% willbe charged Vendors buying back their own material, rather than the 10% commission that will be charged normally to vendors.

5. Lots should be a minimum value of not less than \$5.00 U.S. or E 1./15/0 Sterling, gtg. and a brief description of the lot offered would be appreciated. The BCPSG reserves the right to split or join lots, or to describe them in the manner deemed best by the BCPSG, and undertakes to carry out the Vendors instructions to the best of their ability. However, no responsibility will be assumed by the BCPSG or it's agents for errors of commission or omission, in carrying out these instructions or in describing the material offered for sale.

6. A fee of 10% will be charged to the vendor on all sales except those described in paragraph #4, and in the case of heirs of members who are disposing of members material.

7. All material to be offered in the first sale must be received in Waban, Mass, U.S.A. no later than Fwb. 1, 1967. We will attempt to have the sale listed in the March Journal of the BCPSG, and the date of the sale will be April 10, 1967.

BUYERS.

1. Only members of the BCPSG may bid in material in these sales. Members bidding will be responsible for all purchases, regardless for whom they may be bid.

2. All lots are described to the best of our ability, and are genuine to the best of our knowledge (unless described otherwisr). No responsibility will be taken by the BCPSG because of incorrect description. Any claims or returns because of incorrect description must be made in writing not later than five days after receipt of the material. Lots containing more than five items are not returnable, unless grossly misdescribed.

In case of a question about the genuineness of an item, notice must be made within the prescribed five day period, and an appropriate time will be granted to obtain verification. In all such cases, the burden of proof will rest on the buyer. 3. All lots will be sold to the highest bidder at the minimum price possible. The customary 10% raise over the second highest bidder will be used to determine the selling price, except that the bidder shall not be sole an item at a higher price than he had bid. No. "BUY" bids will be accepted. In case of two identical high bids on any item, the earliest postmarked bid shall buy the lot at the amount bid. All bids shall be held confidential The BCPSG may reject any bid not deemed appropriate.

4. All lots will be sent to the Buyer by Registered Mail or insured mail, uhless bulk prohibits the practice, and the buyer will be held responsible for all mailing and insurance costs. All lots must be paid for within three days of receipt of the bill in U.S., Canadian, or Sterling funds, adjusted for exchange. Payment will in no way prejudice any claims that may be made pursuant to paragraph #2 above. 5. There are currently no arrangements possible for viewing of lots, but interested members may write for amplification of description on any lots that they may like, and an attempt will be made to supply this, to the best of our ability. 6. All bids must be postmarked not later than March 31, 1967, and should be dispatched by airmail from distant points. No bid will be accepted which is postmarked later than this date.

BAHAMAS NEWS AND NOTES.

These Notes show slim pickings this season. No news is yet in regarding the new P.O. at Earnest Street, replacing the Mackey Street one, nor of the pending new P.O.'s on Grand Bahama. I'm deeply indebted to Donaly A MacAllister, acting PM of the SAN ANDROS p.o. on Andros Island, for a fine color photo of the opening ceremony on May 25, 1966. At least on Oct. 21, the TRD was still in use. Speaking of post-office photos, I'll be glad to send a photo of the"old"(closed), PINE RIDGE, Grand Bahama p.o. for 10¢ in mint U.S. stamps plus a stamped, self-addressed envelope. These are copies from the negative made from Johnny Gavalek's unique photograph.

The Bahamas specialists have really been rambling! Morris Ludington, after a summer in Greece, has recently spent several weeks in Bermuda researching the old records, and Bill McFarlan is just home from a fabulous trip around the Caribbean aboard the M/S "Sagafjord".

Highly recommended: the new National Geographic book, "ISLES OF THE CARIBEES", by Carleton Mitchell, with surely some of the finest West Indies photography ever published! The Leewards, Windwards, island by island, in great detail. A recent acquition is an 1840 stampless, folded letter to Methodist headquarters in London, from a missionary in the Bahamas. Headed from Rock Sound, Eleuthera, January 16, 1840, 1t describes his travels around the island to the various villages and churches minutely. Postal rate was 1 shilling (for one folded sheet), with red London backstamp of 13 JU 1840. and has the straight line "BAHAMAS" marking. The possibility exists that this straight-line marking was applied at the old CROOKED ISLAND p.o., where so much Bahamas mail was transferred to packets en route to Europe.

The long-awaited handbook on Bahamas postal markings is now nearing reality, with a publisher ready and waiting for the copy while we draft it page by page. Patience, gentlemen.

For the record, we still urgently need reports of stamps, places and covers of British stamps used-abroad in the Bahamas. De we have a report of your examples? Too, reports are also needed of any COVERS or dated pieces bearing a large "B" killer in violet ink, circa 1940.

Regarding Eddie Adelson's query last issue on PINE RIDGE TRD early dates, we can affirm dates in 1946 and one reported in 1945. Although PINE RIDGE Lumber Camp officially opened in January 1947, apparently the p.o. opened earlier for the construction crews. Can other members confirm the 1945 date?

Best wishes to all for a Very Happy New Year, may this be a year brim full of new discoveries in our joyous paper-chase.

AIR LETTERS (AEROGRAMMES) OF TRINIDAD AND TOBAGO. By Rene M. Leotaud and Harold E. Box. Reprinted from the Trinidad Philatelic Society Bulletin.

Air Letters or Aerogrammes as they came to be called, were first introduced in Great Britain in 1942 for use by the Forces, and later were adopted throughout the world. According to E. Bulger ("Air Letters of the British West Indies", B.W.I. Philatelist Vol. 4, No. 1, Sept 1952, page 11, "The light-weight Air Letter Service from Great Britain to civilian addresses in the B.W.I. started on 11Sept. 1944, but the return services are dated from different dates". In Trinidad, the Postmaster-General's Report for 1944 states: "A 12-cent light-weight air-letter service to all parts of the Empire commenced on 5th October 1944".

The first of these special air letter forms for use in Trinidad and Tobago were printed in England and sold at post offices in the Colony, the stamps to be affixed on them by the sender before despatch. These were the well known Apsley Air Letters, printed in blue on grayish paper, with space for the postage stamp indicated by a vertical dotted-line rectangle, 27 x 24 mm, in the right hand top corner. Front inscribed (Top left hand corner): "BY AIR MAIL" (White san-serif Caps. In blue rectangle, 31 x 24 mm: "AIR LETTER" (uprignt Caps)/IF ANYTHING IS ENCLOSED/THIS LETTER WILL BE SENT/BY ORDINARY MAIL". Reverse sidewith: "Senders name and address" and "The APSLEY AIR LETTER"/Form approved by Postmaster General No. -71995/1D".

E Bulger states (on p. 14 of the same article): "The First of the (Apsley Air Letter) forms I have is one used from Port of Spain, Trinidad, with 7 cents in adhesive stamps postmarked 13 JY 48".

There was another plain air-letter form sold in Trinidad before the stamped ones were issued. This was printed (? locally) in blue or rather coarse off-white paper.

. . . .

Space for the stamp indicated by a horizontal solid line rectangle 33 x 25 mm, containing the words: "AFFIX/12c/FOSTAGE", Scrifed caps. Front inscribed "EY AIR MAIL, (uiderlined)/IF ANYTHING...etc. Scrifed Caps) Reverseside with "Senders Name" and Address:-" only.

In the descriptions below, the "First fold here", "second fold here " and "To open cuthere", are omitted, as, with minor varieties, they are common to all issues. "Revorse" means the opposite side to the front when the Air Letter is folded twice ready to be sealed.

THE AIR LETTERS ISSUED WITH LITHOGRAPHED FACSIMILES OF STANPS, AND SOLD AT ALL POST OFFICES AT THE FACE VALUE OF THE STAMPS:-

(1) Fub. 1, 1950. Similar to the Apsloy Air Letter described above. Printed in blue on grayish paper, but with "imperforate" KG VI 12c stamp (SG Type 14, "Town Hall, San Fernando") Min dull purple on a light colored rectangle 42 x 29 mm., and without the "The APSLEY AIR LETTER"...etc.

(2) 15 Apr. 1952. Printed in blue on pale grayish-blue paper with "imperforate" KG VI 5c. (SG Type 41, "G.P.O. and Treasury") in green without surrounding rectangle. Front with "BY AIR MAIL (pale blue in dark blue rectangle as in (1), above, "AIR/ LETTER" (Slanting caps.)? "If anything is en-/closed this letter/ will be sent by/ordinary mail." Reverse with "Senders name and address-", only

(3) ? 1953. Printed in blue on pathegreyish-blue paper, with "imperforate" QE II
12c (SG Type Ψ_i, Town Hall, San Fornando) in dull purple. Front and reverse as in
(2) above.

(4) ? 1953. Printed in black on dark blue paper (white insmide), with "perforate" QE II 12c. (SG Type 44) in natural colors (black and purple on white). Front with "EY AIR MAIL" (blue in black rectangle 31 x 6/5 mm) /AEROGRAMME (ubderlined)/ AIR LETTER" slanting caps). Reverse with "Sonder's name and address", and "IF ANYTHING IS ENCLOSED THIS LETTER/MAY BE SENT BY ORDINARY MAIL."

(5) 1 March 1960. Printed in blue on bright blue paper with "perforated" QE II 6¢. (SG Type 42, "Discovery of Lake Asphalt") in natural colors (light brown and blue on white) Front as in (4), above in blue rectangle. Reverse with "Sender's name and address:" and "AN AIR LETTER SHOULD NOT CONTAIN ANY/ENCLOSURE: IF IT DOES IT WILL BE SURCHARGED/OR SENT BY ORDINARY MAIL."

(6) March 1960. Similar to (5) but printed in black on bright blue paper, with perforated QE II 15¢ black and bright yellow on white, in the design of the 12¢ (SG Type 44, "Town Hall, San Fernando)

(7) Sept. 1960. Printed in dark brown on pale blue paper (both sides), with "imperforate" QE II 6ϕ .(SG Type 54, "Treasury Building") in reddish brown. Front and reverse as in (5), above.

(8) Sept. 1960 Printed in vermillion on pale blue paper (both sides), with "imperforate" QE II 15¢. (SG Type 58, "CREST") in pale vermilion. Front and reverse as in (5) above.

(9) Sept 1964. Same as above (8), but the stamp is QE II 15ϕ . (SG Type 58a, "Coat of Arms").

NOTE: The original rate for an Air Letter from Trinidad and Tobago was 12ϕ to all parts of the British Wmpire A notice issued by the Postmaster General, G.P.O., Trinidad dated 12 May 1947, gives revised rates (effective on 1st June 1947) for Air Mail Services:- 5¢ for "Air Forms" to Antigua, Barbados, British Guiana, Dominica, Grenada, Jamaica, Montserrat, St. Kitts, St. Lucia, St. Vincent; and 12ϕ to all other British Dominions and Collednes. In 1952 the 12ϕ rate was made available for foreign countries throughout the world. These rates were raised to 6ϕ and 15ϕ , respectively in 1960.
