

## WORLD WAR I TRINIDAD P.O.W. MAIL

It was about five years ago that I first learned of the existence of a Prisoner of War Camp on Trinidad during World War I. This information came in the form of a paragraph in the December 1964, Bulletin No.43 of the B.W.I. Study Circle. At the Autumn Meeting of the Circle, Mr. J.B. Marriott displayed some pages which "showed examples of the 'Military Camp, Trinidad, B.W.I.' double ringed circular handstamp in violet." The first item was described as an Edward VII 1d post card of 26 JAN 1915, addressed to the Bureau Internationale de la Paix, Berne, Switzerland, to be forwarded onward to Germany. The second item, a Prisoners of War envelope, dated 1 APR 1916, bore the same mark, and in addition the "only example recorded" of the double ringed "Post Free, P.C., Prisoners of War" circular handstamp.



My knowledge of the P.O.W. facility from which these items came was furthered when Charles L. Maynard wrote a lengthy article on the subject which appeared in the 15 AUG 1967 issue of Western Stamp Collector. He reported a P.O.W. cover similar to that of Marriott, but used some seven months earlier on 7 SEP 1915. However, more important are details of the P.O.W. Camp which Maynard extracted from files of the Port of Spain Gazette covering the WW I period. He was living in Trinidad at the time he prepared the article, and by an excellent bit of research at the Reference Library, managed to piece together a reasonably complete story.

The Camp was located at St. James on the western outskirts of Port of Spain. The building in which the prisoners were confined had originally been the Hospital for troops at St. James Barracks, but at sometime prior to establishment of the P.O.W. Camp it had become the Female Prison. On about 12 AUG 1914 the Camp was activated after the female prisoners had been transferred to the Royal Gaol.

Internees consisted mainly of seamen and a few passengers removed from ships which called at Trinidad for coal or oil. The total number incarcerated appears to have been about 102. The Camp operated until about 17 JAN 1920, by which time the last of the prisoners had been released.

Last year while going over an auction list I found a cover described that appeared to be from this Camp. A successful bid brought me the cover shown on the previous page. It is similar to those reported by Marriott and Maynard, but the date makes it the earliest use of the "P.C." mark. The postmark date is incomplete and shows only the first digit of the day of month, but the original letter is still inside, and it bears the date 29 MAY 1915. Thus the postmark is either 30 or 31 MAY 1915. The letter is written in perfect English, and requests that the addressee send the writer six one pound glass jars of Prince Albert tobacco, saying that a brother of a fellow internee living in New York will provide payment.

Shortly after purchasing this cover, I wrote Charles Maynard about it. He replied telling me that after publication of his article several other collectors had sent him similar covers to examine. From the additional data collected, he feels about ten covers are now known. On at least one of the covers, the handstamp that reads "Military Camp" has been replaced by one of a generally similar design, but having "Prisoners of War" at the top and "Trinidad, B.W.I." at the bottom, while initials in manuscript of the censor appear in the center. The cover is dated 13 SEP 1916.

This is a subject that I would like to pursue further. Can any member report more covers or furnish further information? The post card and four covers mentioned in this article were mailed during the first two years of the Camp's operation. What is known of the three subsequent years? Did entry of the U.S. in the War in 1917 close the channels of correspondence for the prisoners? Charles Maynard plans to write a follow-up article for Western Stamp Collector. Perhaps he will provide us with some of the answers.

## TRINIDAD USED ABROAD

To BWI collectors the term "Used Abroad" brings visions of stamps of Great Britain franking covers from the Islands just prior to the time they started issuing their own stamps in the early 1860's. Until recently, relatively few philatelists knew that Trinidad adhesives were accepted for postage at Ciudad Bolivar, Venezuela for some six years from at least the latter part of 1869 until 1876. Since the covers that show this use are few, and would generally be listed under Venezuela whenever offered at auction, it has taken a dedicated student of Trinidad Postal History to research the story of this rare use of Trinidad stamps. The article which follows was published in the May-June 1970 Bulletin of the Trinidad Philatelic Society and the June 1970 Bulletin of the B.W.I. Study Circle at about the same time. Many of our readers will have read it in one or the other publication, but to be sure that no one misses it, we reprint it here at the suggestion of Harold Box.

#### TRINIDAD STAMPS USED AT CIUDAD BOLIVAR, VENEZUELA

Various Trinidad stamps are known cancelled with the D22 killer at Ciudad Bolivar, Venezuela. The following have been recorded:

The above are all franked with a single wmk. Crown CC, perf.  $12\frac{1}{2}$  (ld.), except for No. 4, which is franked with a pair. No's. 2, 3, 4, 5, and 6 show a single-line SHIP-LETTER in red; No's. 3, 4, 5, 6 and 7 have a manuscript "2" in blue; No. 1 is marked "4d" in manuscript and is backstamped ST. THOMAS, SP 14 69.

#### FURTHER DATA ON NEW BAHAMAS STRAIGHT-LINE MARKS----

In the article by John Ayre on Bahamas Straight-line Marks in the August BCPJ there were two illustrations which John identified as Type Bl (bottom of page 108) and B2 (top of page 109). After further study of these marks, John decided he wasn't sure that they actually were these types, and he asked Morris Ludington for an opinion.

Morris agrees with the identification of Bl. However, he comments on the other one as follows: ".... it is not exactly like the regular B2. The measurement B to S is 21mm, exactly, on his mark, but is 22.5mm, exactly, on my two strikes of B2. In addition, the "B" and the "H" are fractionally narrower in his mark. This is even in particular, the "H" on my B2's has the appearance of visible to the naked eye. being quite square, whereas on his it is a vertical rectangle. The height of the My earlier example, dated inside 9 MAR lettering on all three is identical, 3mm. 1836, has a weak "S", and if there was a period or full stop after it, this is not visible. My other, on a letter of 29 DEC 1839, has a period and a spot of ink just The "AS" is slightly askew, and this made me opposite the right top of the "S". suspect it was made from loose type. John's mark was definitely made up from loose type, but I feel the narrower "B" and "H" and the difference of 1.5mm in the length are enough to prove that it was a different handstamp."

"I think I shall call this Type B2, Handstamp II, as the differences are too slight to give it its own number, even an "a" or "b" number, which in any case I am having to use for the 2-line and the shorter large BAHAMAS straight-line marks."

## A Few Days on the Emerald Island

During the latter part of May, I had to be in Southern Florida on business. What better time would there be for me to continue on to the Eastern Caribbean to spend a few relaxing days and nights on Montserrat. I had previously visited there in 1967, and was enthralled by that lush green friendly island. While I collect all British Caribbean Islands, my two main interests are Antigua and Montserrat.

My Pan American flight left Miami at 4:45 P.M., and after a brief stop in San Juan arrived in Antigua some five hours later. One must stay overnight in Antigua and fly on to Montserrat the next morning. The Sugar Mill Hotel is very close to the entrance to Coolidge Field. It is comfortable and contains a very quaint bar in an old sugar mill tower where one refreshes (in my case with Heineken's Beer!).

I had also visited Antigua in 1967, and at that time did not consider that Associated State a particularly happy place. At the time of this latest visit, the Post Office was on strike, but this did not affect any of my plans as there was insufficient time for philatelic endeavors on Antigua.

I flew to Montserrat in a LIAT Otter early the next morning. As Montserrat is very mountainous it was visible from quite some distance. We landed at Blackburne Field in a heavy rain, to discover a new Airport Terminal Building was in use. It is quite an impressive structure for an island that has on it but some 14,000 souls.

Formalities at Customs and Immigration did not take more than a few moments, and soon I was on my way to my hotel, the Wade Inn, in the heart of Plymouth.

The road seemed improved since my previous visit, but could still provide a thrill or two. On the way to Plymouth I noticed several new schools, and my taxi driver informed me that they were built by the Canadian Government.

The Wade Inn is a small friendly hotel, offering good services, fine food and cold beer and a rate of only \$12 per day M.A.P. It also has the advantage of being but a few blocks from the G.P.O. where I would spend considerable time. Our President Stan reported and photographed the Country Post Offices, so I did not plan to make visits to any of them. The roads are narrow, winding and contain pot holes; since I have never driven on the left, I felt it best that no driving be done by me!

The business hours at the G.P.O. are from 8 to 3. Patronage was brisk throughout each day during my entire stay. The people of Montserrat are quite literate, and most of them have relatives in the other islands. I noted a goodly number of parcels being sent by air, for which the rates called for use of both \$2.50 and \$5.00 value adhesives. All of the current definitives were available except the 8¢, 42¢ and 60¢, and the old values which have the surcharged rates. The recent Red Cross set of four values were the only commemoratives on sale. One of the windows could supply FDC's of several of the older commemorative sets. The young lady behind it

was most helpful and seemed to be quite knowledgable about philatelic items (those at the other windows were not).

The machine canceler was grinding away but with the date stamp upside down. There was a new CDS being utilized that has the letter "D" above the date rather than an asterisk. While quite similar to the CDS with asterisk, which was also being used to cancel mail, this new mark has some small differences that make it possible for one to distinguish it from others of its type, even without depending on the index letter. The letters are slightly smaller in height, the letters G.P.O. are a bit more closely spaced, and the letters "L" and "U" in PLYMOUTH are well formed while they are somewhat deformed in the asterisk version. President Stan had reported a number of new handstamps were on order at the time of his visit, and this could be one of them.

The old mail van which Stan pictured in his article has been replaced with another of similar manufacture. As far as I could determine, the distribution of mail is still exactly as reported by Stan.

Montserrat is usually naturally air conditioned, but during my visit they had some extremely hot and humid weather. This required me to spend numerous hours at the bar in my hotel, enjoying both the liquid refreshments and conversing with some of the local people. During my visit, I met a number of interesting folks both from Montserrat and other islands of the British Caribbean. All were very pleasant and seemed very interested in the purpose of my visit to Montserrat. One of the local merchants remembered meeting and talking with Manfred Lehmann, who distributes the stamps of Montserrat in the Western Hemisphere, when he visited the island. While most countries which entrust their philatelic distribution to him have embarked on wild programs with new issues at the slightest excuse, Montserrat has maintained a fairly conservative stamp issuing policy. Perhaps this is due to the fact that it continues some of its ties with the Crown Agents and accepts their good advice.

During the course of my two visits, I was able to cover all the scenes depicted on the George VI and earlier Elizabeth II pictorial issues. I found the St. Anthony Church and the Botanical Gardens particularly impressive. While sea island cotton was featured on some of the stamps, not much seems to be under cultivation now.

My visit to the Emerald Island of the Caribbean was most pleasant, and I certainly recommend a trip to this delightful, unspoiled bit of the tropics.

#### MISSENT TO BRITISH HONDURAS----

In the February 1970 BCPJ, Joe Chin Aleong reported a MISSENT TO BRITISH HONDURAS mark with 5mm sans serif letters but did not provide an illustration nor state its

length. Thanks to Gale Raymond who sent us a cover to examine, the illustration can now be provided. Gale's cover was sent from Jamaica

to the Republic of Honduras, and has a Kingston, Jamaica postmark JU 12 1968. The letter reached its destination in the Bay Islands of Honduras just one week later, so the misrouting did not result in any great delay. The "Missent To" mark is in purple ink, and the dimensions are  $5 \, \mathrm{mm} \times 69 \, \mathrm{mm}$ .

This is the mark that is listed as No. 3 on page 16 of the February 1970 BCPJ.

Type numbers in the first column are my reference, while those in the second column are Higgins and Gage catalogue numbers. The prices quoted are those seen by me from various sources in England.

c = Still current as of mid-1969 when list was compiled; dd. = Nominal price of a few pence; S = Scarce owing to being little used.

#### STAMPED AIR LETTER FORMS

#### 21 JULY 1947

Printed by McCorquodale of Wolverton on Yellowish-white unwatermarked paper, with outer panels covered in a Bluish-grey wash, except for the rectangle for insertion of the imprinted stamp.

All instructional lettering typographed in Dark Blue with AIR LETTER in block capitals, and three lined warning.

6d stamp (Priestmans River) lithographed in space provided.

All instructional lettering is lithographed in Dark Blue with AIR LETTER in italic capitals, and four lined warning.

6d stamp (Priestmans River) lithographed in space provided.

Printer as previous. This is a re-issue of the SAL1 item but with panels covered in a Slate-grey wash.

The instructional lettering and the three lined warning are lithographed. 6d stamp (Priestmans River) lithographed in space provided.

SAL3 1a As issued with stamp in deep dull purple 7/6d 2/6d

NOVEMBER 1955 FIRST PROVISIONAL ISSUE.

Printer as previous. Paper as last two items.

All instructional lettering is typographed with the new "British" style curved "BY AIR MAIL" panel, bi-lingual "AIR LETTER/PAR AVION", and four lined warning, all in Dark Blue. This temporary format is believed to have been used because the layout

was already being used for printing air letters of other colonies, and this supply was urgently required.

6d Stamp (Priestmans River) lithographed in space provided.

SAL4 3 As issued with stamp in Pale Purple (shades)  $\frac{\text{MINT}}{10/-}$   $\frac{\text{USED}}{15/-}$ 

This issue amounted to 2,000 items, and they were put on sale only at the Kingston G.P.O. Most of the issue was used to provide First Flight Covers for the new Viscount service to Trinidad in 1955.

#### EARLY DECEMBER 1955 SECOND PROVISIONAL ISSUE.

Printer doubtful, possibly McCorquodale of Wolverton, however official sources say it is believed to have been locally produced. Printed on Light Blue paper without watermark and without colored wash. No rectangle left for imprinted stamp.

Instructional lettering lithographed in Dark Blue in open format.

6d Stamp (Priestmans River) printed directly onto the Light Blue paper.

SAL5 4 As issued with stamp in Purple 5/- 10/- 5a 4a As issued with stamp in Dull Purple 10/- 15/-

This issue was placed on sale only at certain of the larger post offices.

#### 6 AUGUST 1956

Printed by McCorquodale of Wolverton on Sky Blue paper without watermark.

Instructional lettering etc. lithographed in Red, with "British" style panel as in SAL4. Large three lined warning is on reverse of form. Sheets are very unevenly cut and difficult to fold exactly to lines as instructed.

6d Stamp (Doctor Bird) printed directly onto the Sky Blue paper by line engraving, in two operations.

SAL6 5 As issued with stamp in red and black 5/- 5/-

1958

Printer as previous. Exactly as last issue, SAL6, but with stamp lithographed as rest of form. Easily distinguished from SAL6 because red shading covers the area of stamp on which Doctor Bird is printed.

SAL7 6 As issued with stamp in Red and Black. (Shades exist of Red color and Sky Blue paper.) 2/6d 1/SAL7a Variety:- Doctor Bird (Black printing) omitted £22 £18

1962 INDEPENDENCE COMMEMORATIVE ISSUE.

This issue was simply SAL7 (in one of its paler and lighter shades) which had been machine overprinted INDEPENDENCE/1962 by the printers before despatch in two lines in Black ink.

SAL8 7 As issued 1/- dd.

1963

Date of issue incorrectly stated in Higgins and Gage Catalogue.

Printed by Charles Skipper and East Ltd. (a subsidiary company of the McCorquodale

Group), and the forms were gummed and cut at the Wolverton works.

Printed on Pale Blue unwatermarked paper without inset for the imprinted stamp.

The instructional lettering is lithographed in Deep Blue, with curved panel as was used on SAL6. Large six lined warning on reverse panel.

6d Stamp (Aircraft over Jamaica) lithographed directly onto the Pale Blue paper.

SAL9 8 As issued with stamp in Carmine (shades exist of MINT USED Pale Blue paper and of both printing colors.) c dd.

13 JULY 1966 BRITISH EMPIRE AND COMMONWEALTH GAMES ISSUE.

Printers etc., as in SAL9, in multicolor, on Pale Blue paper watermarked "Imperial Airmail", with uncolored inset for printed stamp.

Special layout and 6d stamp (Arms of Jamaica) lithographed in multicolor.

Date of issue given in Higgins and Gage Catalogue is incorrect. Printers etc. are as previous.

As SAL9 and entirely lithographed, but with the instructional lettering, panel and warning printed in Turquoise Blue, with the entire reverse of the sheet printed in multicolor in one of four "scenes".

This issue was on sale throughout the island, priced at 10d. This included a non-postal charge of 4d. As a result, they were extremely unpopular and not in demand commercially which makes them scarce in used condition. See also SAL13, etc.

On 1 July 1968, the air letter rate to most countries was raised from 6d to 9d and pending the printing of a new 9d air letter form, the post office was selling SAL9 and SAL11, 11a, 11b, and 11c with a 3d adhesive affixed to make up the new 9d rate. Other 6d air letter forms held by the public could be so treated, but no stocks of these were held by the post office.



## WERE THERE TWO BERMUDA K1 NO.2 MARKS?

In his book on Bermuda, Morris Ludington notes that the Type K1 cancellations were in general use between September 1865 and May 1879. He also states that the No. 2 mark, which was used at Hamilton, is known canceling the Queen Victoria 1d aniline carmine, watermark Crown and CA, which was issued in 1890.



I have one such example, and I have always been struck by the cleanness of this strike when compared to the ones of the earlier period. Albeit the "2" is not as well inked as one would like, the full outline of the figure is there for study under the magnifying glass. There appear to be several differences between this strike and others of earlier dates. The most prominent of these are:

(a) The bottom left of the late use "2" comes to a sharp point, whereas the earlier ones are blunt.

- (b) The distance from the vertical tail at the bottom of the "2" to the horizontal bars on the right is 7mm, versus 6mm on typical early cancellations.
- (c) On early cancellations, the tail at the right bottom of the "2" is more nearly vertical than on the late use strike.

In addition, the bars of the later cancellation are narrower and appear to be more widely spaced as a result.

In the above illustration, the late use cancellation is in the middle. Is it the same, or is it different?

#### MANUSCRIPT MARKINGS ON BACKS OF STAMPLESS ENTIRES----

Most of the stampless entires which survived, did so because they were of value as records, and were filed away by the party receiving them. To make quick reference possible, the addressee or an employee would scribble a short note of the contents of the letter on the back. This would often include the place and date from which sent, name of sender, and the subject of the correspondence. When a letter had to be located, it could then be identified by the note on the back, making it easier to find than if each letter had to be opened and scanned for contents.

## AN UNSANCTIONED DOMINICA OVERPRINT

Five covers have been found bearing Dominica stamps, Scott #'s 164-5, with a three line diagonal overprint reading INTERNAL/SELF-GOVERNMENT/1 MAR 1967. Examination of the printing under high magnification shows that it was typewritten, as the ink has a mottled look, rather than the solid appearance of letter press.

All covers were addressed to the same person, and it is presumed that he made them and had them posted to him by his connections in Dominica. Only Scott #'s 164 and 165 are known with this overprint. Two colors of ink, red and black, were used.



The first cover I acquired was from St. Joseph. Writing to the postmaster there I received no reply to my query about these stamps. Equally fruitless was a letter to the addressee of the covers. I then posed the same question to the postmaster General at Roseau and received the following reply

GENERAL POST OFFICE ROSEAU, DOMINICA 29th April 1970

Dear Sir,

Thank you for your letter of April 14th 1970, to which I hasten to reply. The typewritten overprinted stamps were not sanctioned by the Post Office nor the Government of Dominica. Mail items bearing such stamps were surcharged in the usual manner. With regard to those canceled at St. Joseph I can only say they escaped the scrutiny of the Post Office.



## **Leewards Information Wanted**

I would appreciate help from our members regarding the illustrated Leeward Islands postal stationery item. I have already sent a Xerox copy to Ed Fladung, Editor of the Higgins and Gage Catalogue, but would like to find out if anyone else has one.



The envelope is similar to the H & G envelope, No. B-10 of the KG VI reign. Paper is thin, and the inside is printed in a light gray mesh pattern to give additional "look through" security. The paper appears to be a yellowish white. The stamp is similar to the regular De La Rue KG V definitives, as Scott illustration A5 and SG illustration 10, and is printed in Brown. Someone has torn off the major portion of the back, and part of the envelope was clipped off at the left edge. Making an allowance for this, the overall dimensions approximate the H & G "d" size envelope which measures 152mm x 90mm. The postmark is ST. JOHN'S, ANTIGUA, JY 3 34.

I also showed Ed Fladung a copy of his type B-10 with a  $1\frac{1}{2}$ d KG VI imprinted stamp, and I presume he will modify his list to include it. Incidentally, the 1939 Post Office Guide of the Leewards lists KG VI envelopes on thick paper, (similar to the 1920-30 KG V envelopes), as well as the thin paper B-10. Denominations are 1d Red and  $1\frac{1}{2}$ d Brown. Per Guide listing, KG VI sizes are: Thick 5 1/4" x 4 1/8" and Thin 6" x  $3\frac{1}{2}$ " (size "d"). I would appreciate hearing from anyone who has one of these KG VI thick paper envelopes, with details on date of use, etc.

## **Book Presented to Jamaica Institute**

Thanks to the efforts of its Director and Curator, C. Bernard Lewis, The Institute of Jamaica is slowly, but surely, building up its Philatelic Department. Recently its collection of philatelic literature received an important addition. Perhaps some member will find an answer he has long been seeking tucked away here, and we know Mr. Lewis and his capable staff will be happy to assist in the quest.

## **WARNING!**

Paul Larsen has shown us an air letter from "CROWNJEW HOUSE" in Georgetown, Guyana offering to sell a lot consisting of twenty complete mint sheets of early Leewards stamps, at well below their market value. It specifies that payment is to be made in U.S.A. \$100 banknotes, with 50% to be sent in advance and the balance after the sheets have been delivered. Total asked is \$1600.

Paul has also shown us a notice in the German Postal Specialist reporting somewhat similar offers to members of the German Philatelic Society, of German mint sheets. In this case the asking price is \$3000, with nine \$100 bills paid in advance.

This is not the first we heard of this dealer in Guyana. In 1969 the ASDA warned its members concerning a Guyana dealer who was offering wholesale lots, and asking for payment in \$100 bills as above. We wrote to Phillip F. Robbins, the Executive Officer of the ASDA about this, and although he preferred not to go into very much detail, he said that the warning applied to a particular dealer who operated under various names in Georgetown, Guyana for many years. He added that nobody has been able to get a shipment from him by paying through the local bank against delivery, or through a bank in the United States.

We have not been able to learn if anyone has ever concluded a successful deal with this individual, but as the G.P.S. says about these offers, "SMELLS REAL FISHY".

While the offer specifies "advance refunded if not satisfied", it takes more faith than we can summon to believe that one who won't allow a local agent to verify the goods before payment, and asks payment in a form that leaves no record, intends to make any refunds.

If anyone can provide more information, it will be much appreciated. We recommend caution until more is known about this dealer.

## ANTIGUA ADDENDA by WILLIAM G. CORNELL

Captain Jerry Kedrierski has come up with a most unusual find, a G.B. stamp having a boxed, straight-line ANTIGUA mark across it. Though it would not be surprising to discover a British stamp struck with one of the pre-adhesive marks, in place of



the proper "A02" obliterator, I have been unable to find a strike such as this in any of the literature on Antigua postal markings.

Shown at the left is a 2½ X enlargement of this odd item. The mark is in black ink, and the height of the letters is about 3½mm. Although not too clear on the photo, a line parallel to that above ANTIGUA at an equal distance below it, shows that this mark is boxed. The adhesive is the 1d rose red of 1857, a stamp known used in Antigua with the "A02" oblit.

It is possible that this mark has additional words, before or after Antigua, since the sides of the box were struck off stamp. If any reader has ever seen a similar strike on stamp, cover, or used in a non-postal function or whatsoever, I would appreciate a

report giving full details concerning its use.

The "flood" discussed in the June Journal occurred on 11th May, the day before the second use of the "DAMAGED BY EXCESSIVE RAIN" handstamp. It is reported that the Public Works Department repaired the gutter of the road outside of the GPO in such fashion that the overflow pipe of the cistern at the rear went right down into the gutter, facing up the hill. Thus, a GPO flood was inevitable when the rains came. Official figures indicate that 17.99 inches of rain fell on Antigua during May.

Gil Holmes comments on the blocked-out control numbers of George Bowman's block of the 20¢ on 25¢ overprint (June Journal) as follows: The stamps arrived on Antigua with the original control numbers blocked out and new numbers printed on, although the first half-dozen odd sheets had the original numbers cut off. No double block-out sheets have been seen on Antigua. Thus, three control number varieties exist.

As discussed in the June Journal, the 25¢ coil stamp has a variety in the form of a white mark above the N of ANTIGUA on the stamps above the wide gutter of certain rolls. Gil Holmes reports, per Harrisons via the C.A., that the coils are printed from a roll having 12 stamps side by side, and 21 stamps around the roll. It can be deduced from this that the variety occurs once in 252 stamps, and also that the variety will be found once in each strip of 21 stamps of every 12th roll.

#### EARLY DATE FOR ST. LUCIA PAQUEBOT MARK----

The boxed St. Lucia PAQUEBOT mark, Studd No. A448, (see April 1970, BCPJ, page 50) is known from 1929, five years earlier than reported by Studd. According to the Editor of the Seaposter, Leonard Joesten, who gave us this information, it is also known to have been used in 1970. He also said that a number of other date changes from those given by Studd were listed in the October 1954 Seaposter.

#### INFORMATION SOUGHT ON FALKLANDS STAMP MARKING----

While the scope of our BCPSG activities does not include study of the Falklands, a number of our members do specialize in that Colony. Thus perhaps someone can shed some light on a postmark found by John Ayre on a Falklands Victorian stamp. It is a strike in black ink of the letter "V". John thinks that it is an obliterator of the "F.I." type often found on early Falkland stamps, but the lines around the "V" are not clear enough to be positive or to make accurate measurements. He suggests that the "V" could be for Valparaiso, Chile. Can anyone help?

45 BROMFIELD STREET, BOSTON, MASS. 02108 TELEPHONE: 617 HA6-2712 Also from Trinidad, we note that a Skeleton postmark is being used at COUVA. Our only strike is dated 9 JY 70, and reads COUVA PO at top and TRINIDAD at bottom. Date is in one line, and there is no asterisk.

A Birmingham B3 Type is reported by Dr. Ben Ramkissoon, reading SAN FERNANDO P.O., date 13 MR 70. The old B3, sans P.O., had been showing signs of wear and may have been replaced by this new version.

Strikes of the EIGHT MILE ROCK, Bahamas CDS Type 7 dated 5 MAY 70 and 17 JUL 70, are so sharp that they may have been made by a new datestamp. The original Type 7 has been in use since 1946 so may have rusted away, but we lack a good strike of it for comparison.

The sinking of the St. Kitts-Nevis ferry on 2nd August with great loss of life was well reported by the news media, and most of you will have heard of it. Eric Heyer has sent information on the ill-fated M.V. CHRISTENA which will appear in the December Journal.

New decimal currency postal stationery from Bermuda has been sent us by Ben Ramkissoon. A Three Cents post card shows no changes in text or stamp frame, but the portrait of QE II is now the cameo type. All printing is in black ink. A Three Cents wrapper bears the same imprinted stamp also in black ink. The old 9d Air Letter form was overprinted, with the 9d barred out and 9 CENTS in black ink added at the upper left of the stamp.

Ben also showed us an unofficial Air Letter consisting of an unstamped IMPERIAL AIRMAIL form imprinted "BERMUDA" within a design of flowers at the top of the message side, and a Red Cross and "Benefits of Sale to assist BERMUDA RED CROSS PROJECTS" in red ink also on the message side, at the bottom.

Our *Dank U zeer* to the kind person who sent an FDC of a recent Netherlands Antilles set from Aruba. The enclosure was also greatly appreciated.

Reg Lant sends a Jamaica cover franked by a green ink OFFICIAL FREE and Crown handstamp on a cover from the Auditor General, who is the only Jamaica Official authorized use of that color of ink. Pat Burke says the A.G. gets this authority from a regulation which was carried over from old Colonial days.
