

BERMUDA MAIL ROUTES

With the advent of ocean going steamships, the mail service to and from Bermuda was made much faster and more reliable, as it was for most parts of the world.

From the mid-19th century onwards, letters between the colony and the mother country could be forwarded by a choice of routes. The Royal Mail Steam Packet Company stopped at Bermuda on its service between England and the West Indies for awhile. Later, Cunard ships, on their way to and from the West Indies and Halifax, carried mail that was transferred to ships going from Halifax to England at one end and from the West Indies to England at the other. As early as 1850, mail could be sent by regularly scheduled steamers to New York to catch the fast transatlantic service to England.

Packet mail was also carried occasionally by Her Majesty's warships serving in the West Indies or based at the Royal Naval Dockyard in Bermuda. Also, commercial ships, carrying freight, often scheduled stops at Bermuda where they would leave or pick up mail. Of course, these services did not always operate simultaneously or continuously from the earliest period onward.

By the early 1880's, correspondence with England could be routed via Halifax, via the West Indies (Jamaica), direct, or via New York, which was usually the fastest way. Since the postage rate was the same for all routes, four pence, the choice depended largely on timing.

Figure 1 shows a letter carried by the Royal Mail Steam Packet S.S. 'Beta' which had arrived from Jamaica on 13 September 1883 and left for Halifax the same day. The letter arrived in London on 5 October 1883 after a trip of 22 days.

In the opposite direction, the R.M.S.P. S.S. "Alpha" arrived from Halifax on 9 June 1882 with the English mails, picked up the letter shown in Figure 2 and left the same day for Turks Island and Jamaica. Here the letter was transferred to a ship going directly back to England where it arrived on 11 July 1882 after 32 days en route.

The cover shown in Figure 3 came direct from England aboard the freighter S.S. "Ceto." The "Ceto" had left London on 7 July 1881, but picked up the letter at Dartmouth two days later.

It is dated London, 7 July, so it must have missed the sailing from London by a few hours and gone overland to Dartmouth. The ship left Dartmouth on 9 July and arrived in Bermuda on 25 July after 16 days at sea. The "Ceto" then proceeded on to Nassau with miscellaneous cargo, a $12\frac{1}{2}$ ton gun, and possibly mail for the West Indies.

On 3 July 1883 another letter to George Smith, Figure 4, left Bermuda for New York on the S.S. "Orinoco" of the Quebec Steamship Company. From there it was transferred to the regular transatlantic service to England where it reached London on 21 July 1883. This trip took only 18 days. It was nearly as fast as on the direct route by an occasional ship like the "Ceto" even though the distance traveled was roughly 20% longer by way of New York.

In these days of less than 12 hours by air between London and Bermuda, it is hard to realize how 16 or 18 days was considered fast modern mail service by our ancestors.

Grenada's Competent Authority

When Great Britain declared war on Germany on 3 September 1939, Grenada immediately dispatched a telegram to the Secretary of State of Great Britain pledging Grenada's loyalty to the war effort. Immediate steps were taken by the Grenada Government to pass Colonial Defence Regulations, set up telegraph and postal censorship and price controls, and establish the office of Competent Authority.

To date, no covers posted during World War II and possessing Competent Authority markings have been recorded. "The Grenada Handbook and Directory 1946" lists E. Gittens Knight, M. B.E. as the Competent Authority. E. Gittens Knight is also listed as a Barrister and was Acting Colonial Treasurer and Controller of Supplies at the time the above book was published. It is probable that Mr. Knight was the Competent Authority throughout the war.

The first postal item recorded with a Competent Authority notation is in the collection of Harvey O'Connor. It is an OHMS envelope and typed in the bottom left corner on the front of the envelope is:

Competent Authority Grenada, B.W.I. The undecipherable initials of the Competent Authority are above the typing. The cover has an Official Paid, Grenada c.d.s. dated 11 SP 1947. It is probable that the Competent Authority used this method of addressing his covers during the war, although confirmation of this is needed.

Long after the war, the Competent Authority had acquired a handstamp which is illustrated below.

The handstamp reads "APPROVED", with an adequate space provided for a signature above "Competent Authority". The "APPROVED" is 4.5×35 mm in sans serif capital letters and the "Competent Authority" has the first letters of each word in sans serif capital letters 3 mm high and the remaining letters in lower case 1.5-2 mm high with the two words 46 mm long.

The earliest known date for the actual use of the handstamp is 23 OC 1953. This was a registered letter addressed to the Moor Stamp Company of Ashland, Ohio and apparently was sent by a private citizen, Mrs. Veronica Xavier. This cover has the handstamp applied to the back in purple ink with the Competent Authority signature of N. Neckles. In "The Grenada Handbook and Directory 1946", a Nicholas N. Neckles is listed as a planter and proprietor of the Beausejour Ice Factory in St. George's parish. Below the handstamp are two strikes of a 5×30 mm straight line datestamp of 23 OCT 1953, also in purple. Apparently the Competent Authority had to give this cover his stamp of approval since it contained stamps for collectors.

Harvey O'Connor also has a cover with the "APPROVED//Competent Authority" handstamp. The cover is dated 23 NO 1956 and is signed by G. Buggs, an unimpressive name for someone holding the impressive sounding position of Competent Authority. Mr. G. Buggs applied his handstamp to the back of the cover and used purple ink to apply the handstamp. He also applied one strike of the 5×30 mm straightline datestamp in purple, dated 23 NOV 1956. In manuscript above the handstamp is "Contents/Used postage stamps", which probably was applied by the sender or a post office employee, as the handwriting is not that of G. Buggs. Like the previous cover with the "APPROVED//Competent Authority" handstamp, the author assumes the handstamp was applied because the cover contained stamps for collectors.

At the outbreak of World War II, the office of Competent Authority was of such importance that it was one of the first steps taken by Grenada to prepare for the war effort. By the 1950's, the Competent Authority was approving covers containing stamps for collectors. Since it is unlikely that the office of Competent Authority was formed in 1939 to check on stamp collectors, we are left in the dark on what its original purpose was.

Hopefully some member can throw some light on what the main functions of the Competent Authority were when the office was originally established and its functions after the war. The author would also like to know if any readers have covers with a competent authority notation used during the war or after, either from Grenada or the other islands.

De La Rue Records: Jamaica

(Editor's Note: This article begins a series on various items of Jamaica philately as gleaned by Michael Vokins from the De La Rue records.)

1. STAMP VENDING MACHINES FOR JAMAICA

The De La Rue records reveal that a stamp vending machine must, in all probability, have been first operated in Jamaica in 1913. The correspondence book with the Crown Agents (Vol. 56) has a letter dated 31 January 1912: "We have received an inquiry from the Govt. of Jamaica as to rolls of stamps 1200 in each for use in an Automatic Stamp selling machine supplied by the British Stamp and Ticket Automatic Delivery Co. For how much could you supply such rolls of stamps?

The reply from De La Rue on 7 February stated 'We could supply reels, each containing 1200 stamps on a cardboard spool at 56s 5d the lot." On 4 April 1913 the Crown Agents wrote again "Please let us know if you can now undertake the manufacture of the rolls of stamps."

According to the Day Books (Vols. AA, AB) stamps in rolls were supplied to Jamaica on four occasions only and then the practice ceased:

15 July 19131d -750 sheets in rolls, 150 rolls of 1200 stamps each27 July 19141d -260 sheets in rolls, 156 rolls of 400 stamps each5 July 19151d -1290 sheets in rolls, 258 rolls of 1200 stamps each29 May 1916 $\frac{1}{2}$ d -510 sheets in rolls, 102 rolls of 1200 stamps each

No more orders for stamps in rolls were placed until the George VI definitives were first issued. On 25 November 1937, the Crown Agents instructed De La Rue that when the new George VI $\frac{1}{2}$ d and 1d stamps were ordered, dummy rolls would be required "in connection with stamp selling machines in Jamaica."

The new George VI definitives were prepared and printed during 1938; on 11 August De La Rue wrote that dummy rolls of the new $\frac{1}{2}d$ and 1d, in rolls of 500 stamps, would be ready in three weeks. However, the dummy rolls were not forwarded to the Crown Agents until 7 October.

It then took eight months for the Crown Agents to issue a contract, on 4 July 1939, for "stamps in rolls." But there were problems, because on 19 September De La Rue sent to the Crown Agents rolls interleaved with wax paper "which we trust will function satisfactorily in the vending machines." And, since the wax paper had to be inserted by hand, they asked a price of 1/8 per roll. On 19 October De La Rue wrote to the Crown Agents that Messrs. Hall Telephone Accessories would be testing the roll. On 6 November they had to write that, because of delays and adjustments, Messrs. Hall would not be able to deliver the machines on time. However, they wrote again on the same day to the almost certainly impatient Crown Agents that the rolls had been tested that very day and had worked satisfactorily.

The 4 July contract was signed on 6 November for 240 reels of the 1d and 240 reels of the $\frac{1}{2}$ d. Delivery was promised for 21 December 1939.

Sadly, there is a gap in the records at this period and no evidence to tell us if these reels were ever printed and dispatched.

Antigua Monograph

The following is a continuation of Section 7.3, King George V Definitive Stamps, which began in the October 1977 BCPJ. The section was drafted by Bill Cornell, with reviews and contributions provided by George Bowman, Gil Holmes, Nat Surtees, Mark Swetland, and Edward Thompson.

QUANTITIES

The data on stamp quantities tablulated below were mainly obtained through the courtesy of the Crown Agents. However, certain data were obtained from the De La Rue Archives through the courtesy of A.G. Rigo de Righi, Curator of the National Postal Museum, who allowed A.J. Branston to examine the Museum's holdings. The De La Rue data shown below consists of all information on the initial shipment of Small Seal stamps in April 1921, as well as certain other data on dealers' quantities and Specimen quantities ((3)). This information is identified by (DLR) in the tabulations.

The "total quantities" are listed as dispatched in the Crown Agents' records. The "dealers' quantities" are from the same source, unless otherwise identified. The difference between total and dealers' quantities represent those sent to the island. Patrick Hamilton ((14)) indicates that the Crown Agents began to handle dealers' supplies with the St. Kitts-Nevis issue of 1920. Accordingly, the system for recording dealers' quantities in the records may well have not been fully developed at the time of the earlier printings of the Small Seal stamps ((3)).

- (ii) Geoffrey W. Groves ((15)) notes two shades dull green and deep dull green, the latter presumably from a later printing (see section below on shades). The two shades are confirmed by Swetland and Cornell, and the chronological order of the shades is confirmed by a dull green block canceled 20 SP 1921 in the Cornell collection ((3)).

No. 1856) was in a slate-grey as compared to the original grey. The three shades are confirmed by Swetland and Cornell, plus the fact that the grey shade appeared initially is confirmed by a block canceled 20 SP 1921 in the Cornell collection ((3)).

The existence of two shades of purple is confirmed by Cornell, but on a single paper color ((3)).

(i) Groves ((15)) notes two shades, dull and bright purple and purple and bright purple. Melville ((1)) states that a printing issued on 23 July 1925 was in "brown-purple and bright purple." Reference 6 states that a mid-1925 (?) printing was in "brown-purple and rosine," possibly following Melville. Although Melville seems accurate about the 2d "slategrey" and 3d SCA being issued on 23 July 1925 since Reqn. No. 1856, dispatched 25 June 1925, contained these stamps, no 6d stamps were included, according to the Crown Agents' records. It may be that the 1921 and 1922 printings were of different shades or that the Crown Agents' records omit another 1925 dispatch. The existence of two shades of purple is confirmed by Swetland and Cornell ((3)).

REMARKS ON SHADES

In defining shades in the above discussion of stamp quantities, Stanley Gibbons' nomenclature has been used and the Gibbons Color Guide has been employed in making comparisons among examples studied.

In addition to the definite shades discussed above, there are minor variations or "sub-shades" as well in the cases of the 1d bright scarlet, $1\frac{1}{2}$ d carmine-red, 2d grey, and 2/- MCA purple and blue on blue (two shades of purple).

BERMUDA FLIGHT UPDATE

by Stephen E. Papworth

I would like to amplify the check list on Charles Cwiakala's "First Flights of Bermuda," which appeared in the August 1976 BCPJournal.

Concerning the flight per USS "Los Angeles," 21/23 April 1925, the two-line and three-line cachets applied in Bermuda for the return flight (Cwiakala Figures 5 and 6 respectively) are noted by Ludington in his major work as AC2 and AC1 respectively. Ludington also notes that the two-line cachet has been applied in both black and mauve, but only reports the three-line in black.

From covers in my own collection, I can report that the following combinations exist: a) twoline in black, (b) two-line in both black and mauve (or purple) on the same cover, (c) threeline in black, (d) two-line and three-line both in black on the same cover, and (e) two-line in mauve and three-line in black on the same cover.

I have never seen or heard of the three-line in any color other than black. From scarcity point of view, both two and three-line appear to be about equal, at least here in the U.K. The double cachet markings, both in black, seem only slightly more rare, the double cachets with twoline in purple a bit more difficult to find, and the two-line in mauve, on its own, the hardest of the lot. Prices asked, however, do not reflect this relative scarcity, the single three-line invariably making a higher premium (unwarranted in my opinion).

There is also a further error of the three-line cachet — the "A" of AIR being missing, which I wrote about in the BWISC "Bulletin" No. 89 (June 1976).

With regard to the outward flight from Lakehurst, NJ, I have a cover dated with the New York cancel APR 15 1925, which also bears a three-line cachet in turquoise which reads "Via Airmail/By Air Ship Los Ange les/From Lakehurst NJ." From the spacing of the letters it would appear that this was a made-up rubber stamp from individual letters. It is reported by Francis J. Field of Sutton Coldfield, U.K., that this cachet is very rare, but I can find no references to such a cachet being officially used and I wonder whether this is a "private" one or not. The cover is addressed to R.O. Clifford, St. Georges, Bermuda (as are most of my covers of this flight), has been machine numbered 148 in black on the reverse together with the St. Georges, Bermuda, CDS dated 22 Apr 26 C. Can anyone throw any light on this particular cachet?

Incidentally, I also have a cover flown on the first "Los Angeles" flight to Bermuda bearing the red New York mark dated Feb 20 which was posted at Varick St. Sta. on 18 February. The cover is addressed in normal script handwriting (again to R.O. Clifford) and bears a two-line cachet in purple reading "AIR MAIL BY/AIR SHIP LOS ANGELES FROM LAKEHURST NJ." This cachet has been type set and, once again, I can find no references to such a cachet being used. Information on this would also be most welcome.

Postmarks of Guyana

The following is a continuation of the article on the Postmarks of Guyana which began in the October 1977 BCPJ.

TYPE 4

PA before or after name of agency, GUYANA at foot in 29.5-30.5 mm diameter circle. Although these marks are used by the greatest number of postal agencies, they are scarcer than most other types; indeed, several of these should prove rare in time. This list includes a number of agencies which have been opened recently due to the expansion of postal business.




PA Before or After Name of Office, Guyana at Foot







BITS & PIECES from HERE & THERE

BARBADOS - Ben Ramkissoon reports seeing a Worthing P.O. 3 CDS dated 17 OC 77. CDS' with P.O. 1, 4, 5, and 6 have previously been reported.

<u>BERMUDA</u> - Lynn Wallace has noticed that <u>official</u> First Day Covers sold by the Bermuda Post Office lately do not have a cachet (Silver Jubilee, UPU, Piloting) and wonders if this is a new post office policy.

Along this line, Jack Arnell advises us an an unofficial First Day Cover for the Piloting issue. The Bermuda Maritime Museum produced 5,000 souvenir covers on the first day of issue, 26 SEP 77, which show the pilot gig 'Rambler,'' the only surviving gig which is on display in the Museum. These covers have the two stamps depicting pilot gigs on them and are available from the Bermuda Maritime Museum, PO Box 273, Somerset 9, Bermuda, for \$2.50 plus 25¢ postage and mailing under separate cover.

Ben Ramkissoon advises that he has a cover with two of the piloting stamps on which has a return address of Bermuda Biological Station. The cover is signed by Captain Emmett of the R/V "Panulinus II" for oceanographic research under the auspices of the Biological Station and NSF.

Referring to articles on Bermuda Prize Court Mail by Lincoln Kieffer (August 1972 BCPJ) and Jack Arnell (Dec. 1974 BCPJ), Richard Heap writes that he has now seen a cover with this mark in red with a Bermuda Registered GPO CDS dated 7 Aug 48, which is an earlier date.

Heap also writes that in reference to Lynn Wallace's article on Bermuda Railway Parcel Stamps which appeared in the October 1976 BCPJ, a cover similar to that described by Wallace (P6910) bearing No. P6907 went for £50 in a recent London auction. It is a West Indian Oil cover from St. George's to Hamilton. The auctioneer sent Heap a cutting of the item which included a photostat which reads "A curiosity than of orthodox philatelic character. Its date is in April 1937. Immediately after I had obtained a few of such covers out of a friend's waste basket in Hamilton the company began using the parcel stamps with the control number torn off and have been doing so ever since, apparently lest they should be used again."

Heap is now turning his attention to U.S. military labels and marks used in Bermuda. He would appreciate any information members may have on this.

Dan Walker reports that at a recent USCS Admiral Byrd Chapter meeting, Dr. Forest Swicker, President of the USCS, discussed a recent trip he took to Bermuda. In Bermuda he visited St. George's and asked about their Paquebot mark. Apparently, at one time they had a straight-line mark, but are presently using a small, blank double circle, approx. 17 and 15 mm in diameter, on paquebot mail. Swicker asked if they would be interested in a new Paquebot handstamp and they answered in the affirmative. Illustrated is a proof strike of the marking which Swicker had made up for the St. George's Post Office.



The Bermuda Post Office set up a special post office at BERMUPEX '78 at the **Castle** Harbour Hotel on 28 January. Both a datestamp and registration handstamp were used on this day.

<u>BRITISH HONDURAS</u> - O. N.D. Phillips has discovered a slogan RED/CROSS/ROLL CALL/ JOIN on a KGVI 4¢ stamp on piece (S.G.153). The first four words are 2.5 mm in height and the last is 4.5 mm. The words are enclosed in a box 20×24 mm which is joined to seven horizontal lines at least 26 mm long and spaced 3.5 mm apart. He is interested in the EKD and LKD dates for this slogan. Can anyone help him?

In the October 1977 BCPSG auction Phillips noted a British Honduras KGV 10¢ stamp (1913) was offered with a violet pre-cancel reading POSTMASTER/BELIZE/BRITISH HONDURAS. He advises that the full reading of this cancel would have been COLONIAL/POSTMASTER/BELIZE/BRITISH HONDURAS. Although it was stated to be an apparently unused o.g. copy, Phillips feels that it must have been used fiscally, doubtless on an 'unsealed' document, perhaps a contract between the Postmaster and another party for the carriage of the mails.

BRITISH VIRGIN ISLANDS - Charles Ricksecker sends a letter written by BVI Postmaster T.A. Fahie, clarifying the handling of future BVI postage stamps. Fahie writes:

"After making inquiries, the Government was satisfied to enter into a sales agreement with I.G.P.C. for the sale of B.V.I. stamps in West Germany, Italy, Switzerland and Japan on an exclusive basis. France, Holland, Belgium and Spain were assigned to the Crown Agents on an exclusive basis and the rest of the world including the United States, Canada and Great Britain was to be shared by both agents. The Crown Agents were unhappy about the European countries assigned to them and have proposed a worldwide sharing arrangement instead. This is being negotiated with I.G.P.C. who are inclined to accept the new suggestion.

"The Crown Agents will also retain responsibility for design and printing control of B.V.I. stamps as they have been doing in the past and the agreement with IGPC is not a departure from our stamp issuing policy except that now two agents are retained instead of one.


"Finally, I would like to say that as far as I know all negotiations made in connection with the agreement with IGPC have been above board."

<u>DOMINICA</u> - Charles Ricksecker writes that in Dominica 2,000 government civil servants were out on general strike from 1 Sept. to 17 Oct. 1977, protesting the failure of their government to pay them raises which had been due for the past three years. The postal services on the island were at a complete standstill, as the post office employees, air traffic controllers, and dock workers all participated. LIAT, the only airline to serve Dominica, was unable to do so for over a month. Sea mail was held up at Barbados or St. Lucia. Ricksecker says that since the strike, the opposition members of the legislature are calling for a "No Confidence" vote against the current government in an attempt to force them to reveal financial figures to show why the Dominica government is practically bankrupt. If the campaign is successful, Ricksecker says it may prove interesting to see the postal revenue figures for Dominica over the past several years, especially for the overseas sales of postage stamps.

<u>ST. LUCIA</u> - Bob Deveaux advises that there is a new sub-post office at PERROT as of 1 No-vember 1977.

TRINIDAD & TOBAGO - Brian Renshaw points out an error in his listing of T&T cancels which appeared in the Oct. 1977 Journal (p.165). A Garden Hill is listed for Tobago, but Garden Hill is in Jamaica! The listing should read Belle Garden.

Both Renshaw and Mike Romano advise of several new p.a. and p.o. openings in Trinidad: the first is PREYSAL (PA), which Renshaw says is near Gran Couva. His dated example is 18 JY 77, but he believes it opened much earlier in the year than that; BELLE EAU ROAD (PA), advises Romano, opened 21 NO 77. The agency is at the home of Mrs. Elsa Benjamin in the Belmont District, an eastern suburb of Port-of-Spain; VALSAYN Post Office opened on or about 1 DE 77 and is located in a huge super-modern "Valpark" Shopping Center according to Romano. Renshaw advises that two CDS' are in use (Types X and XIII). ST. HELENA (PA) was re-established 1 DE 77 at the home of Arjoon Prabhoo in St. Helena Village. The village had been without a postal agency for some time. It is in the Arouca District. PLUM ROAD (PA), Renshaw has a 1 NO 77 example.



Romano writes that Roderick Pemberton is now Acting Postmaster in Trinidad and that things seem to be moving in the way of improvement.

Although a Type XIII CDS has been in use at least for $2\frac{1}{2}$ years at Signal Hill, Tobago, Renshaw does not think it has yet been reported in the BCPJ. His example is dated 23 DE 75.

Ben Ramkissoon reports a meter slogan used in San Fernando, Trinidad, reading SAVE PRECI-OUS WATER seen used 2 April 1976. Claxton Bay has a meter RN64 used by Trinidad Cement Ltd.

<u>TURKS & CAICOS</u> - John Alden writes that the "Conch News," published at Grand Turk, 22 Dec. issue, reports "Estimated revenue to the Treasury (of the Turks & Caicos Islands) from the postage stamp deal done between the Philatelic Bureau and I.G.P.C. is expected to be \$240,000 a year, according to Minister Liam Maguire."

However, Alden feels that there may be a possibility that the islands will experience a slump in philatelic interest comparable to that of Grenada, where sales are said to have fallen to oneeighth of their former figure. The belated issue under I.G.P.C. auspices of a \$5 miniature sheet for the Queen's Jubilee appears to be an omen of future emissions.

My family expresses with me their thanks for your appreciation for the work done in fulfilling this responsibility. I am grateful to all who have helped, particularly our officers, Editor Elaine Durnin, and to my able UK assistant, Al Branston. A special thanks is extended to Dan Walker as he leaves the secretary's position, for his invaluable help.
