FLASH!!! It gives me great pleasure to announce a major work by Edward F. Addis, The "Town" Cancels of British Honduras, 1880-1973. This is a 64-page monograph with a GBC plastic binding. The monograph which will be available in late September is priced at $\$ 15.50$, US printed matter postage paid. Overseas printed matter postage will be $\$ 1.50$ extra as surface mail and $\$ 4.20$ extra as air mail. Michel Forand did the final typing and layout of the monograph.

Starting with a history and story of the early posts, the monograph discusses the transport of the mails and provides examples of almost all the known postmarks of the "towns". Included are obliterators, single- and double-circle cancellations and temporary marks, duplex, circular and oval, as well as a section on mailbag seals. The final section lists all the post offices known or believed to have been in operation between 1880 and 1973. Appendices cover Internal Postal Rates to 1931, Town Populations and Postal Routes in 1921 and The Postal Service in the Early 1920s.

## LONDON, ENGLAND

By all measures, this gathering could only be judged as an outstanding philatelic and social event of major proportions. And it can all be attributed to the efforts of the many individuals who contributed to its success. Leading the parade of these is Mike Rego, who was involved in almost all aspects of the planning and execution of the meeting. Following close behind was Bob Swarbrick, International Director, who made the arrangements for the the use of The Lansdowne Club, of which he is a member; who purchased (via his wife) the Byron Cameron trophy in England; who kindly donated to the Group a small "travelling" gavel for use at its annual meetings; etc., etc. Now for the details of the fruits of their labors and many others.

Promptly at 10:30 AM, Wednesday morning, May 9th, Bob called the meeting to order, welcomed everyone and introduced Jay Fredrick, our President, who chaired the meeting. Total meeting attendance reached over 75, including 9 guests. Approximately 30 members attended London 1990 at various times but could not get to the meeting, including almost all of the dealer-members. Total attendance in London came to just under 100 members! Al Branston, Jack Harwood, Gale Raymond and Vice President Dr. Peter McCann sent regrets; otherwise we might have exceeded 100. Nine countries were represented, including the U.S., G.B. and three of "our" islands.

Taking the "chair", Jay welcomed everyone; thanked Mike and Bob for their efforts; and thanked Ben Ramkissoon, Immediate Past President, for making the changeover in administration orderly and easy. He then reviewed the morning's detailed agenda and informed those assembled that all were welcome to stay during the "business" portion of the meeting. In addition, Bill Ashley was called upon to give a brief rundown on a proposed picture postcard cataloging project. (See details on page --.)

After coffee, Jay made several announcements -

1. Tom Giraldi would act as Secretary Pro Tem for the meeting and record the minutes.
2. Because of VAT problems, no Group auction would be held in London. Instead, our auction manager, Jack Harwood, would hold a mail auction in June.
3. Future personnel changes, involving our Editor (1991) and Auction Manager (1992), were noted, as previously reported in the June Journal.
4. Future annual meetings were announced. (See p. 39 of the June 1990 journal for details.)

At this point our "business" meeting began and everyone stayed! Several of the 24 members of the Group who make up the administrative "team" gave reports. These include Ben Ramkissoon, Chairman of the Publications Committee, who encouraged group publications (we have the funds); Tom Cusick, Treasurer, whose annual report is on pp. 41-42 of the June Journal; Mark Swetland, Editor (cf. p. 84); Dan Walker, Librarian, who presented (via Jay) a progress report and the need for an updated catalog of library holdings and reminded us that donations to the library are tax-deductible in the USA; and Tom Giraldi, Membership Chairman, who reported on sales of back issues of the Journal and various article reprints and that several new members had signed up in London.

Under "old business", Jay thanked Victor Toeg, President of the British West Indies Study Circle and a member of our Group, for inviting us to share in their Wine and Cheese Party the night before.

Under "new business", Jay announced the decision to judge the BCPSG members' Caribbean exhibits independently of the London show. One of our members, Dan Walker, served on the show jury.

The actual judging took place on Monday, May 7th, by a jury consisting of John Griffiths, Chairman, Eddie Addiss, John Jackson and David Parsons (a non-member) of Christie's Robson Lowe staff who was "drafted" at the last moment when it appeared that John Griffiths might not be present for the judging. This was due to his wife having been hospitalized because of an auto accident that occurred
earlier in London. However, John did, indeed, make it and the four-man jury's awards of the BCPSG medals and Cameron trophy were announced as follows:

Eddie Addiss then offered a vote of thanks to Bob Topaz, Ben Ramkissoon, Mark Swetland and Michel Forand for their help in the publication by the BCPSG of his 60-page monograph, "Town Cancels of British Honduras". Jack Arnell discussed his and Morris Ludington's book, "The Bermuda Packet Mails and the Halifax-Bermuda Mail Service 1806-1886", published by the Postal History Society. Michael Vokins announced the publication by the BCPSG of the 3 -volume reprints of Volumes $1-9$ of the British Caribbean Philatelic Journal including the supplements that were published with these volumes. Members can order these reprints as shown on p. --.

Charles Freeland announced that he is updating Britnor's 1965 Montserrat handbook and is seeking "new" information or data on the subject.

Before breaking for lunch three informal spontaneous displays were presented.
Following lunch, we were enthralled at Dr. Joan Harper's presentation on British Honduras -180 pages of beautifully written up "great" material. She was a most articulate speaker with a great sense of humor, as well as an obvious "expert" in her philatelic field. Following the presentation, Eddie Addiss proposed a vote of thanks to her; this was seconded by Tony Shepherd; and then agreed to by all those present by acclamation. Jay then offered the Group's thanks to Mr. Harper for his able "logistic support" at the easels throughout his wife's presentation.

War Stamps - The Local Overprints - First Issue

## First and Second Settings

With the legislation of the War Stamp Ordinance, there was a need for an immediate supply of War Stamps. An order was sent to De La Rue's for overprinted stamps.

In the meanwhile the shortcoming was solved by locally overprinting stocks of the 1d (second printing, line perforated 14), at the Government Printers, Kingstown. The stamps were overprinted by hand in pairs, 'WAR/STAMP.', in two lines with the words $2-2 \frac{1}{2} \mathrm{~mm}$ apart.

The printing was carried out in two settings. The first is identified by alternate stamps having a comma for stop after the word 'STAMP'. (Some catalogs list in error "Every second stamp".)

When the printer set up the type, the comma was inserted in the right hand position as he looked at it. As printed, therefore, it appears on the first, third, fifth, etc. impressions. This can be checked on the illustrated block (Fig. 6a). This block is from the first setting of 1st June 1916, showing plate positions 69/72-105/108. The scratch flaws on the two left hand vertical columns do not reproduce in the illustration. The stamp in position 71 displays the variety, overprint doubled. Also apparent are the commas for stops on every odd-numbered stamp. If a straight edge is placed in line with the overprints, the alignment shows the method of printing, by hand, in pairs.

At some stage (it is impossible to say when) the comma error was noticed and replaced by a stop. It follows that the two settings should ideally be collected in multiples. Single stamps with the stop after 'STAMP' would be impossible to attribute.

The registratimon of the overprinting is remarkably accurate, considering what must have been an extremele tedious task, and the printer is to be commended (Fig. Gb). Note that the words in the second setting are 2 to $21 / 2 \mathrm{~mm}$ apart, with stops after every stamp.

Double overprints exist of both settings. By the nature of the printing they are not constant, and it is impossible to calculate their numbers. It is probable that they do not merit their relatively high catalog values.

Both settings have been forged on genuine unused ld stamps and more usually on cleaned fiscally used stamps. Some have forged cancellations. Those forged cancellations that I have seen are in the main rather crude and bear no relation to any known, genuine postmarks of the period. The forgery shown (Fig. 7) was fiscally used, cleaned and a forged overprint applied and then 'cancelled' with an impossible postmark.

know of only one first day cover. Double overprints, used (Fig. 8), are undoubtedly rare, and caution is advised before purchasing, as again, forgeries do exist.

For dates and printing quantities see the main chart.

## Third and Fourth Settings

In May 1916 stocks of the London overprints were running low. A high proportion had been acquired for the philatelic trade. So again it was decided to resort to locally overprinting sheets of the current ld stamps.

The work was carried out in a way similar to the first locals, only this time the setting started life with the words only $11 / 2 \mathrm{~mm}$ apart. At some stage the type was adjusted, and the words set at $31 / 2 \mathrm{~mm}$ apart. It may be that at this stage the overprinting instrument was altered from a pair of impressions to a larger multiple of possibly three lines of three. There is some evidence of this on the illustrated block (Fig. 9). To be certain of this larger pieces than those existing in my collection need to be examined.

The third setting is the scarcest of all the locals. It is estimated that very few sheets were printed. One specialist has been quoted as saying there was only one sheet! Multiples must be regarded as rare. Illustrated (Fig. 10) is a block with overprint doubled, thought to be unique.

In any event, the change to the fourth setting must have happened early in the overprinting. The color is generally of a fairly strong red, but some examples of the fourth setting are on stamps of a distinct light carmine-red, suggesting that the overprinting was carried out on stock from the January 1915 (Author's code 1b) and the September 1916 (Author's code 5) printings of the basic 1d issues.

## The London Overprints

De La Rue's overprints, with the words in one line, are an example of their usual faultess quality and workmanship. The first printing was invoiced on 23rd June 1916, with 404 specimens (Fig. 11).

There followed a further five printings. A total of 397,080 stamps were overprinted and, remarkably, no major errors are reported. All the overprinted stamps were line perforated 14. Varieties, watermark reversed and watermark inverted, are known to exist. The most spectacular is an imperforate block of four (ex Murray-Stephenson collection) sold on 22.1.1965, and again in January 1968 by Harmers (Fig. 12). Thought to be the only example, its present location is not known.

The London overprinted stamps are found in a wide range of red tints and shades. Refer to the color notes and list (p.45, W/N 155). Multiples are plentiful and an attractive array of shades can be acquired relatively cheaply.

## The Plate Damage

A close inspection of the stamps will reveal that some have scratch markings, some of which are quite pronounced. Althouh mentioned in the philatelic press on a few occasions, it would appear that the first serious study of the plate damage was in a 1982 paper (Ref. 2) for W.I.P.R. by Vincent Duggleby, and it is with his kind permission that the damaged plate markings are illustrated here.

I have also based the following notes on his observations:
It would seem that the flaws first appear on the second printing of the basic 1d stamp. As they also appear on stamps of the first local overprints, the damage must have taken place some time after November 1912 and before January 1915.

How did the damage occur? Duggleby makes a case for it happening during the actual printing operation. However, the author is of the opinion that it happened during storage of the plate. It is impossible to be sure in either case.

Interestingly, John Bunt, in his Falkland Islands book (Ref. 3), illustrates damage to the 1/overprinted plate on page 63, and the pattern of the scratches closely resembles that on the St. Vincent plate. The flaws can be found on stamps of both issues of the local overprints and also on copies of the London overprinted war stamps. Copies of the ordinary $1 d$ value also show the marks, but unaccountably, they appear to be scarcer.

## The Plate Repair

Duggleby reports that he showed examples with and without the flaws to an experienced printer who, after some examination, pronounced that the plate had been 'stoned' to remove the scratches. At the same time, the quarter sheet marginal crosses were removed. On marginal multiples from the repaired plate, the areas of these removed crosses show up as pale pink patches.

The repair took place sometime during the first six months of 1917. The reasoning which leads to this conclusion would take several pages of explanation. I, therefore, recommend that readers obtain a copy of Duggleby's fine piece of detective work in which he explains his reasons for arriving at the date.

## JOURNAL EDITOR'S REPORT

At our annual meeting in London, Mark Swetland reviewed the previously disclosed information that Michel Forand of Ottawa, Canada, will take over as Editor during 1991. Mark discussed, in general terms, the tasks involved and the problems and solutions of shipping the computer equipment into Canada and getting it back out some day (Customs - you know), mailing of the Journals, and effecting a smooth transition in the process.

Mark presented details about the status of the Journal, authors (including columnists) and their contributions, the success of the computer fund drive which raised over $\$ 5,000$, and the need for articles on "stamps", rather than postal history. Notwithstanding this last point, Mark finds himself in the enviable position of having a good backlog of articles for several future Journal issues. In connection with articles, Mark has on hand a $1 / 4$ " thick file of material on the "Bermuda Railway" which needs an author. (Horst Augustinovic volunteered to be the author after the meeting and already has the material.)

Mark, along with our Advertising Manager, Bob Danzer, also pointed out that we had lost three Journal advertisers. This reduced overall advertising space from about 8 pages to 6 . Any suggestions for replacements or additonal advertisers from any of our members would be greatly appreciated.

In his $41 / 2$ years as Editor, Mark has received the cooperation and support of many within the Group. He offered thanks to all the authors and noted that particular thanks go to Ben Ramkissoon, President 1986-89, Jay Fredrick, President 1990-1991, Bob Swarbrick, International Director, and to one man that none of us but Mark knows, Charles Perry, our capable and cooperative Journal printer.

All in all, our Journal is in great shape (thanks, in part, to our new computer equipment), is in good hands now and in the future, and will continue to serve as our principal successful communication media.

## BRITISH VIRGIN ISLANDS PHILATELIC SOCIETY FIRST ANNUAL PHILATELIC EXHIBITION

Further to my previous article I have now reached some conclusions with regard to "H.M.S. Snake". According to the National Maritime Museum in London, the "Snake" in service in 1814 was an 18 -gun ship rigged sloop of the "Cruiser Class" which was sold for breaking up in 1816. The ship in service in 1837 "was a brig rigged sloop of 16 guns built in 1832". It appears there were several other ships in the Royal Navy called "Snake" at various dates.

As to the "Leeward Island F" mark applied at Falmouth, England, to a Jamaica letter, this was shown by Bob Swarbrick in his multiple award winning entry at "LONDON 1990" to be the cancel used for unmarked Jamaica mail after the loss of the "Jamaica F" mark in early 1837. However, I have now had a chance to see and photocopy another letter (Fig. 1) from the "Snake" correspondence dated 15 April 1838 and this has a green "Jamaica F" which appears to be badly worn and has no date plugs which explains it being lost to regular use at this time. I can also confirm from my research at the National Maritime Museum that the "Snake" did not go near the Leeward Islands in 1837 and, therefore, the "Leeward Islands F" mark was applied to the letter which was known to originate in Jamaica.

Hugh James has sent me some data on the Type 21 TRDs. "Nicholson's Type 21 mixes three different styles of type in the town names. I have separated them into three divisions, designated type 21, 21a and 21b. In all three the date line with figures in rounded, upright type, and Jamaica, in antique (Devinne) caps, are the same. The town names vary, however. Type 21 has the town name in type similar to JAMAICA. Type 21 has the town name in type similar to typewriter caps, like TRD 18. In Type 21 b the town name is in slanting (italic) caps, like TRD Type 15.

# THE BUREAUCRATIC MAIL CLERK 

by M. H. Ludington
Illustrated (Fig. 1) is the back of a picture postcard of The New Windsor Hotel Palm Gardens in Hamilton, Bermuda. The message was written in Bermuda on Sunday, 30 December 1934, and states that the writer will be sailing on the ROTTERDAM and that "probably this card will go on our boat". The card was correctly franked with a $11 / 2 d$ stamp, but being Sunday, the post office was closed and it did not get cancelled. The ROTTERDAM sailed in the afternoon and arrived at Hoboken, N.J., on Tuesday, 1 January 1935. There the P. O. clerk refused to accept the card as prepaid, postmarked it at 11 AM, 2 January, and stamped it at the bottom "HELD FOR POSTAGE" and the date "2 JAN 1935". He sent a notice to the addressee in Ypsilanti, Michigan, to send 1 cent, which she did, having to pay 3 cents more in postage to do so. At Hoboken, a 1 cent stamp was added and cancelled at 10 AM on 10 January and stamped in purple "THIS IS THE MAIL / FOR WHICH YOU SENT POSTAGE" and was finally forwarded.

Coming off a steamer that had just arrived from Bermuda, the card could have been accepted as prepaid, but if not, ought to have been forwarded postage due, which would have saved everybody a lot of time and trouble. The.clerk's pettiness, however, did make an unusual item for a collector.

## Naval Operating Base and Air Station [Navy Number 117]

The formal opening of the United States seaplane base took place on 1st August 1941, under the command of Capt.A.W.Radford (4). The air station was located at Carenage Bay but gradually the operating base was extended to cover most of the Chaguaramus area in the north west peninsula of Trinidad, with aircraft repair facilities, hospital and escort ship repair dock (1). The base was decommissioned on 1st July 1950, when it was reduced to a Naval Station and was finally closed in 1975.

Navy Numbers were disguised mail addresses established in 1942 for security purposesg. They were assigned to a specific location which remained fixed for the duration of WW II. Trinidad was allocated No.117, c/o Postmaster, New York. The Navy Number should not be confused as being an official
P.O. number (11).

Certain Naval Construction Battalions were assigned Naval Numbers but these were discontinued in the spring of 1943. 8160 was assigned to the 30th N.C.B. during its early period in Trinidad.
F.P.O. Military "Zip" codes officially went into effect on 1st January 1965. They replaced any Navy Number address. Trinidad was allocated 0955 between 1965 and 1969.

Branch Numbers are identification numbers assigned to each U.S. Naval post office facility attached to U.S. Naval shore bases etc. The numbers were assigned by the U.S. Civil Post Office in New York. They are called Branch Numbers because each of these facilities was in fact a branch of the New York Post Office (11). The branch number may appear in the cancel.

## Censor Handstamps

Each cancel has a manuscript initial of the examiner in the centre. USNC 1 is known with a numeral 2 in place of the initial. The same initials are known used on more than one type of handstamp indicating the handstamps were interchangeable.

Note:- Type USNC 2, used by the Naval Operating Base in Trinidad, is known used on a cover from the Dutch ship H.M.N.S. Queen Wilhelmina, dated 1st May 1943, with a return address c/o Fleet Post Office, New York.

Belize - British Honduras
Dr. Luis Escalante has sent two different variations on the Shell definitives of Belize. Figure 2 is SG 632a, the 1981 Independence Overprint of the 4 shell with the overprint inverted. When Dr. Escalante sent in the illustration, he intended it to complement Carl Troy's 1984 BCPJ article reporting similar inversions on the $10 \notin$ and $85 \notin$ stamps. Figure 3 is SG 745, a $198310 \not \subset$ surcharge of the $35 \notin$ shell. As can be seen, the surcharge is shifted upwards and to the right so badly that it is almost unrecognizable. A trace of the "10c" can be made out in the top border of the stamp just above the royal cipher. The rectangle to the left is part of the obliterator from the adjacent stamp. Belize seems to had some problems with this issue, as Gibbons catalogs surcharge omitted, vertical pair lower stamp without surcharge, and surcharge double.

Figure 4 is a registered cover from Dr. Luis Escalante to Ben Ramkissoon. Although the registration label is not of a style with which most of us are familiar, Ben notes that the addition of the blue rubber-stamped "Belize City" is apparently new, or rather was new in 1986.

In contrast to the spartan simplicity of the registration label is the official cover from 1987 in Figure 5. I seem to be establishing a pattern for being unsure of initials, (and thank those members telling me what OT\&TGS stood for), but guess that "OSGB" stands for On the Service of the Government of Belize. In the upper right corner appears a rather attractive double oval Official Paid handstamp in purple with manuscript initials and the date. The large receipt stamp from the Ministry of Finance and Development is also in purple. The intimidating size and the large space for a dollar amount would indicate this stamp may be a general-purpose receipt stamp and not an exclusively postal marking.

Figure 6 shows another official cover, this one from two months after independence. The OSGB can be seen faintly at the top and a large double circle departmental stamp in red, signed and dated, appears at bottom right. The name of the department is illegible [A???, too short to be Agriculture], but the addressee is at the Ministry of Natural Resources in Belmopan.

Finally, Figure 7 provides a nostalgic look at the pre-independence days of the last British colony on the American mainland. Although this peccary cleverly dodged the meter cancel by running for the top left corner of the cover, a determined civil servant hamstrung it with a handstamp exhibiting a flair equal to any pig-sticking prowess in the army of the Raj.

BAHAMAS：International Literacy Year 1990 set of three．To be issued June 27．Designed by G．Vasar－ helyi and printed by The House of Questa．Denominations are： $10 \notin, 40 \notin$ and $50 \not \subset$ ．All show children studying．

BELIZE：Turtles set of six．July release．Designed by Gordon Drummond．Denominations are： $10 \notin$ ， green turtle；25ф，hawkbill turtle；60ф，loggerhead（Caretta caretta）；75申，loggerhead（Staurotypus tri－ porcatus）；\＄1，bocatroa；and \＄2，hicattee．

BERMUDA：Stamp World London 90 logo overprinted on the Commonwealth Postal Conference issues of 1989 ．

CAYMAN ISLANDS：Angelfish set of four．To be released on April 25．Designed by Derek Miller and printed by The House of Questa．Denominations are： $10 \not \subset$ ，French angelfish； $25 \not \subset$ ，queen angelfish； $50 \notin$ ， grey angelfish；and $\$ 1$ ，rock beauty．

JAMAICA：Girl Guiding 75th anniversary set of three．No release date reported．Designed by John Sayer and printed by BDT International Security Printing．Denominations are： $45 \notin, 55 \notin$ and $\$ 5$ ．All show Girl Guides．

MONTSERRAT：London 1980 stamps overprinted with new values and the Stamp World London 90 logo．The new values are： $70 \notin$ on $40 \not \subset ; 90 \notin$ on $55 \notin ; \$ 1$ on $\$ 1.20 ; \$ 1.15$ on $\$ 1.20$ ；and $\$ 1.50$ on \＄1．20．

ST．KITTS：Battle of Britain 50th anniversary SS containing two $\$ 3$ stamps．Release date September 15．Designed by Tony Theobald and printed by BDT International Security Printing．The two stamps show Spitfire airplanes．

TRINIDAD \＆TOBAGO：Bird definitives set of twelve．Designed by Derek Miller and printed by The House of Questa．Denominations and birds are：20ф，yellow oriole； $25 \notin$ ，green－rumped parrotlet；40ф， fork－tailed flycatcher；50\＆，copper－rumped hummingbird；\＄1，bananaquit；\＄2，semp；\＄2．25，channel－ billed toucan；$\$ 2.50$ ，bay－headed tanager；$\$ 5$ ，green honeycreaper；$\$ 10$ ，cattle egret；$\$ 20$ ，golden olive woodpecker；and $\$ 50$ ，peregrine falcon．
